Ditto 3 1 THE ABERDEEN CORPORATION ACT, 1899.

HEREAS by the Aberdeen Corporation Act, 1899, it is, amongst other things, enacted that, on and after the day prescribed by the Secretary for Scotland under Part II. of the said Act, the City and Royal Burgh of Aberdeen shall be a County of a City, by the name of the County of the City of Aberdeen, and that, for the purposes of the said Act, the area of the said City and Burgh, as defined by the said Act, shall be severed from the Counties of Aberdeen and Kincardine within which it was situated on the prescribed day.

Now, therefore, I, the Right Honourable Alexander Hugh, Lord Balfour of Burleigh, Her Majesty's Secretary for Scotland, do hereby appoint Wednesday the 15th day of November 1899, as the prescribed day under and for the purposes of the said Part II. of the said Act.

^{*}Section 8 of the Corn Returns Act, 1882, provides that where returns of purchases of British Corn are made to the Local Inspector of Corn Returns in any other measure than the imperial bushel, or by weight or by a weighed measure, that Officer shall convert such returns into the imperial bushel, and in the case of weight or weighed measure the conversion is to be made at the rate of sixty imperial pounds for every bushel of wheat, fifty imperial pounds for every bushel of barley, and thirty-nine imperial pounds for every bushel of oats.
