under Tarrife, and attack her. I immediately ordered both the Medula's cables to be slipped, and proceeded to her assistance; as we approach-

ed they hauled from her.

Favourable circumstances of wind and current aided the Medufas failing; and, at eleven o'clock, we opened our fire upon one (as she cros-fed on the opposite tack) with effect; the other we ran close alongside and cuptured, as per annexed report, then tacked, and continued firing upon the other until sher rowed amongst the rocks, within a shot of a battery to the westward of Cabrita Point. She received fo many of our shot; and from both her yards being shot away, and nearly all her oars broken, I have no doubt fhe is effectually destroyed. I understand she was called La Sorcier, of two twelve and two fix-pounders, with feventy men.
