WESTMINSTER-MARCH 9.

This day, the Lords being met, a meffage was fent to the Honourable House of Commons, by Sir FRANCIS MOLYNEUX, Gentleman Usher of the Black Rod, acquainting them, "That the Lords, authorifed by virtue of his Majeifty's commission for declaring his Royal Asset to several acts agreed upon by both Houses, " do desire the immediate attendance of the " Honourable House in the House of Peers, to " hear the commission read;" and the Commons being come thither, the faid commission empowering the Lord Archbishop of Canterbury, the Lord High Chancellor of Great Britain, and feveral other Lords therein named, to declare and notify the Royal Affent to the faid acts was read accordingly, and the Royal Affent given to

An Act for punishing mutiny and defertion, and for the better payment of the army and their quarters.

An Act for the regulation of his Mujesty's royal ma-rine forces while on shore.

An Act to continue, until three months after any re-friction imposed by any act of the present session of Parliament on the Bank of England from issuing cash in payment shall cease; an act made in the Parliament of freland in the 37th year of the reign of his present Ma-jesty, for confirming and continuing the restrictions on payments in cash by the Bank of Ireland; and also an act made in the 43d year of the reign of his present Ma-jesty, for amending the said act.

An Act for allowing reffels employed in the Green-land whale lifhery, and clearing out from any port in Great Britain, to complete their full number of men at certain ports for the prefent featon.

An Act for further continuing, until the 25th day of March 1806, an act made in the 33d year of the reign of his prefent Majefty, for rendering the payment of creditors more equal and expeditious in Scotland.

And to feveral other public and three private acts.
