SHIPOWNERS' AND SHIPMASTERS' SOCIETY OF KINCARDINE.

HEREAS the Lords Commissioners of Her Majesty's Treasury have made a Gift to the Parish Council of the Parish of Tulliallan of the funds derived from the Estate of the Shipowners' and Shipmasters' Society of Kincardine, on condition that a Scheme for the application of the said funds be previously approved by the Secretary for Scotland;

And whereas the Parish Council of Tulliallan framed a Scheme and submitted the same to the Local Government Board for Scotland, and at a Meeting held on the 2nd November 1899 approved of the Scheme as amended by the Local Government Board;

And whereas the said Scheme provides as follows:-

Scheme for the Administration of the Fund lately belonging to the Shipowners' and Shipmasters' Society of Kincardine, commonly called the "Sailors' Box."

Whereas the Shipowners' and Shipmasters' Society of Kincardine having become defunct, and the funds belonging to the Society having fallen to the Crown as ultimus hares, the Right Honourable the Lords Commissioners of Her Majesty's Treasury have been graciously pleased to make a gift of the said funds, amounting to eight hundred and sixteen pounds four shillings or thereabouts, to the Parish Council of Tulliallan; therefore, the said funds shall from and after the date of this Scheme (being the day on which it shall receive the approval of Her Majesty's Secretary for Scotland) be held and administered for the purposes, with the powers, and under the conditions and provisions hereinafter set forth:—

1. From and after the date of this Scheme the said funds shall be vested in the Parish Council of Tulliallan, to be held and administered by them under the conditions and provisions of this Scheme.

2. The business of the fund shall be transacted either at ordinary Meetings of the Parish Council or at Meetings summoned for the purpose, which shall be convened and conducted according to the ordinary rules and practice of the said Parish Council.

3. The Parish Council shall invest the said funds in such securities as are authorised by the Trusts (Scotland) Acts.

4. The Parish Council shall cause full accounts to be kept of the capital, income, and expenditure

vested in, received, and expended by them under this Scheme, in such form and manner as the Local Government Board for Scotland shall from time to time prescribe. Such accounts shall be made up to the 15th day of May in each year; and after the same have been examined and passed by the Parish Council, shall be audited by the same auditor, and subject to the same provisions, as the accounts of the Parish Council.

- 5. The Parish Council, after paying the necessary expenses of management and the burdens and taxes affecting the Trust, shall apply the free annual income in providing for the payment of not more than four pounds sterling per annum, payable half-yearly, to as many poor and deserving persons residing in the Parish of Tulliallan, and not in receipt of parochial relief, as the funds of the Trust for the time being will allow,—the preference being always given to persons who through themselves or their immediate relatives have had a seafaring connection.
- 6. Any balance remaining after the beneficiaries have been paid in any one year may be added to and disposed of along with the income of the year following, or may be added to and form part of the capital fund of the Trust as the Parish Council shall think fit.

7. The list of persons entitled to benefit by this fund shall be made up at the first Meeting of the Parish Council after the fifteenth day of

- May in each year.
 8. It shall be in the power of the Parish Council to withhold the benefits of the Trust for good and sufficient reasons in the case of any recipient, and their determination in such case shall be final.
- 9. It shall be in the power of the Parish Council to alter the provisions of this Scheme with consent of the Local Government Board for Scotland.
- 10. The Parish Council shall have power to make such regulations for the management of the Trust as they think fit in so far as the same are not inconsistent with the provisions of this Scheme.

Now, therefore, I, the Right Honourable Alexander Hugh Lord Balfour of Burleigh, Her Majesty's Secretary for Scotland, do hereby signify my approval of the foregoing Scheme.
