Alteration of Parish Areas.

PROPOSED ORDER No. XLVI.

PARISHES OF BOTHKENNAR, FALKIRK, AND POLMONT.

(NEW PARISH OF GRANGEMOUTH.)

HEREAS it has been represented to me by the Parish Councils of the Parish of Bothkennar and the Parish of Polmont and the Commissioners of the Police Burgh of Grangemouth, that I should issue an Order, under section 51 of the Local Government (Scotland) Act, 1889, and section 46 of the Local Government (Scotland) Act, 1894, uniting the Parish of Bothkennar (except certain portions thereof) and the Parish of Polmont and portions of the Parish of Falkirk into one Parish, and transferring certain portions of the Parish of Bothkennar to the Parish of Falkirk:

And whereas, after consulting with the authorities concerned, and causing a local inquiry to be Parish Council of the Parish constituted by this

held, I am of opinion that it is expedient to give effect to the said representation:

Now, therefore, I, the Right Honourable Alexander Hugh, Lord Balfour of Burleigh, Her Majesty's Secretary for Scotland, do, in virtue of the powers conferred upon the Secretary for Scotland by the Local Government (Scotland) Acts, order and direct as follows:—

1. The two portions of the Parish of Bothkennar situated to the south of the centre line of the River Carron shall cease to be parts of that Parish, and shall form part of the Parish of Falkirk.

2. The portion of the Parish of Falkirk situated to the east of the Kerse County Road and the portions of the said Parish situated to the north of the centre line of the River Carron shall cease to be parts of that Parish, and shall form part of the Parish constituted by this Order.

3. The Parish of Polmont, the Parish of Bothkennar excepting the aforesaid portions thereof, and the aforesaid portions of the Parish of Falkirk, shall be united into one Parish, to be called the Parish of Grangemouth.

4. The Parish Council of Polmont and the Parish Council of Bothkennar shall cease and determine, and their whole powers, rights, duties, property, liabilities, debts, officers, and servants shall be transferred to the Parish Council of the Parish constituted by this Order.

Parish constituted by this Order.

5. The Parish Councillors elected for the Parish of Polmont, the Parish Councillors elected for the Parish of Bothkennar, and the Parish Councillors elected for the Grangemouth Ward of the Parish of Falkirk, shall together form the Parish Council of the Parish constituted by this

Order, and shall hold office until the date of the next election of Parish Councillors. The first Meeting of the Parish Council shall be held on the 15th day of May 1900, and such Meeting shall be deemed to be the first statutory Meeting of the Parish Council. The Parish Councillors for the aforesaid Grangemouth Ward shall cease to be Parish Councillors for the Parish of Falkirk, and the remaining Parish Councillors of that Parish shall constitute the Parish Council thereof, until the date of the next election of Parish Councillors.

- 6. The Scotch Education Department may by Order provide for the election of a School Board for the Parish constituted by this Order, and for that purpose may fix the number of members of the said School Board, the date of the election, and of the first meeting of the said Board, and may also appoint the returning officer at such election.
- 7. The existing School Boards of Grangemouth, Bothkennar, and Polmont shall remain in office until noon on the fifteenth day of May 1900, and immediately thereafter the existing School Boards shall cease and determine, and the School Board of the Parish of Grangemouth constituted by this Order shall take office. The whole powers, rights, duties, property, assets, liabilities and debts of the said existing School Boards shall be transferred to, vested in, and imposed on the School Board of the said Parish as soon as they take office.
- 8. The Parish Council of Falkirk shall assume responsibility for, and shall relieve the Parish Council of Bothkennar of all advances which the latter body may be called upon to make for, or on account of, any pauper whose claim is derived (1) from birth in the aforesaid portions of the Parish of Bothkennar, or any of them, prior to the 15th day of May 190, or (2) from residence for the statutory period in the aforesaid portions of the Parish of Bothkennar, or any of them, prior to the 15th day of May 1900.
- 9. The Parish Council of the Parish of Grangemouth shall assume responsibility for, and shall relieve the Parish Council of Falkirk of all advances which the latter body may be called upon to make for, or on account of, any pauper whose claim is derived (1) from birth in the aforesaid portions of the Parish of Falkirk, or any of them, prior to the 15th day of May 1900; or (2) from residence for the statutory period in the aforesaid portions of the Parish of Falkirk, or any of them, prior to the 15th day of May 1900.
- 10. Nothing herein contained shall affect the rights of Creditors or of persons having vested interests, and all questions of adjustment consequential on this Order are expressly reserved.

This Order shall take effect immediately for all purposes concerning School Boards, and on the 15th day of May 1900 for all other purposes.

Whereas, by Treaty, grant, usage, sufferance, and other lawful means, Her Majesty the Queen has power and jurisdiction in China and Corea:

And whereas by "The China and Japan Order in Council, 1865," a Court was established, styled Her Britannic Majesty's Supreme Court for China and Japan:

And whereas by "The China, Japan, and Corea Orders in Council, 1834 and 1886," it was provided that all powers and jurisdiction of the said Supreme Court should be exercisable in relation to Corea:

And whereas by virtue of an Order in Council made on the seventh day of October one thousand eight hundred and ninety-one, the Orders in Council regulating Her Majesty's Consular jurisdiction in the Empire of Japan have, save as provided in the said Order, ceased to be in force and operation within that Empire:

And whereas in view of the recited extension of jurisdiction as respects Corea, and cesser of jurisdiction as respects Japan, it is expedient that the style of the said Supreme Court should be altered, and also that the provisions of "The China and Japan Order in Council, 1865," and of the Orders amending or extending that Order, should be repealed as far as relates to Japan.

Now, therefore, Her Majesty, by virtue and in exercise of the powers in this behalf by "The Foreign Jurisdiction Act, 1890," or otherwise in Her Majesty vested, is pleased, by and with the advice of Her Privy Council, to order, and it is

hereby ordered, as follows:-

1. The Court established by Article Seven of "The China and Japan Order in Council, 1865," shall be styled "Her Britannic Majesty's Supreme Court for China and Corea," and all references in that Order, or in the Orders amending or extending that Order to the Supreme Court, for China and Japan, or to the Supreme Court, shall, in so far as the said Orders relate or are applied to China or Corea, be read as references to the Supreme Court for China and Corea.

2. All provisions relating to the exercise of Her Majesty's power and jurisdiction in Japan, contained in "The China and Japan Order in Council, 1865," or any Order amending or extending that Order, are hereby repealed, subject to the provisions of the said recited Order in Council of the seventh October one thousand eight hundred and ninety-nine; provided that where any of those provisions are by the same or any subsequent Order extended or applied to China or Corea, this Article shall not affect such extension and applicatiou.

3. This Order may be cited as "The China and Corea (Supreme Court) Order in Council, 1900."
