Cards will be forwarded. Forms for the purpose can be obtained at the Lord Chamberlain's Office.

Gentlemen who wish to be presented officially should communicate with the heads of their Department, who will provide them with the necessary cards and instructions.

It is particularly requested that the names of the Gentlemen to be presented be very distinctly written on the Presentation Cards delivered to the Lord Chamberlain at the Levee, in order that there may be no difficulty in announcing them to His Royal Highness.

SPECIAL REGULATIONS (supplementary to the General Regulations issued 8th April 1872, and amended by subsequent Notices in the London Gazette) respecting Open Competitive Examinations for the situation of Assistant in the Nautical Almanac Office of the Admiralty.

N.B.—These Regulations are liable to alteration for future Examinations.

I. The limits of age for this situation are 18 and 25, and Candidates must be of the prescribed age on the first day of the Examination.
