## In Parliament—Session 1900.

#### COSTA RICA RAILWAY COMPANY LIMITED.

(Power to Company to borrow further Moneys and Special Provisions in reference thereto.)

OTICE is hereby given, that the Costa Rica Railway Company Limited (hereinafter called "the Company"), intend to apply to Parliament for leave to introduce a Bill in the present Session for the following purposes, or some of them (that is to say) :--

1. To empower the Company to raise further moneys for the general purposes of their undertaking, and to authorise the raising of such further moneys by borrowing, and by the creation and issue of debentures, mortgages, and bonds, or by any of such means.

2. To provide that either with the consent of the existing debenture holders of the Company, or such proportion of them as may be prescribed by the intended Act, or by the terms and conditions of such debentures or of the deeds securing the same, or otherwise, such moneys and the interest thereon shall be a charge upon the undertaking of the Company, in priority to all or some of the existing debentures, mortgages, or bonds and debts of the Company, and shall have such other rights, priorities, preferences, or privileges as may be prescribed or provided for by the intended Act.

3. To alter, vary, or rescind the terms and conditions upon which all or some of the existing debentures of the Company were issued, and the rights and privileges attaching thereto, and any other rights and privileges which would or might interfere with the objects of the intended Act, and to empower and require all or any of the holders of any debentures, mortgages, bonds, or other securities, or debts dealt with, or proposed to be dealt with, or affected by the intended Act, to consent to such Act, or to anything to be done thereunder, or to dispense wholly or in part with such consent, and on and subject to such terms and conditions (if any) as the intended Act may provide.

4. Printed copies of the intended Act will be deposited in the Parliament Office of the House of Lords and the Private Bill Office of the House of Commons, and may be obtained at the offices of the undersigned.
