TO THE QUEEN'S MOST EXCELLENT MAJESTY,
MAY IT PLEASE YOUR MAJESTY,—

We, Your Majesty's devoted and loyal subjects, met in General Assembly of the Church of Scotland, have received Your Majesty's most gracious Letter with due gratitude and respect.

We receive with gladness the assurance of Your Majesty's affection for the Church of which we are the Ministers and Office-Bearers, and Your conviction of the service which it is rendering to the Scottish people. We earnestly trust that, by the faithful discharge of the duties committed to us, we will prove ourselves worthy of Your continued confidence and support.

We acknowledge with thankfulness Your Majesty's gracious gift of Two thousand pounds, and with pleasure we undertake to carry out the instructions communicated to us in regard to its destination.

We are deeply gratified to receive Your Majesty's Commission to the Right Honourable the Earl of Leven and Melville as Your Representative in this General Assembly. May it please Your Majesty, Your Majesty's loyal Subjects and Servants, the Ministers and Elders of the Church of Scotland convened in General Assembly.
