The Queen has been pleased to give and grant unto Colonel John Smith Young, late Commissariat and Transport Staff, Her Majesty's Royal licence and authority that he may accept and wear the Insignia of the Third Class of the Imperial Ottoman Order of the Osmanieh, conferred upon him by His Highness the Khedive of Egypt, authorised by His Imperial Majesty the Sultan of Turkey, in recognition of his services to the British and Egyptian sick and wounded in the Soudan Campaign of 1898.
