THE MERCHANT SHIPPING ACT, 1894.

(57 and 58 Vict. c. 60.)

Whereas by an Order, dated the 2nd day of November 1899, the Board of Trade, by virtue of the power conferred upon them by section 369 (2) of the Merchant Shipping Act, 1894, did order that, as from the date of the said Order, fishing boats registered at any port in the United Kingdom of the following class, that is to say, steam fishing vessels employed in line-fishing, but which are also fitted for use as trawlers, should be exempt, and they were thereby exempted from such portion of Part IV. of the said Act as is contained in section 414 (2).

And whereas it appears to the Board of Trade

to be expedient to revoke the said Order.

Now, therefore, the Board of Trade, by virtue of the power conferred upon them by section 369 (2) of the Merchant Shipping Act, 1894, do by this Order revoke the said Order, dated the 2nd day of November 1899, as from the date hereof, but such revocation shall not prejudice or affect anything duly done or any right or privilege acquired whilst the said Order was in operation.
