1. The Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England, on Monday the 12th instant, at one o'clock, for Treasury Bills to be issued under the Acts 40 Vict. cap. 2, and 52 Vict. cap. 6, to the amount of £2,500,000, in replacement of Bills falling due on the 15th instant (£1,000,000), and of Bills paid off on the 29th September 1900.

2. The Bills will be in amounts of £1000, £5000, or £10,000. They will be dated the 15th November 1900, and will be payable at three months, or six months, or nine months, or twelve months, after date (at the option of the persons tendering), viz., on the 15th February 1901, or 15th May 1901, or 15th August 1901, or 15th November 1901 respectively.

3. *The Tenders must specify the net amount per cent. which will be given for the amounts applied for; and the Tenders of private individuals must be made through a London Banker.*

4. The Bills will be issued and paid at the Bank of England.

5. The persons whose Tenders are accepted will be informed of the same on Tuesday the 13th instant, and payment in full of the amounts of the accepted Tenders must be made to the Bank of England not later than three o'clock on Thursday the 15th instant.

6. The Lords Commissioners of Her Majesty's Treasury reserve the right of rejecting any Tenders.
