## CARRADALE PIER (PROVISIONAL ORDER).

(Power to take Rates, &c., at Carradale Pier; Leasing and Composition of Rates, &c.; Provisions for the Maintenance and Regulation of Pier, &c.; Borrowing of Money, and other purposes.)

OTICE is hereby given that application is intended to be made on or before the 23rd December next to the Board of Trade by Austin Mackenzie, Esquire of Carradale, in the County of Argyll (who and whose heirs, successors, and assigns are hereinafter referred to as "the Promoters"), for a Provisional Order pursuant to and in accordance with the provisions of the General Pier and Harbour Act, 1861, and the General Pier and Harbour Act, 1861, Amendment Act, for the following purposes or some of them (that is to say):---

- (1) To empower the Promoters to levy and take tolls, rates, and duties upon or in respect of the Pier known as the Carra-dale Pier, in the Parish of Cranaig or Saddell, otherwise known as the United Parishes of Saddell and Skipness, in the County of Argyll, and the works connected therewith, in respect of all persons and vessels using or frequenting the same, and all animals and goods embarked or disembarked thereat, and in respect of cranes, buoys, and other conveniences, and from time to time to alter such tolls, rates, or duties, to confer, vary, or extinguish exemptions therefrom, and to lease or let the said tolls, rates, and duties, and to compound and agree with any person or persons with respect to the payment thereof, and to confer, vary, or extinguish other rights and privileges.
