PRESENT,

The QUEEN's Most Excellent Majesty in Council.

WHEREAS by section 659 of the Merchant Shipping Act, 1894 (which is a section in Part XI. of that Act, and which re-enacts similar provisions of the Merchant Shipping Act, 1854, which were repealed by the said first-mentioned Act), it is (among other things) enacted that Her Majesty may, by Order in Council, fix the establishments to be maintained by each of the General Lighthouse Authorities on account of the services of lighthouses, buoys, and beacons, or the annual or other sums to be paid out of the Mercantile Marine Fund in respect of these establishments, and that an increase of any establishment or part of an establishment so fixed shall not be made without the consent of the Board of Trade.

And whereas by section 1 of the Merchant Shipping (Mercantile Marine Fund) Act. 1809 is (among other things) provided that references in Part XI. of the Merchant Shipping Act, 1894, to the Mercantile Marine Fund shall be construed as references to the General Lighthouse Fund by the now reciting Act constituted.

And whereas Her Majesty, by Order in Council dated the 16th day of March 1892, was pleased to fix the establishment which might be maintained by the Commissioners of Northern Lighthouses, and the amount of the salaries to be paid to the officers of the said establishment out of the Mercantile Marine Fund.

And whereas it is expedient that the salary payable to Mr. David Ross, a clerk of the said establishment, should be increased in the manner hereinafter set forth.

And whereas it has been made to appear to Her Majesty that the Board of Trade have consented to such increase.

Now, therefore, Her Majesty, by virtue of the power vested in Her by the Merchant Shipping Act, 1894, and of any other powers Her thereanto enabling, and by and with the advice of Her Privy Council, is pleased to fix as follows, that is to say—

- (1) The salary of the said Davi i Ross shall be $\pounds 250$ per annum as from the 1st day of April 1900, rising by $\pounds 10$ per annum until a maximum salary of $\pounds 300$ per annum is reached.
- (2) The said salary shall be paid out of the General Lighthouse Fund.
