PRESENT.

The KING's Most Excellent Majesty in Council.

Whereas under section twelve of "The Coinage Act, 1870," His Majesty, with the advice of His Privy Council, has power, by Order, to make regulations respecting the trial of the Pry and all matters in its act. the Pyx and all matters incidental thereto, and by virtue of the same section any such Order may !

be revoked and altered by any subsequent Order made under that section.

And whereas by an Order dated the twentyninth day of June one thousand eight hundred and seventy-one, and made in pursuance of the said Act, Her late Majesty Queen Victoria made regulations respecting the trial of the Pyx, and it is expedient to amend those regulations as appears in this Order.

Now, therefore, His Majesty King Edward the Seventh, by and with the advice of His Privy Council in pursuance of the said Act, and of all other powers enabling His Majesty in that behalf,

is pleased to order as follows:—

1. This Order may be cited as "The Trial of the Pyx Order in Council, 1901," and the Order of the twenty-ninth day of June one thousand eight hundred and seventy-one (making regulations respecting the trial of the Pyx) may be cited as "The Trial of the Pyx Order in Council, 1871."

2.—(1) The regulations made respecting the trial of the Pyx by "The Trial of the Pyx Order in Council, 1871," as amended by this Order, apply and extend to the trial of any coins coined at any branch of the Mint which are for the time being subject to the trial of the Pyx.

(2) The trial of coins coined in England and coins coined at any one or more branch mint or mints may be included in the same warrant for a trial of the Pyx, but a separate examination shall be made and a separate verdict given with respect to coins coined in England and coins coined at each branch mint.

(3) In the application to a branch mint of the provisions of "The Trial of the Pyx Order in Council, 1871," respecting the setting apart of construed to be the Deputy Master of the Branch

- 3. The Treasury may, on such occasions as they think fit, appoint some person other than the Master or Deputy Master of the Mint, or in the case of a branch mint the Master of the Mint or the Deputy Master of the Branch Mint, to set apart or cause to be set apart coins with a view to the trial of the Pyx, and any person so appointed shall, so far as his appointment extends, act for the purpose under "The Trial of the Pyx Order in Council, 1871," as amended by this Order, in she place of the Master or Deputy Master of the Mint, or in the case of a branch mint the Master of the Mint or the Deputy Master of the Branch Mint.
- 4. The coins to be set apart for the trial of the Pyx shall consist in the case of gold coins of one from every two thousand pieces ready for issue instead of one from each journey weight as provided by "The Trial of the Pyx Order in Council, 1871."
- 5. The trial of the Pyx may be adjourned by the King's Remembrancer or Master presiding at the trial from time to time, and from place to place.

- (3) If it be found that exceptional sickness and death have been due to arsenic in beer, or in

other articles of food or drink, by what safeguards the introduction of arsenic therein can be prevented:

Now know ye that We, reposing great trust and confidence in your knowledge and ability. have nominated, constituted, and appointed, and do by these Presents nominate, constitute, and appoint you the said William, Baron Kelvin; Sir William Hart Dyke; Thomas Edward Thorpe; Henry Cosmo Orme Bonsor; William Selby Church; and Benjamin Arthur Whitelegge, to be Our Commissioners for the purposes of the said inquiry.

And for the better effecting the purposes of this Our Commission, We do by these Presents give and grant unto you, or any two or more of you, full power to call before you such persons as you shall judge likely to afford you any information upon the subject of this Our Commission; and also to call for, have access to, and examine all such books, documents, registers, and records as may afford you the fullest information on the subject; and to inquire of and concerning the premises by all other lawful ways and means whatsoever.

And We do by these Presents authorise and empower you, or any two or more of you, to visit and personally inspect such places as you may deem it expedient so to inspect for the more effectual carrying out of the purposes aforesaid, and to employ such persons as you may think fit to assist you in conducting any inquiry which you may hold.

And We do by these Presents will and ordain that this, Our Commission, shall continue in full force and virtue, and that you, Our said Commissioners, or any two or more of you, may, from time to time, proceed in the execution thereof and of every matter and thing therein contained, although the same be not continued from time to time by adjournment.

And We do further ordain that you, or any two or more of you, have liberty to report your proceedings under this Our Commission from time to time, if you shall judge it expedient so to do.

And Our further will and pleasure is that you do, with as little delay as possible, report to Us under your hands and seals, or under the hands and seals of any two or more of you, your opinion upon the matters herein submitted for your consideration.

And for the purpose of aiding you in your inquiries, We hereby appoint Our trusty and well-beloved George Seaton Buchanan, Esquire, Doctor of Medicine, to be Secretary to this Our Commission.

TRANSFER TO THE SCOTTISH HOUSE TO HOUSE ELECTRICITY COMPANY LIMITED.

NOTICE is hereby given, that the Provost, Magistrates, and Town Council of the Burgh of Andrie, in the County of Lanark (hereinafter called "the Council"), intend, in pursuance of the powers given them by the Airdrie Burgh Electric Lighting Order, 1898, and with the consent of the Board of Trade, to transfer their powers, duties, and liabilities under the said Order to the Scottish House to House Electricity Company Limited.
