Whereas by the Extradition Acts, 1870 to 1895, it was amongst other things enacted that, where an arrangement has been made with any foreign State with respect to the surrender to such State of any fugitive criminals, His Majesty may, by Order in Council, direct that the said Acts shall apply in the case of such foreign State; and that His Majesty may, by the same or any subsequent Order, limit the operation of the Order, and restrict the same to fugitive criminals who are in or suspected of being in the part of His Majesty's dominions specified in the Order, and render the operation thereof subject to such conditions, exceptions, and qualifications as may be deemed expedient:

And whereas a Convention was concluded on the thirteenth day of December one thousand nine hundred between Her late Majesty Queen Victoria and the President of the United States of America, for the mutual extradition of fugitive criminals, which Convention is in the terms

following :—

"Her Majesty the Queen of Great Britain and Ireland and the President of the United States of America, being desirous of enlarging the list of crimes on account of which extradition may be granted under the Convention concluded between Her Britannic Majesty and the United States on the twelfth July one thousand eight hundred and eighty-nine, with a view to the better administration of justice and the prevention of crime in their respective territories and jurisdictions, have resolved to conclude a Supplementary Convention for this purpose, and have appointed as their Plenipotentiaries, to wit:

"Her Majesty the Queen of the United Kingdom of Great Britain and Ireland, His Excellency the Right Honourable Lord Pauncefote, Knight Grand Cross of the Most Honourable Order of the Bath, Knight Grand Cross of the Most Distinguished Order of Saint Michael and Saint George, and Her Majesty's Ambassador Extraordinary and Plenipotentiary to the United

States; and

"The President of the United States, the Honourable John Hay, Secretary of State of the

United States;

"Who, after having communicated to each other their respective full powers, which were found to be in due and proper form, have agreed to and concluded the following Articles:—

#### "ARTICLE I.

"The following crimes are added to the list of crimes numbered one to ten in the first Article of the said Convention of July twelfth one thousand eight hundred and eighty-nine, on account of which extradition may be granted, that is to say—

"II. Obtaining money, valuable securities, or

other property by false pretences.
"12. Wilful and unlawful destruction or obstruction of railroads which endangers human life.

"13. Procuring abortion.

#### "ARTICLE II.

"The present Convention shall be considered as an integral part of the said Extradition Convention of July twelfth one thousand eight hundred and eighty-nine, and the first Article of the last-mentioned Convention shall be read as if the list of crimes therein contained had originally comprised the additional crimes specified, and numbered eleven to thirteen in the first Article of the present Convention.

"The present Convention shall be ratified, and the ratifications shall be exchanged either at London or Washington as soon as possible.

"It shall come into force ten days after its publication, in conformity with the laws of the High Contracting Parties, and it shall continue and terminate in the same manner as the said Convention of July twelfth one thousand eight hundred and eighty-nine.

"In testimony whereof the respective Plenipotentiaries have signed the present Convention in duplicate, and have thereunto affixed their

seals.

"Done at Washington, this thirteenth day of December one thousand nine hundred.

And whereas the ratifications of the said Convention were exchanged at Washington on the twenty-second day of April one thousand nine hundred and one:

Now, therefore, His Majesty, by and with the advice of His Privy Council, and in virtue of the authority committed to Him by the said recited Acts, doth order, and it is hereby ordered, that from and after the thirteenth day of July one thousand nine hundred and one, the said Acts shall apply in the case of the United States and of the said Convention with the President of the United States of America.

Provided always that the operation of the said Acts shall be and remain suspended within the Dominion of Canada so long as an Act of the Parliament of Canada passed in one thousand eight hundred and eighty-six, and entitled "An Act respecting the Extradition of Fugitive Criminals," shall continue in force there, and no longer.

And We do by these presents authorise and empower you, or any three or more of you, to visit and personally inspect such places as you may deem it expedient so to inspect for the more effectual carrying out of the purposes aforesaid, and to employ such persons as you may think fit to assist you in conducting any inquiry which you may hold.

And We do by these presents will and ordain that this Our Commission shall continue in full force and virtue, and that you, Our said Commissioners, or any three or more of you, may from time to time proceed in the execution thereof, and of every matter and thing therein contained, although the same be not continued from time to time by adjournment.

And We do further ordain that you, or any three or more of you, have liberty to report your proceedings under this Our Commission from time to time, if you shall judge it expedient so to do.

And Our further will and pleasure is that you do, with as little delay as possible, report to Us under your hands and seals, or under the hands and seals of any three or more of you, your opinion upon the matters herein submitted for your consideration.

# CITY AND ROYAL BURGH OF GLASGOW.

THE TOWN COUNCILS (SCOTLAND) ACT, 1900.

WHEREAS an Act was passed on the Eighth day of August, in the year One thousand nine hundred, intituled "An Act to consolidate and amend the Law relating to the Election and Proceedings of Town Councils in Scotland" [63 and 64 Viet. cap. 49]:

And whereas it is provided that the said Act, the short title of which is the Town Councils (Scotland) Act, 1900, shall commence and have effect from and after the thirty-first day of December, in the year One thousand nine hundred:

And whereas by the said Act the enactments specified in the first schedule to the Act are repealed:

And whereas by the said Act it is provided that, "notwithstanding anything in this Act contained, it shall be in the power of the Town Council of any of the burghs mentioned in Schedule II. of the Burgh Police (Scotland) Act, 1892, by a resolution passed at any time within twelve months after the passing of this Act, to declare that any sections or sub-sections of this Act relating to the constitution and government of burghs, the minutes and proceedings of council, the officers of council, and accounts and corporate property, specified in such resolution, shall not be applicable to such burgh, and that in lieu thereof the corresponding sections or sub-sections (if any) of an Act or Acts applying to such burgh repealed by this Act, which sections or sub-sections shall be specified in the resolution, shall, notwithstanding such repeal, remain in force or revive within the burgh. Any resolution passed under this section shall be transmitted to the Secretary for Scotland, and published in the Edinburgh Gazette, and from and after such publication the resolution shall have effect as if it were enacted in this Act:"

And whereas the City and Royal Burgh of Glasgow is one of the burghs mentioned in Schedule II. of the Burgh Police (Scotland) Act,

Therefore the Town Council of the City and Royal Burgh of Glasgow do hereby in exercise and in virtue of the powers conferred upon them by the Town Councils (Scotland) Act, 1900, resolve and declare that the sections of the lastmentioned Act relating to the constitution and government of burghs, the minutes and proceedings of council, the officers of council, and accounts and corporate property, specified in Part I. of the Schedule annexed to this resolution, shall not be applicable to the City and Royal Burgh of Glasgow, and that in lieu thereof the sections of the Acts applying to the City and Royal Burgh of Glasgow, repealed by the Town Councils (Scotland) Act, 1900, which sections are specified in Part II. of the Schedule annexed to this resolution, shall, notwithstanding such
