LOCAL GOVERNMENT (SCOTLAND) ACTS.

Alteration of Parish Areas.

ORDER No. XLII.

DUNDEE COMBINATION PARISH (NEW PARISH OF LIFF AND BENVIE).

by the County Council of the County of Forfar that I should issue an Order, under section 51 of the Local Government (Scotland) Act, 1889, and section 46 of the Local Government (Scotland) Act, 1894, "detaching from Dundee Combination Parish the landward part of the Parish of Liff and Benvie, and creating the said landward part of the Parish of Liff and Benvie into a separate Parish, or such other or further Order as to the Secretary for Scotland shall seem necessary or expedient in order to provide a remedy in the circumstances:"

And whereas, after consulting with the authorities concerned, and causing a local inquiry to be held, I am of opinion that it is expedient to give effect to the said representation:

And whereas I caused the proposed Order to be published in the Edinburgh Gazette of the 21st August 1900:

Now, therefore, I, the Right Honourable Alexander Hugh, Lord Balfour of Burleigh, K.T., His Majesty's Secretary for Scotland, do, in virtue of the powers conferred upon me by the Local Government (Scotland) Acts, order as follows:—

1. The portion of the former Parish of Liff, Benvie, and Invergowrie, now forming a landward part of Dundee Combination Parish, shall cease to be part of Dundee Combination Parish, and shall

form a separate Parish, to be called the Parish of Liff and Benvie.

- 2. The Parish Council of Liff and Benvie shall assume responsibility for and shall relieve the Parish Council of Dundee Combination Parish of all advances which the latter body may be called upon to make for or on account of any pauper whose claim is derived (1) from birth in the said part of Dundee Combination Parish prior to the 3rd day of December 1901, or (2) from residence for the statutory period in the said part of Dundee Combination Parish prior to the 3rd day of December 1901.
- 3. Nothing herein contained shall affect the rights of Creditors or of persons having vested interests, and all questions of adjustment consequential on this Order are expressly reserved.
- 4. For the purpose of receiving the Parish Council Register prior to the election of a Parish Council and summoning the first statutory meeting of the Parish Council of Liff and Benvie, in terms of the Local Government (Scotland) Act, 1894, the Inspector of Poor of Dundee Combination Parish shall be deemed to be the Inspector of Poor of the Parish constituted by this Order.
- 5. This Order shall take effect at once for all purposes connected with the election of Parish Councils, and on the 3rd day of December 1901 for all other purposes.

Our trusty and well-beloved German Sims Woodhead, Esquire, Doctor of Medicine, Professor of Pathology in Our University of Cambridge;

Our trusty and well-beloved Sidney Harris Cox Martin, Esquire, Doctor of Medicine, Fellow of the Royal Society, Professor of Pathology at University College, London;

Our trusty and well-beloved John M'Fadyean, Esquire, Principal and Professor of Comparative Pathology and Bacteriology at the Royal Veterinary College; and

Our trusty and well-beloved Rubert William Boyce, Esquire, Professor of Pathology at University College, Liverpool; Greeting!

Whereas We have deemed it expedient that a Commission should forthwith issue to inquire and report with respect to Tuberculosis—

- (1) Whether the disease in animals and man is one and the same;
- (2) Whether animals and man can be reciprocally infected with it;
- (3) Under what conditions, if at all, the transmission of the disease from animals to man takes place, and what are the circumstances, favourable or unfavourable, to such transmission:

Now know ye that We, reposing great trust and confidence in your knowledge and ability, have authorised and appointed, and do by these presents authorise and appoint, you the said Sir Michael Foster, German Sims Woodhead, Sidney Harris Cox Martin, John M'Fadyean, and Rubert William Boyce to be Our Commissioners for the purposes of the said inquiry.

And for the better effecting the purposes of this Our Commission, We do by these presents give and grant unto you, or any three or more of you, full power to call before you such persons as you shall judge likely to afford you any information upon the subject of this Our Commission; and also to call for, have access to, and examine all such books, documents, registers, and records as

may afford you the fullest information on the subject, and to inquire of and concerning the premises by all other lawful ways and means whatsoever.

And We do by these presents authorise and empower you, or any three or more of you, to visit and personally inspect such places as you may deem it expedient so to inspect for the more effectual carrying out of the purposes aforésaid.

And We do further by these presents will and ordain that this Our Commission shall continue in full force and virtue, and that you Our said Commissioners, or any three or more of you, may from time to time proceed in the execution thereof, and of every matter and thing therein contained, although the same be not continued from time to time by adjournment.

And We do further ordain that you, or any three or more of you, have liberty to report your proceedings under this Our Commission from time to time if you shall judge it expedient so to do.

And Our further Will and Pleasure is that you do, with as little delay as possible, report to Us under your hands and seals, or under the hands and seals of any three or more of you, your opinion upon the matters herein submitted for your consideration.

Given at Our Court at Saint James' the thirty-first day of August one thousand nine hundred and one, in the first year of Our Reign.
