Bradley	During the action at Itala, Zululand, on the 26th September 1901, Major Chapman called for volunteers to carry ammunition up the hill; to do this a space of about 150 yards swept by a heavy cross fire had to be crossed. Driver Lancashire and Gunner Bull at once came forward and started, but half-way across Driver Lancashire fell wounded. Driver Bradley and Gunner Rabb, without a moment's hesitation, ran out and caught Driver Lancashire up, and Gunner Rabb carried him under cover, the ground being swept by bullets the whole time. Driver Bradley then, with the aid of Gunner Boddy, succeeded in getting the ammunition up the hill.
