By the KING. A PROCLAMATION

For appointing Saturday, 25th October, a Bank Holiday in the County of London.

EDWARD R. & I.

E, considering that it is desirable that Saturday the twenty-fifth day of this instant October, being the occasion of Our Royal Progress through London, should be observed as a Close Holiday in all Banks throughout the County of London, and in pursuance of the provisions of "The Bank Holidays Act, 1871," Do hereby, by and with the advice of Our Privy Council, and in exercise of the powers conferred by the Act aforesaid, appoint Saturday the twentyfifth day of this instant October, being the occasion of the said Royal Progress, as a special day to be observed as a Close Holiday in all Banks throughout the County of London, under and in accordance with the said Act, and We do, by this Our Royal Proclamation, command the said day to be so observed, and all Our loving subjects concerned to order themselves accordingly.

Given at Our Court at Buckingham Palace, this twentieth day of October, in the year of our Lord one thousand nine hundred and two, and in the second year of Our Reign.

^{*} Section 8 of the Corn Returns Act, 1882, provides that where returns of purchases of British Cern are made to the Local Inspector of Corn Returns in any other measure than the imperial bushel, or by weight or by a weighed measure, that Officer shall convert such returns into the imperial bushel, and in the case of weight or weighed measure the conversion is to be made at the rate of sixty imperial pounds for every bushel of wheat, fifty imperial pounds for every bushel of barley, and thirty-nine imperial pounds for every bushel of oats.

AYR CORPORATION TRAMWAYS. BYE-LAWS AND REGULATIONS

For the Regulation of same on the Ayr District Roads of the County of Ayr.

THE Ayr District Committee of the County Council of Ayrshire, being the Local Authority for the Parishes of Ayr and Monkton and Prestwick, which lie around the Ayr Burgh Boundary, do hereby, in virtue of the powers conferred by Section 46 of the Tramways Act, 1870, and of every other power enabling them in that behalf, make and enact the following Bye-Laws and Regulations as to the following most tere. 11.—The above Bye-Laws and Regulations shall be strictly and faithfully observed and performed in all points. points. Any proprietor, conductor, or driver, and any person whomscever, who shall be convicted of a breach of or contravention of these Bye-Laws and Regulations, or any of them, shall be liable in a penalty not exceeding forty shillings for each offence, and a further penalty for continuing offence not exceeding ten shillings for every day during which the offence continues.
