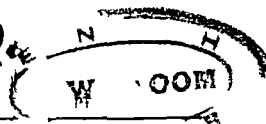

ORDER OF THE BOARD OF AGRICULTURE.

(DATED 18TH NOVEMBER 1902.)

ORKNEY (INFLUENZA) REVOCATION ORDER OF 1902.

The Board of Agriculture, by virtue and in exercise of the powers in them vested under the Diseases of Animals Acts, 1894 and 1896, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:—

1. The Order described in the Schedule to this Order is hereby, from and after the commencement of this Order, revoked: Provided that such revocation shall not invalidate or make unlawful anything done under the Order hereby revoked before the commencement of this Order, or interfere with the institution or prosecution of any proceeding in respect of any offence committed against, or any penalty incurred under, the Order hereby revoked before the commencement of this Order.

2. This Order shall come into operation on the twenty-fifth day of November one thousand nine hundred and two.

3. This Order may be cited as the ORKNEY (INFLUENZA) REVOCATION ORDER OF 1902.

MILLPORT PIER AND HARBOUR.

(PROVISIONAL ORDER.)

(Constitution of Harbour Board; Vesting existing Pier and Harbour Works in Board; Widening and Extension of Pier; Dredging; Regulation of Harbour and Bye-laws; Rates; Power to appoint Harbour-master; Power to supply Steam Tugs, &c.; Limits of Harbour; Acquisition of Lands, &c.; Borrowing and other Powers; Incorporation and Amendment of Acts).

NOTICE is hereby given, that application is intended to be made to the Board of Trade, on or before the 23rd day of December 1902, by the Millport Pier and Harbour Company (Limited) whose registered office is at No. 8 Bath Street, Largs (hereinafter referred to as "The Company"), for a Provisional Order (hereinafter referred to as "The Order"), under the provisions of the General Pier and Harbour Act 1861 and the General Pier and Harbour Act 1861 Amendment Act, and any other Act or Acts enabling the Board of Trade in that behalf,

to confer the powers and effect the objects and purposes hereinafter mentioned, or some of them. That is to say:—

To constitute and appoint the Company as the Harbour Authority for Millport in the County of Bute under the name or style of the Millport Harbour Board (hereinafter referred to as "the Board") or such other name or style as may be prescribed by the Order, and to confer upon the Board all or any of the following rights, powers, privileges, obligations and liabilities, and to make such other provisions as are hereinafter mentioned.

To transfer to and vest in or provide for the transferring to and vesting in the Board, in such manner as may be prescribed by the Order, the existing Harbour at Millport and the piers, quays, wharves, works and other property and conveniences connected therewith, together with all the rights, powers, privileges and authorities belonging or relating thereto, and to provide for the discharge of the debts and liabilities incurred in respect thereof or to which the same may be subject, and to enable all necessary parties to make and enter into all such deeds, conveyances or agreements as may be necessary or convenient for the objects and purposes aforesaid or any of them on such terms as may be agreed, or as may be provided in the Order, and to sanction, confirm and give effect to any agreement or arrangement made or to be made in respect thereof.

To authorise the construction and maintenance of the following works or some part or parts thereof which are or will be situate at Millport aforesaid in the parish of Cumbrae, Great Cumbrae Island, in the County of Bute and in the foreshore or bed of the sea adjacent thereto:— that is to say;—

The widening and extension of the Company's existing pier at Millport commencing at a point 30 yards or thereabouts Eastwards from the North East Corner of the Company's Offices at Millport and extending thence in an Easterly direction to and terminating at a point 68 yards or thereabouts from the point of commencement.

The dredging, deepening, and improvement of the Harbour and the entrance and approaches thereto.

To confer powers of deviation from the lines and levels shown on the plans and sections to be deposited as hereinafter mentioned.

To authorise the making, placing and maintaining of all necessary embankments, walls, piles, piers, breakwaters, groynes, wharves, railways, tramways, sidings, landing places, pier-heads, slips, stairs, roads, approaches, jetties, warehouses, buildings, sheds, cranes, buoys, lifts, staithe, mooring posts, dolphins, beacons, lights, and other works, machinery, appliances and conveniences in connection with the before mentioned works or any of them, or otherwise for the convenient use of the said pier and Harbour and Works.

To confer powers of dredging and removing any rocks, gravel, sand or other material and deepening the Harbour in the Bay at Millport and altering and improving the channels leading to the Harbour and any channels or banks near thereto and the foreshore and bed of the sea at or near the Harbour and works in order to provide and maintain suitable and convenient means of access to the Harbour and works.

To provide for the management, use, regulation and protection of the harbour, piers, breakwaters, docks, channels, works and conveniences, the regulation and control of vessels, the towage of shipping, the passage, navigation, anchorage, and lying of vessels, ships, boats and other craft at, along or near to the harbour, piers, docks, channels and works, the order and precedence of different classes of vessels passing into or out of the harbour, docks, channels and works, and the placing of buoys, lights, beacons, chains, posts and other conveniences.

To authorise and empower the Board to demand, levy, charge and recover tolls, rates, duties, tonnage and other dues and charges on or in respect of vessels resorting to the Harbour, piers and works or coming within such limits as may be defined by the Order, and on or in respect of passengers, animals, fish, goods, minerals, wares, merchandise and other articles landed, shipped, or unshipped therein or on the quays, works and conveniences belonging to or connected with the Harbour and for the use of staithe or shipping appliances, engines, waggons and carriages and for the hire or use of any pilot or tug, vessels or boats of the Board, and in respect of watching, lighting, and any services to be rendered or performed or cranes, wharves, weighing machines or other conveniences provided by the Board; to confer exemptions from and to compound for any such tolls, rates, duties, charges or other payments or to alter or vary the same or omit the levying of any of them or any part thereof and to advance and revive the same again, or to sell or lease the undertaking or some portion thereof or to lease or compound such rates, duties and charges or any of them as may appear to the Board to be for the interest of the Harbour.

To empower the Board to appoint and remove harbour masters, dock masters, pier masters, meters, weighers, constables and other officers and to define the limits within which such harbour and pier masters may exercise the powers to be conferred them.

To empower the Board to make and enforce bye-laws for the management, control and regulation of the existing and intended harbour, piers and works and with reference to passengers, animals, fish, goods, minerals, wares, merchandise and other articles, ships, vessels, boats, carts, carriages and other vehicles using or passing over or frequenting or resorting to the harbour or piers or any of the works, conveniences, or lands of the Board and with reference to the discharge and tipping of ballast and other matters.

To empower the Board to buoy, light or remove wrecks, obstructions, or floating timber and to recover the cost thereof and to prevent or regulate the deposit of refuse, spoil or rubbish on the beach or foreshore, at or on either side of the harbour within such distance or limits as may be defined by the Order.

To enable the Board to purchase or acquire by Agreement and hold lands, foreshore and other rights and easements for the purposes of the Order.

To empower the Board to purchase, lease or hire and use steam tugs for the assistance and convenience of vessels coming to the harbour and to make and recover charges for or in respect of the services rendered by such steam tugs and other vessels.

To define the limits of the Harbour of Millport and the area within which the powers to be conferred by the Order will be operative.

To authorise and empower the Board to borrow money by way of cash credit bond, and disposition and assignation in security, or otherwise, for the purposes of the Order on security of the existing Harbour and intended Harbour and works and of the lands and property belonging to the Board and of the tolls, rates, duties and charges authorised to be raised and levied thereat and upon such other securities as may be defined by the Order and to guarantee the repayment of principal and payment of interest of any moneys so borrowed and to make all necessary provisions with respect thereto.

To empower the Board to sell, feu, or lease lands, to let wharves or warehouses, buildings, yards, cranes, machines, shipping, staites, tips, or other conveniences and to make charges in respect thereof, or of any services to be rendered at, or by means thereof.

To empower the Board to enter into and carry into effect agreements with any Company, body or person with respect to the conveyance of traffic to or from the Harbour and piers and the shipment or landing thereof and as to the occupation or use of quay-space, wharves, staites, tips or other conveniences, and so far as necessary to confer similar powers on any such Companies, bodies or persons.

To incorporate with the Order all or some of the provisions of the following Acts, viz.:—The Harbours and Passing Tolls Act 1861, the Commissioners' Clauses Act 1847, the Lands Clauses Consolidation (Scotland) Act 1845, the Lands Clauses Consolidation Amendment Act 1860 and the Harbours, Docks and Piers Clauses Act 1847, with such alterations or modifications thereon respectively as may be provided by the Order; and if deemed necessary or expedient, to provide and declare that the provisions of the Harbours, Docks and Piers Clauses Act 1847 with respect to lifeboats and to keeping a tide and weather gauge, shall not apply to the Board or their undertaking.

A copy of this advertisement with a plan showing the proposed limits of the Harbour and a plan and section of the intended new works will on or before the 30th day of November instant be deposited for public inspection in the Private Bill Office of the House of Commons, in the Office of the Clerk of the Parliaments, House of Lords, in the Office at Rothesay of the Principal Sheriff Clerk of the County of Bute, in the Custom House at Greenock, and in the Office of the Board of Trade, London.
