OTICE is hereby given that His Majesty the King will hold Levées at Buckingham Palace on Monday the 23rd February, and on Monday the 9th March next, at twelve o'clock noon, and that for these and all future Levées Cards of Admission will be required, as the numbers at each of these Ceremonies must be limited.

In consequence of the State Apartments at St. James' Palace being temporarily required for other purposes, the Levees will be held, until further notice, at Buckingham Palace.

The following are the rules to be observed:

ATTENDANCES AND PRESENTATIONS.

- 1. All Officers, whether on the active or retired lists, of the Royal Navy and the Royal Marines, of whatever rank, will communicate with and obtain their cards from the Private Secretary to the First Lord of the Admiralty. All Civil Officers of the Admiralty will follow the same rule
- 2. All Officers, whether on the active or retired lists, of the Army, Militia, Yeomanry, or Volunteers, of whatever rank, except those on the Indian and Colonial Establishments, will communicate with and obtain their cards from the Adjutant-General at the War Office.
- 3. All Officers of the Indian Civil Service and of the Indian Army, of whatever rank, whether on the active or retired lists, will communicate with and obtain their cards from the Private Secretary to the Secretary of State at the India Office, Whitehall.

- 4. All Officers of the Colonial Service and Colonial Forces, of whatever rank, whether on the active or retired lists, will communicate with and obtain their cards from the Colonial Office, Whitehall, with the exception of Officers of the local Forces of the Colonies possessing responsible Government, who will apply to the War Office for their cards for attendance or for presentation by the Adjutant-General. The application must in all cases be supported by a credential from the Governor or Officer commanding the local Forces of the Colony.
- 5. Similarly, all Gentlemen connected with the Foreign Office, the Home Office, Officials connected with the Houses of Parliament or any Government Department, will communicate with and obtain their cards for attendance or presentation at Levées from the Department under which they serve.
- 6. Judges, Law Officers, King's Counsel, and all Legal Officials holding appointments under the Crown, are requested to make their applications through the Secretary to the Lord Chancellor.
- 7. Peers, Bishops, Members of Parliament, Clergy of all Denominations, and all Gentlemen other than the above-mentioned, will be good enough to communicate with the Lord Chamberlain at St. James' Palace, when they will each be furnished with a card of admission for use at the Levée.

In the case of the Levée to be held on the 23rd instant, all names, both for attendance and presentation, must be received at the various Offices not later than Wednesday next, the 18th instant.

For the Levée to be held on the 9th March, and for all future Levées, the names, both for attendance and presentation, must be received at the various Offices above indicated not later than eight days prior to the date of each Levée, except in the case of Officers who make application to the War Office, where, owing to the great number of applications to be dealt with, fourteen days before the date of each Levée will be required.

And whereas in the said Representation it is recommended that the said Burial Grounds (viz., the East and West Graveyards, Prestonpans) should be closed, subject to a reservation of the rights of existing lair-holders to make future interments with the consent of the Local Authority; provided always as regards all future interments that the exercise of the right of burial be not injurious to the public health, that no graves be less than five feet deep, that no grave be buried in unless it can be opened to that depth without exposure of coffins, and that notice be given to the Sanitary Inspector of the Burgh of Prestonpans on the day preceding that on which a grave is to be opened:

Now, therefore, His Majesty in Council is pleased to give notice of such Representation, and to order that the same be taken into consideration by a Committee of His Majesty's Most Honourable Privy Council on the 28th day of

March 1903:

And whereas the Secretary for Scotland made a Representation stating that he had received a copy of an Interlocutor by the Sheriff-Substitute of Lanarkshire at Hamilton, finding that the Old Strathaven Graveyard, situated in Castle Street, Strathaven, in the Parish of Avondale, is in a condition which is offensive and contrary to decency:

And whereas in the said Representation it was recommended that the said Graveyard should be closed, subject to certain regulations:

And whereas notice of the said Representation, and of the time when it pleased His Majesty to order the same to be taken into consideration by a Committee of the Lords of the Privy Council, has been duly published in the Edinburgh Gazette, and has been fixed as required by the said Act:

Now, therefore, His Majesty, by and with the advice of His Privy Council, is pleased to order as follows, viz. :

That burials be forthwith discontinued in the Old Strathaven Graveyard, situate in Castle Street, Strathaven, in the Parish of Avondale, provided that the right of interment shall be reserved to the following parties :-

(1) All Heritors and Householders of the Parish of Avondale as per Valuation Roll, 1901-2, with their wives and widows and single members of their families:

And whereas the Secretary for Scotland made a Representation stating that he had received a copy of an Interlocutor by the Sheriff-Substitute of Fife and Kinross at Cupar, finding that the Old Burial Ground at Milton of Balgonie, in the Parish of Markinch, is so crowded with bodies as to be dangerous to health and offensive and contrary to decency:

And whereas in the said Representation it was recommended that the said Burial Ground should be closed, subject to certain exceptions:

And whereas notice of the said Representation, and of the time when it pleased His Majesty to order the same to be taken into consideration by a Committee of the Lords of the Privy Council, has been duly published in the Edinburgh Gazette, and has been fixed as required by the said Act:

Now, therefore, His Majesty, by and with the advice of His Privy Council, is pleased to order as follows, viz.:—

That burials be forthwith discontinued in the Old Burial Ground at Milton of Balgonie, in the Parish of Markinch, except for the burial Any widow or widower whose husband or wife has been buried in the said burial ground.

(2) The cremated ashes of any person having right of burial within the aforesaid burial

(3) The following persons, being old residenters within the Parish of Markinch, who have relatives buried in the said burial ground, provided that there shall be ground therein, available for their interment under the conditions hereinafter set forth, videlicet:—

Provided, as regards all interments after the date of this Order:

That the exercise of the right of burial shall not be injurious to public health:
That no interment shall be made in any part of the Burial Ground unless the coffin can be laid at a depth of four feet from the surface of the ground to the upper side of the coffin, and that without the exposure of another coffin:
That such burials be made at sight of the sanitary inspector of the district in which the said burial ground is situated: and that notice be given to the sanitary inspector on the day proceeding that on which a grave is to be opened.

BYE-LAWS AND REGULATIONS

Made by the Lord Provost, Magistrates, and Councillors of the Burgh of Dundee, hereinafter called the Corporation, coming in place and stead of the Commissioners of Police for the Burgh of Dundee, under and by virtue of "The Dundee Corporation Act, 1894." and as such the Local Authority of the District, and also as the Promoters and Users of the Transways within the Burgh of Dundee, under "The Dundee Transways, Turnpike Roads, and Police Act, 1875," "The Dundee Street Transways, Turnpike Roads, and Police Act, 1875," "The Dundee Street Transways, Recreation Grounds, Police and Improvement Act, 1887," "The Dundee Extension and Improvement Act, 1894," "The Dundee Corporation Act, 1894," "The Dundee Corporation (Transways) Act, 1898," "The Dundee Gas, Street Improvements and Transways Act, 1899," and "The Dundee Corporation Order Confirmation Act, 1901," and Acts thereby incorporated, for preventing the commission of any nuisance in or upon any Carriage, or in or against any premises belonging to them, and for regulating the travelling in or upon any Carriage belonging to them: the distances at which Carriages using the Transways shall be allowed to follow one after the other; the stopping of Carriages using the Transways; and the traffic on the Roads in which the Transways are laid; and for other purposes.

1. No Tramway Car or Tramway Carriage (hereinafter in these Bye-Laws and Regulations called "Car") shall follow any other Car on the same line of rails at a nearer distance than 50 yards, except in case of accident or mishap, when a derelict Car may be drawn or propelled by another

2. Every Driver and Conductor of any Car shall stop the Car for the purpose of taking up passengers in the course of its journey, whenever required by any person desiring to enter any Car, as well as at the Stances allotted to it by the Magistrates, but no Car shall stop at or within ten yards on either side of any crossing from one line of Tramway to another line of Tramway, or at or within ten yards of any crossing over any Street, or on any curve or gradient where difficulty would be experienced in starting the Car.

3. All carts, carriages, or other vehicles travelling or 3. All carts, carriages, or other vehicles travelling or being driven on or over or standing on any part of any road in which the Tramways or any of them are laid shall, on any Car approaching, take the side of the road or Tramway other than that upon which such Car is ap-proaching, so as to steer clear of the same when passing: Provided always that should such cart, carriage, or other rabials he stading travelling. vehicle be standing, travelling, or passing on any part of any road with an ample free space between and the nearest line of rail, so as to allow of the safe passing of the Car, this rule shall not apply.

4. All persons in charge of any animal or animals shall take or drive them out of the way, and all foot passengers shall also get out of the way of any passing Car; but the Drivers and Conductors of all Cars shall have their brakes always under control, and use their utmost endeavours to avoid any collision with or injury to any animals or foot passengers, and shall keep a good look-out for children incautiously straying or walking in the Streets or attempting to cross over in the face of an approaching Car, and the Driver shall, by sounding his bell, give warning

and the Driver shall, by sounding his bell, give warning of the approaching Car.

5. When any Car is following any vehicle ample space between the Car and such vehicle shall be allowed, so that in the event of the vehicle pulling up suddenly no collision may result thereby; but every vehicle shall go out of the way of the Car with all despatch, so as to keep the Tramway clear for the use of the Car.

6. No Car shall be stopped abreast, or within twelve yards, of another Car on an adjoining line of rails except the precasary occasions; and when Cars on different lines.

on necessary occasions; and when Cars on different lines are passing each other the Drivers shall reduce the speed of the Cars, and gently put on the brakes, to guard against running over persons that may be crossing in the rear of either Car.

7. In the event of any Street being blocked, the Driver of any Car shall stop the same before arriving at the place where the block occurs, so as to keep an open space between for carriages to pass. In case a Car is stopped by any block so long as to bring two Cars together, the so that the time lost by the delay may be gradually made up as soon as possible; but notwithstanding no Car shall be driven faster than the rate prescribed by the Board of Trade.

8. When Cars are going in opposite directions, and likely to meet near a facing point (whether such facing point leads to a Junction, Siding, or Cross-Over), Drivers shall not pass each other until they are certain that the Car first approaching such facing point has taken it safely. The Car about to take a point shall have the precedence

of the other.

9. No person shall act as a Conductor of any Tramway Car, unless and until he be Licensed by the Magistrates, and such License may be granted annually, and may be withdrawn on one conviction, and shall be withdrawn on two convictions by any Magistrate of any breach of any Bye-Law: Provided always that the Chief Constable shall be entitled to grant temporary Licenses till the first meeting of the Magistrates after application for any such

10. All Drivers of Cars, on coming in sight of any cart, carriage, or other vehicle standing on the line of Tram-way on which he is plying, or by the side thereof, without there being free space to pass, shall sound his bell as a signal to the Drivers or persons in charge of any such cart, carriage, or other vehicle, and that for a distance of 30 yards at least before coming up to such cart, carriage,

or other vehicle.

11. All Drivers and Conductors of Cars shall obey all orders by any Police Officer on duty on the road or in the route travelled over, who is hereby authorised to give such directions as may be necessary for the safety of vehicles and passengers, and for securing the observance of the foregoing Bye-Laws and Regulations in all other

12. No person shall enter, mount, or leave, or attempt to enter, mount, or leave any Car whilst in motion, but should any person do so, he shall be responsible for any

mishap or injury to himself or others by having done so.

13. All persons desiring to alight from any Car shall do so before any person boards such Car for the purpose of travelling thereon, and all persons desirous of boarding the Car shall permit such persons to alight as aforesaid.

14. No person, except a passenger or intending passenger, or a servant of the Tramways Department of the Corporation acting in the performance of his duty, shall enter mount any Car.

15. No person in a state of intoxication, or affected with any dangerous infectious or contagious disease, shall enter or mount upon any Car, and, if found in or upon any Car, shall be immediately removed by or under the direction of the Conductor.

16. When any Car contains in the interior thereof the full number of passengers which it is licensed to carry in the inside, no additional person shall enter, mount, or re-main in the interior of any such Car, except by the express permission of the Conductor first obtained. When any Car contains in the conductor first obtained. When any Car contains in the outside thereof the full number of passengers which it is licensed to carry on the outside, no additional person shall enter, mount, or remain in or on the outside of any such Car.

7. No passenger, or other person, not being a servant of the Tramways Department of the Corporation acting in on the steps, platforms, buffers, or guards of any Car, or stand on the roof, or sit on the outside rail on the roof of any Car, and shall cease to do so immediately on request by the Conductor.

18. No person shall bring into or upon, or convey, or cause or permit to be brought into or upon or conveyed in or on any Car, any bundle of clothing or any article or thing tending to communicate any dangerous infectious or contagious disease, or any article of an offensive or dangerous character, or of a bulk or description which may interfere with the comfort of any passenger, and such article or thing, if introduced, may be removed summarily from such Car by the Conductor.

19. No person shall take a dog or other animal into or on any Car, except by permission of the Conductor, nor in any case in which the conveyance of such dog or other animal might be offensive or an annoyance to passengers. No person shall take a dog or other animal into any Car after having been requested not to do so by the Conductor. Any dog or other animal found on any Car shall be removed by the person in charge of such dog or other animal from the Car immediately upon request by the Conductor. In default of compliance with such request, and without prejudice to the presention of the present of the pres and without prejudice to the prosecution of the person offending hereunder, such dog or other animal may be removed by or under the direction of the Conductor.

20. No person shall travel in or on any Car with loaded firearms, or any article, instrument or implement, or any material or substance, which may be dangerous or offen-

sive to the passengers.

21. No person shall wilfully cut, tear, soil, or damage the seats or the iurnishings or tittings, or remove or deface any number plate, advertisement, printed or other notice, of or on any Car, or break or scratch any window, waith or need or incompany or in result of or otherwise wilfully paint, or wood or ironwork of, or otherwise wilfully damage any Car. Any person acting in contravention of this Bye-Law and Regulation shall be liable to the penalty prescribed by these Bye-Laws and Regulations, in addition to the liability to pay the amount of any damage done.

22. No passenger of other person shall smoke or carry a lighted pipe or eigar or eigarette inside any Car. Every person smoking on the outside of a Car shall occupy a

seat in the rear, so as not to annoy passengers.

23. No passenger or other person shall, while travelling in or upon any Car, play or perform upon any musical

or other instrument.

24. No person shall swear or use obscene, indecent, or offensive language whilst in or upon any Car, or spit, or commit any nuisance in or upon or against any Car, or wilfully interfere with the comfort of any passenger.

25. A person whose dress or clothing might, in the opinion of the Conductor of a Car, soil or injure the furnishings or fittings of the Car, or the dress or clothing of any passenger; or a person who, in the opinion of the Conductor, might for any other reason be offensive or objectionable to passengers, shall not be entitled to mount or enter or travel in or on any Car, and may be prevented from mounting or entering any Car, and shall not mount

from mounting or entering any Car, and shall not mount or enter any Car after having been requested not to do so by the Conductor, and if found in or on any Car, shall, on the request of the Conductor, lave the Car, upon the fare, if previously paid, being returned.

26. Personal or other luggage (including the tools of artisans, mechanics, and daity labourers) shall be placed in such position on the Car as shall be directed by the Conductor; but in no case shall such luggage be placed in the interior or on the roof of any Car, and all such luggage shall only be carried at the owner's risk. No more than 28 lbs of personal luggage for each passenger more than 28 lbs. of personal luggage for each passenger

shall be carried tree.

27. The Conductor of every Car shall take the fare of each passenger immediately on entering the Car, and he shall furnish a Ticket which has not been previously issued, to each passenger immediately on payment of fare. 28. Each passenger shall, upon demand, pay to the Conductor, or other duly authorised officer of the Corporation, the fare legally demandable for the journey.

32. The Drivers and Conductors of every Car shall be responsible for, and be bound to keep time in accordance with the Time-Tables of the Corporation, unavoidable accidents or detailing on the west specific to the conductors.
