THE following is the text of the Agreement, signed at Washington, on the 7th of May 1903, between Great Britain and the United States of Venezuela, for the appointment of a Commission to examine and decide the British Claims against the Venezuelan Government:—

Whereas, by a Protocol signed on the 13th February 1903, by his Excellency the Right Honourable Sir Michael Henry Herbert, G.C.M.G., C.B., His Britannic Majesty's Ambassador Extraordinary and Plenipotentiary to the United States of America, and Mr. Herbert W. Bowen, duly authorised thereto by the Government of Venezuela, it was agreed that certain claims by British subjects, including those preferred by the Railway Companies, against the Government of Venezuela, should, unless otherwise satisfied, be referred, under the conditions specified in the Protocol, to a Mixed Commission, to consist of one British and one Venezuelan member, and that in each case where the Commissioners came to an agreement their decision should be final; and that, in cases of disagreement, the claims should be referred to the decision of an Umpire nominated by the President of the United States of America.

Now the undersigned, his Excellency the Right Honourable Sir Michael Henry Herbert, G.C.M.G., C.B., His Britannic Majesty's Ambassador Extraordinary and Plenipotentiary to the United States of America, and Mr. Herbert W. Bowen, duly authorised thereto by the Government of Venezuela, have further agreed as follows:—

One member of the Commission shall be appointed by His Britannic Majesty's Government;

and the other by the Government of Venezuela, and the Umpire shall be nominated by the President of the United States of America.

If either of the said Commissioners or the Umpire shall fail or cease to act, his successor shall be appointed forthwith in the same manner as his predecessor. The said Commissioners and Umpire are to be appointed as soon as possible.

The Commissioners and the Umpire shall meet at Carácas on the first day of June 1903.

Before assuming the functions of their office, the Commissioners and the Umpire, if necessary, shall make solemn oath or declaration carefully to examine and impartially to decide according to justice and the provisions of the Protocol of the 19th February 1903, and of the present Agreement, all claims submitted to them, and the oath or declaration so made shall be embodied in the record of their proceedings. The Commissioners, or, in case of their disagreement, the Umpire, shall decide all claims upon a basis of absolute equity, without regard to objections of a technical nature, or of the provisions of local legislation.

The decisions of the Commission, and, in the event of their disagreement, those of the Umpire, shall be final and conclusive. They shall be given in writing. All awards shall be made payable in sterling money of Great Britain or its equivalent in silver at the current rate of exchange of the

The Commissioners, or Umpire, as the case may be, shall investigate and decide the said claims upon such evidence or information only as shall be furnished by or on behalf of the Governments of Great Britain and Venezuela respectively. They shall be bound to receive and consider all written documents or statements which may be

presented to them by or on behalf of the Govern- | Martin Murphy, Esq., Provincial Engineer of the ments respectively in support of or in answer to any claim, and to hear oral or written arguments submitted by the Agent of each Government on every claim. In case of their failure to agree in opinion upon any individual claim, the Umpire shall decide.

Every claim shall be formally presented to the Commissioners within thirty days from the day of their first meeting, unless the Commissioners or the Umpire in any case extend the time for presenting the claim for a further period not exceeding three months. The Commissioners shall be bound to examine and decide upon every claim within six months from the day of its first formal presentation, and, in case of their disagreement, the Umpire shall examine and decide within a corresponding period from the date of such disagreement.

The Commissioners and the Umpire shall keep an accurate record of their proceedings. For that purpose each Commissioner shall appoint a Secretary versed in the language of both countries to assist him in the transaction of the business of the Commission.

In the proceedings, either the English or the Spanish language may be used. Except as herein stipulated, all questions of procedure shall be left to the determination of the Commissioners, or, in case of their disagreement, to the

Reasonable remuneration to the Commissioners and to the Umpire for their services and expenses, and the other expenses of the said Arbitration, are to be paid in equal moieties by the Powers parties to this agreement.

Statutes of the Distinguished Service Order.

EDWARD, R. and I.

EDWARD, by the Grace of God, of the United Kingdom of Great Britain and Ireland and of the British Dominions beyond the Seas King, Defender of the Faith, Emperor of India, Sovereign of the Distinguished Service Order, to all to whom these

presents shall come, greeting.

Whereas Her late Majesty, Our Beloved Mother, Queen Victoria, by a Warrant under Her Royal Sign Manual, countersigned by one of Her Principal Secretaries of State, and bearing date at Her Court at Balmoral the sixth day of September one thousand eight hundred and eightysix, in the fiftieth year of Her reign, did institute and create a new naval and military order of distinction, to be styled and designated the "Distinguished Service Order."

And whereas by the said Royal Warrant it was, among other things, ordained that the said Order should rank next to, and immediately after, Our Order of the Indian Empire, and that the badge of the Order should have on the reverse Her late Majesty's Imperial and Royal Cypher, V.R.I.

And whereas We have thought fit to signify Our Royal Will and Pleasure that the said Order shall rank next to, and immediately after, Our Royal Victorian Order, and that the badge shall have on the reverse Our Imperial and Royal

Cypher, E.R.I.

Now, therefore, We do, by these presents for Us, Our Heirs and Successors, ordain and appoint: Firstly, that the Distinguished Service Order shall rank next to, and immediately after, Our Royal Victorian Order, and that the companions thereof shall, in all places and assemblies whatsoever, have place and precedency next to, and immediately after, the members of Our said Royal Victorian Order, and shall rank among themselves according to the dates of their respective nominations. Secondly, that the badge of the Order, which shall consist of a gold cross, enamelled white, edged gold, having on one side thereof in the centre, within a wreath of laurel, enamelled green, the Imperial Crown in gold, upon a red enamelled ground, and on the reverse, within a similar wreath, and on a similar red ground, Our Imperial and Royal Cypher, E.R.I., shall be suspended from the left breast by a red riband, edged blue, of one inch in width.

Given at Our Court at Saint James' this twenty-fourth day of July, in the second year of Our Reign, and in the year of Our Lord one thousand nine hundred and two.
