WHEREAS the Secretary for Scotland has, under the provisions of the Burial Grounds (Scotland) Act, 1855, made a Representation stating that he has received a copy of an Interlocutor by the Sheriff-Substitute of Stirlingshire at Falkirk, finding that (1) the portion of the Burial Ground known as the Parish Churchyard of Larbert, which is represented by the area included within a green border on the plan signed by the Secretary for Scotland, and deposited with the Sheriff-Clerk of the County of Stirling at his office at Falkirk, and (2) the Larbert East United Free Church Churchyard, are dangerous to health and offensive and contrary to decency, and that the said Larbert East United Free Church Churchyard and the said portion of the Parish Churchyard of Larbert should be closed in terms of the

At the Court at Buckingham Palace, the 12th | afore-mentioned Act, provided that right of interment should be reserved as follows, viz. :-

- (1) Within the said portion of the Parish Churchyard of Larbert and in the said Larbert East United Free Church Churchyard to any widow or widower whose husband or wife has been buried therein;
- -(a) Within the burial place of the family of (2)-Dundas of Carronhall, in the said Parish Churchyard of Larbert, to Margaret Isabella Dundas, residing at Winterfield, North Berwick, widow of the late Lieu-tenant-Colonel Joseph Dundas of Carronhall, and to her daughter, Eleanor Charlotte Dundas:

(b) Within the burial place of the family of Stirling of Glenbervie, in the said Parish Churchyard, to any two of the descendants of the late Sylvester Douglas Stirling of Glenbervie, or in place of one such to the wife or husband, widow or widower of a descendant :

Provided always, as regards all interments after the date of the Order, in either the said Larbert East United Free Church Churchyard or the said portion of the Parish Churchyard of Larbert, that the exercise of the right of burial shall not be injurious to public health; that no interment shall be made unless the coffin can be laid at a depth of four feet from the surface of the ground to the upper side of the coffin, and that without the exposure of another coffin; that such burials in either of the said burial grounds be made at sight of the Sanitary Inspector of the District in which the Burial Ground is situated; and that notice be given to the Sanitary Inspector on the day preceding that on which a grave is to be opened:

And whereas in the said Representation it is recommended that the said Larbert East United Free Church Churchyard and the said portion of the Parish Churchyard of Larbert should be closed, subject to the exceptions named.

Now, therefore, His Majesty in Council is pleased to give notice of such Representation, and to order that the same be taken into consideration by a Committee of His Majesty's Most Honourable Privy Council on the 21st day of November 1903:

And His Majesty is further pleased to direct that this Order, or notice thereof, be published in the Edinburgh Gazette, and that copies of this Order, or notice thereof, be affixed, as required by the above-mentioned Act, on the doors of the Churches of, or on some other conspicuous places within, the Parish affected by such Representation one month before such Representation is so considered.

THEREAS by sub-section (one) of section two hundred and thirty-eight of the Merchant Shipping Act, 1894, it is provided that, where it appears to His Majesty that due facilities are, or will be, given by the Government of any foreign country for recovering and apprehending seamen who desert from British merchant ships in that country, His Majesty may, by Order in Council, stating that such facilities are or will be given, declare that that section shall apply in the case of such foreign country, subject to any limitations, conditions, and qualifications contained in the Order:

And whereas it appears to His Majesty that due facilities are given by the Government of Japan for recovering and apprehending seamen who desert from British merchant ships in that country:

And whereas Her late Majesty Queen Victoria was pleased, by and with the advice of Her Privy Council, on the nineteenth day of May one thousand eight hundred and ninety-eight, to apply the provision of section two hundred and thirty-eight of the Merchant Shipping Act, 1894, in the case of Japan:

And whereas since the date of the above-mentioned Order in Council the Treaty of Commerce and Navigation entered into by Her late Majesty the Queen of the United Kingdom of Great Britain and Ireland, Empress of India, and His Majesty the Emperor of Japan, dated the sixteenth day of July one thousand eight hundred and ninety-four, has been brought into operation in accordance with the provisions of Article XXI. thereof:

And whereas under Article XIV. of such Treaty it was provided that the stipulations therein contained for the recovery of deserters from the vessels of their respective countries should not apply to the subjects of the country where the desertion takes place:

And whereas it is desirable to repeal the said Order in Council of the nineteenth day of May one thousand eight hundred and ninety-eight:

Now, therefore, His Majesty, by virtue of the power vested in Him by the hereinbefore recited sub-section (one) of section two hundred and thirty-eight of the Merchant Shipping Act, 1894, and by and with the advice of His Privy Council, is pleased to order and declare, and it is hereby ordered and declared, that from and after the publication hereof in the London Gazette seamen not being slaves (and not being British subjects) who, within His Majesty's dominions, desert from ships belonging to subjects of His Majesty the Emperor of Japan, shall be liable to be apprehended and carried on board their respective ships :

And His Majesty, by virtue of the powers vested in Him by the provisions of section seven hundred and thirty-eight of the Merchant Shipping Act, 1894, and by and with the advice of His Privy Council, is further pleased to order and declare that upon and after the publication hereof in the London Gazette the Order in Council made on the 19th day of May one thousand eight hundred and ninety-eight, and published in the London Gazette on the twentieth day of May one thousand eight hundred and ninety-eight, shall be revoked, and the same is hereby revoked accordingly:

And the Secretary of State for the Home Department, the Secretary of State for the Colonies, and the Secretary of State for India, in Council, are to give the necessary directions herein accordingly.

WHEREAS by an Act passed in the fortyfifth and forty-sixth years of Her late Majesty Queen Victoria's reign, intituled "The Militia Act, 1882," it is, amongst other things, enacted that, save as therein otherwise provided, the Militia shall be trained and exercised for not less than twenty-one days, and not more than twenty-eight days, in every year, at such times and at such places in every part of the United Kingdom as His Majesty may appoint, and also that His Majesty may, from time to time, with the advice of His Privy Council, order that the period of training and exercise, in any year, of all or any part of the Militia be extended, but so that the whole period of training and exercise be not more than fifty-six days; and also, on the other hand, may order that in any year the annual training of all or any part of the Militia be dispensed with :

And whereas it is expedient for the year one thousand nine hundred and three that the training of the Militia unit hereinafter mentioned should be extended beyond the period of twenty-eight days:

Now, therefore, His Majesty, with the advice of His Privy Council, is pleased to order and direct that, for the year one thousand nine hundred and three, the period of training and exercise of the under-mentioned Field Company of Militia shall be extended, under the provisions of the before-cited Act, from twenty-eight days to forty-eight days, viz. :—

HEREAS by section one hundred and three of the Patents, Designs, and Trade Marks Act, 1883, as amended by section six of the Patents, Designs, and Trade Marks (Amendment) Act, 1885, it is enacted as follows:—

(1) If Her Majesty is pleased to make any arrangement with the Government or Governments of any foreign state or states for mutual protection of inventions, designs, and trade marks, or any of them, then any person who has applied for protection for any invention, design, or trade mark in any such state, shall be entitled to a patent for his invention or to registration of his design or trade mark (as the case may be) under this Act, in priority to other applicants; and such patent or registration shall have the same date as the date of the application in such foreign state:

Provided that his application is made, in the case of a patent within seven months, and in the case of a design or trade mark within four months, from his applying for protection in the foreign state with which the arrangement is in force:

Provided that nothing in this section contained shall entitle the patentee or proprietor of the design or trade mark to recover damages for infringements happening prior to the date of the actual acceptance of his complete specification or the actual registration of his design or trade 'mark in this country, as the case may be:

- (2) The publication in the United Kingdom, or the Isle of Man, during the respective periods aforesaid of any description of the invention, or the use therein during such periods of the invention, or the exhibition or use therein during such periods of the design, or the publication therein during such periods of a description or representation of the design, or the use therein during such periods of the trade mark, shall not invalidate the patent which may be granted for the invention, or the registration of the design or trade mark:

(3) The application for the grant of a patent, or the registration of a design, or the registration of a trade mark under this section must be made in the same manner as an ordinary application under this Act; provided that, in the case of trade marks, any trade mark the registration of which has been duly applied for in the country of origin may be registered under this Act:

(4) The provisions of this section shall apply only in the case of those foreign states with respect to which Her Majesty shall from time to time by Order in Council declare them to be applicable, and so long only in the case of each state as the Order in Council shall continue in force with respect to that state:

And whereas it pleased Her late Majesty Queen Victoria to make an arrangement of the nature contemplated by the said enactment, by and in virtue of a declaration signed and sealed by Her Majesty's Ambassador at Paris on the seventeenth day of March one thousand eight hundred and eighty-four, conveying Great duly the accession oť Britain and Ireland to the International Convention and Protocol for the Protection of Industrial Property, signed by representatives of certain Powers on the twentieth day of March one thousand eight hundred and eighty-three, and duly ratified on the sixth day of June one thousand eight hundred and eighty-four, power being reserved to Her Majesty to accede thereafter to the provisions of the said Convention and Protocol on behalf of the Isle of Man, the Channel Islands, and any of Her Majesty's possessions, which Declaration of Accession was ouly accepted by the French Government on behalf of the signatory Powers by and in virtue of a Declaration dated the second day of April one thousand eight hundred and eighty-four:

And whereas by various Orders in Council Her late Majesty Queen Victoria was pleased to declare that the hereinbefore recited provisions of the said Act should apply to the several foreign countries named in the said orders parties to the said Convention and Protocol:

And whereas on the fourteenth day of December one thousand nine hundred, an Additional Act was agreed upon between Her late Majesty Queen Victoria and the Government of the Foreign Countries parties thereto for the purpose of modifying certain of the provisions of the said International Convention and the Protocol annexed thereto, the ratifications of which Additional Act were duly effected except as regards the Dominican Republic and Servia :

And whereas by section one of the Patents Act, 1901, it is enacted as follows :--- 1.—(1) In the first proviso to sub-section one of section one hundred and three of the Patents, Designs and Trade Marks Act, 1883 (which section relates to the time for making applications for protection under international arrangements) the words "twelve months" shall be substituted for the words "seven months":

(2) An application under that section shall be accompanied by a complete specification, which, if it be not accepted within the period of twelve months, shall, with the drawings (if any), be open to public inspection at the expiration of that period:

And whereas on the first day of May one thousand nine hundred and three, the German Empire duly acceded to the said International Convention Protocol and Additional Act :

Now therefore His Majesty, by and with the advice of His Privy Council, and by virtue of the authority committed to Him by the above enactments doth declare, and it is hereby declared, as follows:—

 The provisions of section one hundred and three of the Patents, Designs, and Trade Marks Act, 1883, as amended by section six of the Patents, Designs, and Trade Marks (Amendment) Act, 1885, and by section one of the Patent Act, 1901, shall apply to Germany.

\* Section 8 of the Corn Returns Act, 1882, provides that where returns of purchases of British Corn are made to the Local Inspector of Corn Returns in any other measure than the imperial bushel, or by weight or by a weighed measure, that Officer shall convert such returns into the imperial bushel, and in the case of weight or weighed measure the conversion is to be made at the rate of sixty imperial pounds for every bushel of wheat, fifty imperial pounds for every bushel of barley, and thirty-nine imperial pounds for every bushel of oats.
