DUNS AND DISTRICT (SWINE FEVER)
PROHIBITION OF MOVEMENT REVOCATION ORDER OF 1904.

The Board of Agriculture and Fisheries, by virtue and in exercise of the powers in them vested under the Diseases of Animals Acts, 1894 to 1903, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:—

1. The Orders described in the Schedule to this Order is hereby, from and after the commencement of this Order, revoked: Provided that such revocation shall not invalidate or make unlawful anything done under the Order hereby revoked

before the commencement of this Order, or interfere with the institution or prosecution of any proceeding in respect of any offence committed against, or any penalty incurred under, the Order hereby revoked before the commencement of this Order.

- 2. This Order shall come into operation on the thirtieth day of January nineteen hundred and four.
- 3. This Order may be cited as the Duns and District (Swine Fever) Prohibition of Movement Revocation Order of 1904.

Letters Patent (that is to say):-

Letters Patent bearing date the twentieth day of February 1899, and numbered 3760 - 99, granted to Richard Jaegar, of 1 Bernstrasse, Berlin, in the Empire of Germany, Merchant, for an improved process for the dry slaking of lime, and apparatus therefor, for the term of fourteen years from the date of the said Letters Patent, and which Letters Patent have been assigned to and are now held by Henry Ernest Victor, Baron de Barreto, of Sennowe Park, Ryburgh, in the county of Norfolk.
