MOTOR CAR ACT, 1903. County of Perth.

The Secretary for Scotland has received an application from the County Council of the County of Perth praying that Regulations under the Motor-Car Act, 1903, should be made—

1st. Prohibiting Motor Car traffic on the high-ways enumerated in Schedule I. appended to the application, for the reasons therein set forth.

2nd. Restricting such traffic to the extent that the speed limit shall not exceed ten miles an hour on the highways enumerated in Schedule II. appended to the application, for the reasons therein set forth.

3rd. Restricting the rate of speed to ten miles an hour for the safety of the public in the towns, villages, and other special places or areas enumerated in Schedule III. appended to the application.

The application, with relative schedules and a map on scale one inch to the mile showing the roads proposed for prohibition and restriction, and the points where prohibition or restriction begins and ends, may be inspected during office hours at the Office of the County Clerk, County Buildings, Perth, and objection to the making of any such Regulation may be sent in writing to the Secretary for Scotland, at the Scottish Office, Whitehall, London, S.W., within three weeks of the date of publication of this notice. A copy of any such objection should be sent at the same time to the County Clerk.
