ORDER OF THE BOARD OF AGRICULTURE AND FISHERIES.

(DATED 29TH JUNE 1904.)

The Board of Agriculture and Fisheries, by virtue and in exercise of the powers in them vested under the Diseases of Animals Acts, 1894 to 1903, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:-

Application of Swine Fever (Regulation of Movement) Order of 1903.

1. From and after the commencement of this Order, the provisions of the Swine Fever (Regulation of Movement) Order of 1903 shall apply to the Area described in the Schedule to this Order.

Commencement.

2. This Order shall come into operation on the ninth day of July nineteen hundred and four.
