#### FACTORY AND WORKSHOP ACT, 1901. |

The Secretary of State for the Home Department hereby gives notice, pursuant to section 80 of the Factory and Workshop Act, 1901, that he has certified to be dangerous the generation, transformation, and use of electricity in electrical stations and in any factory, workshop, dock, wharf, quay, warehouse, or other place to which section 79 of the Factory Act is applied, and that he proposes to make regulations to apply to all such places aforesaid, other than electrical stations in which electricity is used at pressure greater than 250 and less than 650 volts.

Copies of the regulations proposed to be made may be obtained at the office of the Chief Inspector of Factories, Home Office, London, and at the local offices of the Inspectors of Factories.

Objections to the draft regulations by or on behalf of any persons affected by the regulations must be sent to the Secretary of State within forty days from the date of this notice.
