ELEMENTARY SCHOOL TEACHERS (SUPERANNUATION) ACT, 1898.

Notice is hereby given, in pursuance of the Rules Publication Act, 1893, that a supplementary rule under section 6 of the above-mentioned Act is proposed to be made by the Treasury and Board of Education in order to enable the Treasury to delegate to the Paymaster-General any or all of its powers under Numbers 28 to 30 of the Elementary School Teachers (Superannuation) Rules, 1899.

- (1) The Treasury may by order direct that the Paymaster-General shall, for all or any purposes, be substituted for the Treasury in Rules 28 to 30 of the Elementary School Teachers (Superannuation Rules, 1899; and while any such order is in operation, those Rules shall be construed as if for the purposes mentioned in the order that substitution took effect.
- (2) This Rule may be cited as the Elementary School Teachers Superannuation Rule, 1905, and shall be construed together with the Elementary School Teachers Superannuation Rules, 1899.

Special Regulations respecting Open Competitive Examinations for the situation of Assistant to the Head of the Intelligence Branch of the Board of Agriculture and Fisheries. (Supplementary to the General Regulations respecting Open Competitive Examinations for situations in the Civil Service, included in Schedule A of the Order in Council of 4th June 1870.)

N.B.—These Regulations are liable to alteration for future Examinations.

- I. The limits of age for this situation are 22 and 35, and Candidates must be of the prescribed age on the first day of the Examination.
- II. The Examination will be in the following subjects, viz.:—
 - 1. English Composition and Précis Writing.
 - 2. Agriculture.
 - 3. German.
 - 4. French.

Note.—All Candidates must pass to the satisfaction of the Civil Service Commissioners in German.

III. Application for permission to attend an Examination must be made at such times and in such manner as the Commissioners may appoint.

IV. A fee of £2 will be required from each Candidate attending the Examination.
