^{*} Section 8 of the Corn Returns Act, 1882, provides that where returns of purchases of British Corn are made to the Local Inspector of Corn Returns in any other measure than the imperial bushel, or by weight or by a weighed measure, that Officer shall convert such returns into the imperial bushel, and in the case of weight or weighed measure the conversion is to be made at the rate of sixty imperial pounds for every bushel of wheat, fifty imperial pounds for every bushel of barley, and thirty-nine imperial pounds for every bushel of oats.

BURGH OF PORT-GLASGOW. NOTICE.

A PETITION has been presented by the Provost, Magistrates, and Councillors of the Burgh of Port-Glasgow to the Sheriff of Renfrew and Bute at Greenock, craving him (first) (1) to ascertain and declare for the purposes of the Town Councils (Scotland) Act, 1900, the population within the Municipal Boundaries of the Burgh of Port-Glasgow; (2) to declare that the number of Magistrates and Councillors of said Burgh shall be increased from nine to twelve; (3) to determine when and in what manner this increase is to be effected; (4) to determine when and in what order the whole of said Magistrates and Councillors as increased in number shall vacate office; and (5) to determine all questions that may arise in connection with such increase, and to pronounce any Order that may be found expedient for effecting the same, or for obviating any difficulty which may prevent the due carrying out thereof; and (second) (1) to redivide the whole of the said Burgh into four Wards; (2) to apportion the existing Councillors and the increased number of Councillors for said Burgh among the Wards so created or altered; and (3) to determine all questions that may arise in connection with such redivision of Wards or apportionment, and to pronounce any Order that may be found expedient for effecting the same, or for obviating any difficulty which may prevent the due carrying out thereof.

The boundaries of the Wards suggested by the Pursuers are shown on a plan lodged with said Petition, and are as follows, viz.:—

First Ward.

From the point where the eastern parliamentary boundary of the Burgh meets the River Clyde, up said boundary to the point where it meets the southern pacliamentary boundary of said Burgh, along said last mentioned boundary to a point in the centre of the Barr's Brae Road, down the centre of said road to Barr's Braefoot, along Barr's Braefoot to Ropework Lane, down the centre of said lane to Dockhead Street, across that street to the breast of the dry dock, along the east or south-east breast of the dry dock, through the wet rock to the River Clyde, and along this river to the foresaid point of commencement of this Ward.
