ings, cross-overs, passing places, triangles, tubes, subways, conduits, section boxes, contact studs, ropes, wires, cables, poles, manholes, drain rails, drains, access boxes, shafts, warehouses, offices, waiting-rooms, stables, carriages, carriagehouses, engines, engine-houses, generating and transforming stations and sub-stations, stationary engine works, sheds, buildings, works, and conveniences connected therewith respectively, and to enter upon, take and acquire, and use the lands and property required for the purposes of the said tramways and works, as shown on the deposited plans and described in the deposited Book of Reference aftermentioned or any of them.

Wholly situate in the County of Mid-Lothian, the City and the County of the City arish of Edinburgh, and the City Parish of Edinburgh, a single line of Tramway forming a crossing between the lines of Tramway No. 1 commencing in Queenferry Street at a point 10 yards or thereby from the commencement of the proposed Tramway No. 1, and terminating in said street at a point 37 yards or thereby from the commencement of said Tramway No. 1.

TRAMWAY No. 2,

Wholly situate in the County of Mid-Lothian, the City and the County of the City of Edinburgh, and the City Parish of Edinburgh, commencing by a junction with Tramway No. 1 at its termination, passing thence along the Dean Bridge and Queensferry Road, and terminating in said road at a point 33 yards or thereby west of the line of the north-east wall of Belford Road.

TRAMWAY No. 3.

Wholly situate in the County of Mid-Lothian, the City and the County of the City of Edinburgh, and the City Parish of Edinburgh, commencing by a junction with Tramway No. 1 at its termination, and passing thence along Lynedoch Place, Belford Road, over Belford Bridge, and terminating in said Queensferry Road at the termination of Tramway No. 2.

TRAMWAY No. 4.

Wholly situate in the County of Mid-Lothian, the City and County of the City of Edinburgh, and the City Parish of Edinburgh, commencing in the Queensferry Road, by a junction with Tramways Nos. 2 and 3 at their termination, and passing thence along the said Queensferry Road and terminating at a point in said road 66 yards or thereby east of the east end of the Station Buildings at Craigleith Railway Station.

TRAMWAY No. 5.

Wholly situate in the County of Mid-Lothian, the City and County of the City of Edinburgh, and the City Parish of Edinburgh, commencing in Comely Bank at a point 15 yards or thereby west of the line of the west wall of East Fettes Road, and passing thence along Comely Bank and Barnton Terrace, and terminating in the Queensferry Road by a junction with the intended Tramway No. 4 at its termination.

# TRAMWAY No. 5 (a).

Wholly situate in the County of Mid-Lothian, the City and County of the City of Edinburgh, and the City Parish of Edinburgh, a single line of Tramway forming a crossing between the lines of Tramway No. 5 commencing at a point 10 yards or thereby from the commencement of Tramway No. 5 and terminating at a point 37 yards or thereby from the commencement of said Tramway No. 5.

TRAMWAY No. 6.

Wholly situate in the County of Mid-Lothian, the City and County of the City of Edinburgh, and the City Parish of Edinburgh, commencing by a junction in Queensferry Road with Tramways Nos. 4 and 5 at their termination, and passing thence along the said Queensferry Road, and terminating in said Road at the western boundary of the County of the City of Edinburgh at a point 220 yards or thereby west of the Station Buildings at Craigleith Railway Station.

TRAMWAY No. 6 (a)
Wholly situate in the County of Mid-Lothian, the City and County of the City of Edinburgh, and the City Parish of Edinburgh, a single line of Tramway forming a crossing between the lines of Tramway No. 6, commencing at the commencement of Tramway No. 6, and terminating in said Queensferry Road at a point 27 yards or thereby west from said commencement of Tramway No. 6.

TRAMWAY No. 7.

Wholly situate in the County of Mid-Lothian, and passing through portions of the Parishes of Corstorphine and Cramond, commencing by a junction in the said Queensferry Road with Tramway No. 6 at its termination, and passing thence along the said road and terminating at a point on Cramond Bridge above the medium filum" of the River Almond, being the boundary between the counties of Mid-Lothian and Linlithgow.

TRAMWAY No. 7 (a).

Wholly situate in the County of Mid-Lothian and Parish of Cramond, commencing by a junction with Tramway No. 7 at a point 193 yards or thereby east of the milestone indicating a distance of three miles from Edinburgh, and passing thence along the Queensferry Road, the road to Davidson's Mains, Quality Street, and High Street, Davidson's Mains, and terminating at a point on the north side of said High Street 127 yards or thereby east of the fountain at the east end of the village of Davidson's Mains at the gate of the east avenue to Barnton House.

TRAMWAY No. 8.

Wholly situate in the County of Linlithgow and Parish of Dalmeny, commencing by a junction with Tramway No. 7 at its termination, and passing thence along the said Queensferry Road, and terminating in the said road at a point 430 yards or thereby west of Newhalls Gate, being the boundary of the Burgh of South Queensferry

TRAMWAY No. 8 (a).

Wholly situate in the County of Linlithgow and Parish of Dalmeny, commencing by a junction in the Queensferry Road with Tramway No. 8 at a point 120 yards or thereby west of Newhalls Gate, and crossing said Queensferry Road in a curved direction and terminating at the south boundary of said road at a point 126 yards or thereby west of Newhalls Gate.

TRAMWAY No. 8 (b).

Wholly situate in the County of Linlithgow and Parish of Dalmeny, commencing by a junction with Tramway No. 8, at a point in the Queensferry Road 137 yards or thereby west of Newhalls Gate, and crossing said Queensferry. Road in a curved direction and terminating at the south boundary of said road 133 yards or thereby west of Newhalls Gate.

TRAMWAY No. 9.

Wholly situate in the County of Linlithgow and Parish of Dalmeny and Burgh of Queensferry, commencing by a junction with Tramway No. 8 at its termination, and passing thence along the said Queensferry Road, and terminating at a point 41 yards or thereby east of the milestone indicating the distance of 8 miles from Edinburgh.

TRAMWAY No. 10. Wholly situate in the County of Linlithgow, Parish of Dalmeny, and Burgh of Queensferry, commencing by a junction with Tramway No. 9 at its termination, and passing thence along the said Queensferry Road, and terminating in said road at a point 40 yards or thereby east of the eastmost house in the High Street of the Burgh of South Queensferry.

The said Tramways will be made or pass from, in, through, or into the following Counties, Parishes, and Places, or some of them (that is to say):—

The Royal Burgh and City of Edinburgh.

The County of the City of Edinburgh.

The County of Mid-Lothian. The County of Linlithgow.

The City Parish of Edinburgh, and Parishes of Corstorphine, Cramond, and Dalmeny.

The Burgh of Queensferry.

The said Tramways or some parts thereof will be laid so that at several places for a distance of 30 feet or upwards a less space than 9 feet 6 inches will intervene between the outside of the footpath and the nearest rail of the Tramway at the places indicated by a thick dotted line on the plans to be deposited as hereinafter mentioned.

2. The Tramways are intended to be constructed on a gauge of 4 feet 8½ inches, or such other gauge as may be authorised, with such grooves, rails, plates, tubes, sleepers, chairs, points, channels, junctions, turntables, turnouts, crossings, crossovers, passing places, triangles, subways, conduits, section boxes, contact studs, ropes, wires, cables, poles, manholes, drain rails, drains, and shafts as may be necessary to work the same.

AREA A.—Wholly situate in the County of Mid-Lothian and Parish of Cramond, consisting of plot of land with tenement house and two sheds erected thereon (the whole being the property of Mrs. Crow, Peggy's Place, Davidson's Mains), on the north side of the High Street of Davidson's Mains, and the western part of that arable field labelled 269 on the Ordnance Survey Sheet of the scale of twenty-five inches to the mile published in 1895. The whole of Area A. extends to 2.61 acres or thereby.

AREA B.—Wholly situate in the County of Mid-Lothian and Parish of Cramond, consisting of a triangular portion of ground at Bonniefield on which are built

To empower the Company to work and use the proposed Tramways or any of them by means of engines, carriages, trucks, and vehicles propelled (in addition to, or in substitution for animal power) by electrical power generated at and applied from stations or otherwise, or pneumatic, gas, oil, or other mechanical power, or partly by one such power and partly by another such power, and for that purpose, or any purpose appurtenant or ancillary thereto, to confer on the Company such rights, powers, and privileges as may be necessary or expedient for carrying into effect the purposes of the Order; and in particular power to enter upon and open the surface of and to lay down on, in, under or over the surface of any footway, footpath, street, road, place, railway, or bridge, pier or quay, such poles, wires, tubes, contact studs, mains, plates, or apparatus, and to make and maintain such openings, poles, wires, tubes, or ways on, in, under, or over any such surface, and to attach to any house or building such supports, brackets, and fittings as may be necessary or convenient either for the actual working of the tramways or for providing access to or in connection with any generating stations, engines, machinery, or apparatus, and to empower the Company, for the purpose of working the Tramways, and of the Order to erect engines and machinery, and to empower the Company to acquire and hold Patent and other rights and licences, and to use Patent and other rights and licences in relation to such electrical or other mechanical power.

10. To enable the Company to levy and recover tolls, rates, and charges for the use of the proposed Tramways and for the conveyance of passengers and traffic thereon, and to confer, vary, or extinguish exemptions from the payment of such tolls, rates, and charges, and to alter existing tolls, rates, or charges and any exemptions therefrom, and to vary and extinguish all existing rights and privileges, and to confer other rights and

privileges.

11. To provide for and regulate the user by the Company for the purposes of the Order of any paving, metalling, or road material and District Committees or by the Town excavated or removed by them during the Council of Queensferry or such Local Authority, construction of any of the proposed Tramways body, or person, and to confirm any agreements

7. To empower the Company from time and other works, and the ownership and disposal

of any surplus paving, metalling, or material.

12. To authorise the Company when by reason of the execution of any work affecting the surface or soil of any footway, footpath, street, road, or place, or otherwise in which any tramway, channel, conduit, or electric line shall be laid or placed it is necessary or expedient to remove or discontinue the use of any tramway, channel, conduit, or electric line as aforesaid, or any part thereof, to make in the same or any adjacent street, road, or place, and maintain, work, and use, so long as occasion may require, a temporary tramway, channel, conduit, or electric line or temporary tramways, channels, conduits, or electric lines in lieu of the tramway, channel, conduit, or electric line, or part of a tramway, channel, conduit, or electric line, so removed or discontinued to be used or intended so to be.

To make provision for preventing injury to any tramways of the Company and to any works, carriages and electrical and other machinery or other apparatus connected therewith, and for preventing danger to passengers thereon, and to impose, in respect of any such injury, interference, or obstruction, such punishment or penalty as the Order may define.

15. To reserve to the Company the exclusive right of using on the proposed tramways, engines and carriages with flange wheels or wheels specially or particularly adapted to run

on a grooved edge or other rail.

16. To incorporate in the Order the Lands Clauses Acts and extend and apply to the intended tramways and works, with or without variation or amendment, all or some of the powers and provisions of the Tramways Act, 1870, and so far as may be deemed expedient to alter, amend, repeal, render inapplicable, or extend, all or some of the provisions of that | and copies of the "Gazette" notice above

- 25. To authorise the Company to provide motor cars or omnibuses and work the same and make charges in respect thereof.

Tramway No. 1 (Double Line): -6.53 chains or thereabouts in length, wnolly situate in the City Parish of Edinburgh, commencing by a junction with the existing Tramway in Home Street at a point .3 chain, or thereabouts, northwards from the northern side of Gilmore Place, and passing thence in a westerly direction by a curved line along the roadway of Gilmore Place, and terminating by a junction with the existing Tramway in Gilmore Place at a point in line with the western side of Hailes Street.

Tramway No. 2 (Double Line):—4.2 chains or thereabouts in length, wholly situate in the City Parish of Edinburgh, commencing by a junction with the existing Tramway in Gilmore Place at a point .12 chain or thereabouts, westward of the western line of Upper Gilmore Place, and terminating at a junction with the existing Tramway in Gilmore Place at a point 1.8 chains or thereabouts eastwards from the line of the east side of Leamington Terrace.

Tramway No. 3 (Double Line): -4.32 chains or thereabouts in length, wholly situate in the City Parish of Edinburgh, commoncing by a junction with the existing Tramway at a point in line with the east side of Viewforth, and terminating at a junction with the existing Tramway, 4.4 chains or thereabouts, eastwards from the line of the east side of St. Peter's Place.

Tramway No. 4 (Double Line):-6 furlongs 6.9 chains or thereabouts in length, wholly situate in the City Parish of Edinburgh, commencing by a junction with the existing Tramway in Granville Terrace at a point in line with the west side of Merchiston Park, and passing thence in a south-westerly direction along the roads or streets of Granville Terrace, Polwarth Gardens, and Polwarth Terrace, and terminating at the terminus of the existing Tramway in Polwarth Terrace at a point .08 chain or thereabouts northwards from the line of the north side of Colinton Road.

Tramways Nos. 1, 2, 3, and 4 will each consist of a Double Line of Tramways, and will be laid along the centre of the respective streets or roads, and will take the place of the existing lines of Tramway along the said streets or roads, and the Corporation will take up, remove, or alter all or any passing places or rails laid in said streets or roads which interfere with or will be rendered unnecessary by the laying down of the said Tramways Nos. 1, 2, 3, and 4.

NEW TRAMWAYS.

Tramway No. 5 (Single Line with Passing Places.)—4 furlongs 0.68 chain or thereabouts in length, of which 2 furlongs 5.55 chains or thereabouts are single line and 1 furlong 5.13 chains or thereabouts are double line, wholly situate in the City Parish of Edinburgh, commencing by a junction with Tramway No 14

at its termination in Polwarth Terrace and passing thence in a south-westerly direction along the roadway of Colinton Road, and terminating at a point in the Municipal Boundary of Edinburgh opposite the entrance to Craiglockhart Safety Ponds.

Tramway No. 6 (Single Line with Passing Places.)—2 furlongs 5.73 chains or thereabouts in length, or which 1 furlong 8.8 chains or thereabouts are single line and 6.93 chains or thereabouts are double line, wholly situate in the Parish of Colinton, commencing by a junction with Tramway No. 5 at the Municipal Boundary of Edinburgh, and passing thence in a southwesterly direction along Colinton Road, and terminating at a point 1.07 chains or thereabouts westwards from the line of the west side of Lane to Craiglockhart Poorhouse.

Tramway No. 7 (Single Line with Passing Places.)—3 furlongs 4.41 chains or thereabouts in length, of which 1 furlong 9.84 chains or thereabouts are single line and 1 furlong 4.57 chains or thereabouts are double line, wholly situate in the Parish of Colinton, commencing by a junction with Tramway No. 6, .85 chain or thereabouts eastwards from the line of the east side of Craiglockhart Avenue, and passing thence by a curved line in a north-westerly direction along Craiglockhart Avenue, thence by a curved line into Slateford Road, terminating at a point in the said road at the Municipal Boundary of Edinburgh near the east side of the aqueduct carrying the Union Canal over the said Slateford Road.

Tramway No. 8 (Double and Single Lines.)—2 miles 2 furlongs 5.42 chains or thereabouts in length, of which 1 mile 6 furlongs 9.41 chains or thereabouts are double line and 3 furlongs 6.01 chains or thereabouts are single line, wholly situate in the City Parish of Edinburgh, commencing by a junction with Tramway No. 7 at the Municipal Boundary of Edinburgh in Slateford Road, and passing thence in a north-easterly direction along the roads or streets of Slateford Road, Angle Park Terrace, Dundee Street, Fountainbridge, and terminating at a point in Fountainbridge .6 chain or thereabouts westward from the line of Main Point.

Tramway No. 9 (Double and Single Lines.)-8 furlongs, 7.17 chains or thereabouts in length, of which 8 furlongs 3.84 chains or thereabouts are double line and 3.33 chains or thereabouts are single line, wholly situate in the City Parish of Edinburgh, commencing by a junction with the existing Tramway in Leith Street at a point .2 chain or thereabouts northwards from the line of the south side of Broughton Street, and passing thence by a curved line in a north-westerly direction along the roads or streets of Broughton Street and Bellevue, and by a curved line in a north-easterly direction along the roads or streets of East Claremont Street and Broughton Road, and terminating at a point in the said Broughton Road .2 chain or thereabouts westwards from the line of the west side of Pilrig

Tramway No. 10 (Double Line.)—2 furlongs 6.27 chains or thereabouts in length, wholly situate in the City Parish of Edinburgh, commencing in Bellevue by a junction with Tramway No. 9 at a point .62 chain or thereabouts eastwards from the line of the east side of East Claremont Street, and passing thence in a northwesterly direction along the roads or streets and to make and maintain such openings,

of Bellevue, Rodney Street, and Canonmills, and terminating by a junction with the existing Tramway at a point in the roadway of Canonmills in line with the south-west abutment of the Bridge crossing the Water of Leith.

Tramway No. 11 (Double Line.)—1.4 chains or thereabouts in length, wholly situate in the City Parish of Edinburgh, commencing by a junction with the existing Tramway at a point .59 chain or thereabouts westwards from the line of the west side of Broughton Street, and terminating by a junction with Tramway No. 9 at a point .3 chain or thereabouts northwards from the line of the north side of York Place.

Tramway No. 12 (Double Line.)—1.65 chains or thereabouts in length, wholly situate in the City Parish of Edinburgh, commencing by a junction with the existing Tramway at a point .62 chain or thereabouts eastwards from the line of the east side of Broughton Street, and terminating by a junction with Tramway No. 9 at a point .3 chain or thereabouts northwards from the line of the north side of York Place.

The said existing and intended Tramways are and will be situate in the City Parish of Edinburgh, Parish of Colinton, and City and Royal Burgh of Edinburgh and County of the City of Edinburgh and County of Mid-Lothian.

At the places indicated in the plans by a thick dotted line it is proposed to lay the Tramways, so that for a distance of 30 feet or upwards a less space than 9 feet 6 inches will intervene between the outside of the footpath on either side of the road and the nearest rail of the Tramways.

The proposed Tramways will be constructed on a gauge of 4 feet  $8\frac{1}{2}$  inches, and it is not intended to run carriages or trucks adapted to run on railways, and the motive power will be mechanical power.

To deviate laterally from the lines of the Tramways and Works to the extent shown on the plans to be deposited as hereinafter mentioned, and vertically from the levels as shown on the sections after-mentioned, and as may be provided by the Order.

To authorise the Corporation to enter upon and break up the surface of and cross up, appropriate, raise, lower, alter, or divert temporarily or permanently streets, roads, lands, passages, footpaths, tramways, sewers, drains, mains, gas and water pipes, telegraph and telephonic wires and apparatus, and works of any description within the Perishes and City and Royal Burgh before mentioned, so far as may be necessary or convenient for carrying out the objects and the purposes of the Order, and to make junctions with existing tramways.

To authorise the Corporation and their lessees from time to time to work the said reconstructed and intended Tramways or any part thereof by means of engines, carriages, trucks, and vehicles, propelled (in addition to, or in substitution for, animal power), by cable or by electric power, generated at and applied from stations or otherwise, or steam, pneumatic gas, oil, or other mechanical power, or partly by one and partly by another, and to adapt the existing Tramways or any of them to the use of such power, and to make such alterations therein, and to execute all such works thereon and in connection therewith, and in, over, or under the streets or roads in which the same are laid as may be necessary for that purpose, posts, wires, tubes on, in, under, or over any such surface, and remove any lamp-post, pillarbox, and other erections, and to attach to any house or building, bridge, or existing lamp-post or standard such supports, brackets, and fittings as may be necessary or convenient either for the actual working of the existing and proposed Tramways, or for providing access to or in connection with any generating station, engines, machinery, or apparatus, and to authorise the Corportion to erect engines, machinery, and apparatus, and to acquire and hold patent and other rights, licences, and to use patent and other rights and licences in relation to such electrical or other mechanical power.

To authorise the Corporation for the purpose of working the existing and proposed tramways beyond, as well as within, the City. to supply electrical energy from any generating station of the Corporation, and so far as may be necessary in that behalf to amend, enlarge, or repeal all or some of the provisions of the Edinburgh Corporations Electric Lighting Order, 1891, and of the Electric Lighting Acts, and to require the lessees of the Tramways to take such supply of electrical energy from the Corporation on terms which may be agreed or settled by arbitration, or provided in the Order.

To authorise the Corporation from time to time, and either temporarily or permanently, to make maintain alter, renew, or remove such tramways, crossings, cross-overs. passing places, sidings, junctions, turnovers, and other works in addition to those particularly specified in this notice, as may be necessary or convenient for the efficient working of the proposed Tramways, or any of them, and for facilitating the passage of traffic along streets, or for providing access to any works, stables, engine-houses, or carriage sheds of the Corporation.

To authorise the Corporation to substitute double lines for single or interlacing lines, single lines for double or interlacing lines, and interlacing lines for double or single lines on any of the Tramways.

To authorise the Corporation to cut and lop any trees growing, situate. or planted in or near any roads or streets in which their existing or intended Tramways may be laid, which may interfere with the construction or working of the Tramways.

or working of the Tramways.

To enable the Corporation in carrying out the powers and purposes of the Order or any of them, when, by reason of the execution of any works affecting the surface or soil of any street, road, or thoroughfare, or otherwise, it is necessary or expedient to remove or discontinue the use of any part of the Tramways, or any of them, or the existing Tramways, to make in the same or adjacent street, road, or thoroughfare in any Parish mentioned in this Notice, and maintain, so long as occasion may require, a temporary Tramway or temporary Tramways in lieu of part of the Tramways so removed or discontinued to be used, or intended so to be.

To provide for the maintenance of the whole or some portion or portions of the respective streets, roads, and places upon or along which any of the proposed Tramways, rails, or plates may be laid, and to provide for and regulate the use and disposal by the Corporation of any paving metal or road material excavated

or removed by them in the construction of the proposed Tramways or any of them, or in the exercise of any of the powers of the Order.

To empower the Corporation, by themselves or their lessees, to work the intended Tramways, and to place and run carriages thereon, and to demand, take, and recover tolls, rates, fares, and charges in respect of the use of such carriages, and to alter or vary tolls, rates, and charges, and to confer, vary, or extinguish exemptions from payment of tolls, rates, and charges.

To provide that the proposed Tramways shall for all purposes be deemed part of the Tramway undertaking of the Corporation, and to authorise and empower the Corporation to lease the same to the lessees of the Corporation Tramways as part of the present system of Tramways of the Corporation, or to any person or Company, on such terms and conditions and for such considerations as they think fit, and to provide that the said Tramways and works connected therewith shall or may be held and taken to be part of any existing lease of the other Tramways of the Corporation, in the same way and to the same effect as if such Tramways and works had originally been included therein, or otherwise as may be either agreed or provided by the Order, and to confirm any lease or agreements already made or that may be made with reference thereto.

To abolish all existing limitations and enactments relative to the rate of speed of the existing Tramways of the Corporation, and to repeal all the provisions contained in any of the Acts and Orders and Bye-laws of and relating to the Edinburgh Tramways owned by the Corporation, and to make provision in the Order with respect thereto.

To provide that Section 43 of the Tramways Act, 1870, shall not apply to the intended Tramways and works or to any part thereof.

Tramways and works or to any part thereof.

To impose penalties for malicious damage to any of their existing and the intended Tramways, and of works connected therewith, and for offences under Section 50 of the Tramways Act, 1870.

To authorise the Corporation to erect, construct, and widen, maintain, and use the works and improvements hereinafter mentioned, with all necessary and proper works and conveniences connected therewith.

The said works and improvements are the following, that is to say:—

- (1) A widening, alteration, and improvement wholly situate in the City Parish of Edinburgh (Work No. 1) of part of the Street of Gilmore Place on South Side thereof, commencing at a point opposite the centre of Hailes Street and terminating at a point 17 yards or thereabouts Westwards from the line of the West Side of Leven Street.
- (2) A widening, alteration, and improvement wholly situate in the City Parish of Edinburgh (Work No. 2) of part of the street of Gilmore Place on both sides thereof, commencing at a point in line with the west Boundary Wall of Church at west corner of Upper Gilmore Place, and terminating at a point 12 yards or thereabouts Eastwards from the line of the East Side of Leamington Terrace.

- (3) A widening, alteration, and improven ent wholly situate in the City Parish of Edinburgh (Work No. 3) of part of Colinton Road on both sides thereof, commencing at a point 3 yards or thereabouts Northwards from the Northern Boundary of No. 120 Polwarth Terrace, and terminating at a point 13 yards or thereabouts Westwards from the line of the West Side of Craiglockhart Terrace.
- (4) A widening, alteration, and improvement wholly in the City Parish of Edinburgh (Work No. 4) of part of Colinton Road on the North Side thereof, commencing at a point in Colinton Road 3 yards or thereabouts Eastwards from the Western Boundary of Waverley House, and terminating at a point in the Municipal Boundary of Edinburgh, near the entrance to Craiglockhart Safety Ponds.
- (5) A widening, alteration, and improvement wholly in the Parish of Colinton (Work No. 5) of part of Colinton Road and Craiglockhart Avenue, commencing at a point in Colinton Road 20 yards or thereabouts westwards from the line of the east boundary wall of Craigowan, and terminating in Craiglockhart Avenue at a point 65 yards or thereabouts northwards from the line of the north side of Colinton Road.
- (6) A widening, alteration, and improvement wholly in the Parish of Colinton (Work No. 6) of part of Craiglockhart Avenue, on the east side thereof, commencing at a point 21 yards or thereabouts northwestwards from the line of the northboundary wall of Craiglockhart House Grounds, and terminating at a point in Slateford Road at the west side of the aqueduct carrying the Union Canal over the said Slateford Road.
- (7) A widening, alteration, and improvement wholly in the City Parish of Edinburgh (Work No. 7) of the Bridge crossing the Union Canal at Fountainbridge on both sides thereof, commencing at a point in line with the eastern boundary of the North British Railway Company's property, and terminating at a point 42 yards or thereabouts eastwards from the line of the east side of Freer Street.
- (8) A widening, alteration, and improvement wholly in the City Parish of Edinburgh (Work No. 8) of part of Broughton Road, on the west side thereof, commencing at a point 40 yards or thereabouts northwards from the northern line of Claremont Crescent, and terminating at a point opposite Broughton Point.
- (9) A widening, alteration, and improvement wholly in the City Parish of Edinburgh (Work No. 9) of part of Broughton Road, on the east side thereof, commencing at a point 35 yards or thereabouts northwards from the line of the northern side of M'Donald Road, and terminating at a point in the southern boundary of the North British Railway (Edinburgh, Leith, and Granton Branch), opposite the south-east corner of Powderhall Station.

- (10) A widening, alteration, and improvement wholly in the City Parish of Edinburgh (Work No. 10) of part of Broughton Road on the west side thereof, commencing at a point at or near the eastern boundary of the North British Railway (Edinburgh, Leith, and Granton Branch), opposite the north-east corner of Powderhall Station, and terminating at a point opposite the centre of Gibson Street.
- (11) A widening, alteration, and improvement wholly in the City Parish of Edinburgh (Work No. 11) of part of the street of Canonmills on the north side thereof, commencing at a point in line with the south side of Evre Place, and terminating at a point in line with the south gable of Canonmills Mission Hall.
- (12) For the protection of foreshore and public roadway at Joppa (Work No. 12), a sea wall, wholly in the City Parish of Edinburgh, along the foreshore and ex adverso of the City and Royal Burgh of Edinburgh, commencing at a point in line with the east gable of No. 36 Esplanade Terrace, and terminating at a point in the western boundary of Joppa Salt Works 9 yards or thereabouts northwards from the southern boundary of the same.
- (13) For the protection of the foreshore and public roadway at Joppa (Work No. 13), a sea wall, wholly in the City Parish of Edinburgh, along the foreshore and ex adverso of the City and Royal Burgh of Edinburgh, commencing at a point in the east boundary wall of Rockville, 4 vards or thereabouts northwards from the southern boundary of the same, and terminating at a point in the western boundary of Eastfield 4 yards or thereabouts northwards from the southern boundary of same.

To provide that the Corporation may charge any owner or owners, and if more than one in such proportions as the Corporation think fit, with the cost which the Corporation may incur in constructing and improving the sea wall at Joppa, and to require and to compel any such owner or owners to refund the Corporation such cost accordingly.

To adopt and to incorporate, with or without amendment or with such amendments or variations as may be necessary or expedient, the provisions or some of the provisions of the Burgh Police (Scotland) Act, 1903, and particularly the provisions or some part of the provis ons of the following sections thereof:-Section 12, to enable the Corporation to impose certain conditions with respect to plans and sections of any new street or court submitted for the approval of the Corporation; Section 15, with respect to the fencing of ground abutting on any street or court; Section 26, with respect to the sanction of the Corporation in respect of buildings for noxious trades; Section 44, to confer powers on the Corporation with respect to public parks and the use of the same; Section 50, to require all carriages, carts, and vehicles of all sorts to carry lights; Section 51, to prohibit betting in streets, courts, parks, or open spaces, common stairs, closes, alleys, or passages; Section 79, to confer further and enlarged powers on the Corporation over and relating to the foreshore of the Burgh; Section 104 (f),

to provide for the proportion of expenses with respect to private streets and courts being fixed by the Corporation; and to adapt such provisions to the circumstances and requirements of the Corporation and to the provisions of the Edinburgh Municipal and Police Acts, 1879 to 1903; and also to incorporate any other provisions of the said Police Act of 1903 with such variations and alterations, all as

the Order may prescribe.

To amend the Edinburgh Municipal and Police Act, 1879, and particularly to amend Section 248 of the said Act, by making the provisions thereof extend to Holyrood Park or other place to which the public have access, and to amend Sub-section 1 of that Section by extending and enlarging and amending the scope of the provisions thereof with respect to prostitution: and Section 278 of the said Act by extending its provisions to every owner, factor, or agent who shall knowingly and wilfully let any house or building or part of a house or building to be used for the purposes set forth in the said Section.

To amend the Edinburgh Municipal and Police Act, 1900, and in particular Section 77 of the said Act, by making the word "street" to comprehend and include for the purpose of the said Section any common stair, common close, alley, or passage.

To amend the Edinburgh Municipal and Police Acts with respect to illuminated pictures or representations within the city, or on or at any part of any house or building or erection or enclosure, and with respect to the performance of any bands of music at or within any building or enclosure, so as to cause any crowds or obstruction of the free passage along any street; and to confer power on any officer of police to enter and to require the owner or occupier of any such house or building, erection, or enclosure within or upon which any such exhibition may be exposed or musical performance carried on to cease the same and to desist therefrom, or to cause such exhibit or any such music to be stopped, and to prescribe penalties for the breach of any such provision.

To make provision for the incorporation of the Institution now under the management and control of the Corporation known as the Royal (Dick) Veterinary College, and for the future management thereof, and to repeal, alter, and amend any existing provisions or requirements in any deed or instrument relating to the said College, and to make all suitable and necessary provision for the administration of the said College, under the new incorporation, and for carrying out the purposes of the said Institution as so incorporated, and to make provision for the appointment and election of the persons so to be incorporated for the management and administration of the said College.

To authorise the Corporation to pay over to the Board proposed to be incorporated for the administration of the said College such sum or sums of money as the Corporation think fit, or as may be agreed or provided in the Order, and to authorise the Trustees of the late Miss Mary Dick to pay over to the said Board so to be incorporated the share of the free residue of the said Mary Dick's Estate, the Corporation of all their acts and intromissions and management of and connected with the said College.

To make provision for the administration of the said College so to be incorporated, and to make agreements for and with respect to such administration, and to set out the purposes for which the said College should be administered, and to confirm any agreement or agreements which have been or which may be made in

relation to the administration of the said College. To authorise the Corporation to borrow and reborrow money for the reconstruction and conversion of the existing Tramways and for the construction and equipment of the said intended Tramways, and for executing the foresaid works and improvements authorised by the Order or any of them, and for the acquisition of lands, houses, and other property, and for all or any of the other purposes of the Order by mortgage, or by cash credit, or by annuity, or by short loans on simple receipt bills or promissory notes, or otherwise, or by the creation and issue of stock on security of the tolls, rates, duties, and assessments leviable under the Edinburgh Municipal and Police Acts, 1879 to 1903, and the Corporation Stock Act, 1894, and any Act amending the same; the provisions of the said Edinburgh Municipal and Police Acts, 1879 to 1903, in regard to a sinking fund or sinking funds for repayment of moneys borrowed or the redemption of such stock will or may, with such variations and amendments as the Order will or may prescribe, be applied to the moneys borrowed and to be borrowed or raised under the authority of the Order.

To authorise the Corporation to impose, assess, levy, and recover tolls, rates, duties, assessments, and charges for the purposes of the Order and for the purchase or acquisition of lands, houses, and other property, and that, under and in terms of the powers and provisions of the Edinburgh Municipal and Police Acts, 1879 to 1903, or otherwise, as the Order may provide, and to alter, vary, amend, or enlarge tolls, rates, duties, and assessments and charges. and to confer, vary, or extinguish exemptions from payment of tolls, rates, duties, assessments, and charges.

To enter into and carry into effect agreements and arrangements with Corporations, Local or Road Authorities, Companies, bodies, or persons, with respect to any of the objects and purposes of the Order, and any identical matters relating thereto, and to confirm any agreements made or to be made in relation to the objects, powers, and purposes of the Order.

The Order will vary or extinguish all rights, restrictions, powers, authorities, jurisdictions, privileges, servitudes, and exemptions inconsistent with, or which would or might in any way interfere with, the objects or purposes of the Order, and will confer, vary, or extinguish other rights, powers, authorities, jurisdictions, privileges, servitudes, and exemptions.

The Order will incorporate with or without modification or alteration the provisions of the Lands Clauses Acts and the Railways Clauses Consolidation (Scotland) Act, 1845, with respect to roads and the temporary occupation of lands during the construction of works, and provided by her Settlement for the purposes the Edinburgh Municipal and Police Acts, 1879 of said College. To exonerate and discharge to 1903, the Edinburgh Corporation Stock

Act, 1894, the Tramways Act, 1870, the Edinburgh Tramways Act, 1871. the Edinburgh Northern Tramways Act, 1884, and the other Acts of and relating to the Tramways in the City and Royal Burgh of Edinburgh acquired and constructed by, and now belonging to, the Corporation, and to confer upon the Corporation with respect to the Tramways proposed to be authorised and made applicable thereto, all or any of the provisions of, and the powers, rights, and privileges which the Corporation now have or may exercise with respect to their authorised Tramways and works under any of the said Acts.

To alter, amend, extend, and enlarge, or to repeal, so far as it may be necessary or desirable for the purposes of the Order, all or some of the powers and provisions of the Edinburgh Municipal and Police Acts, 1879 to 1903, the Tramways Act, 1870, the Edinburgh Tramways Act, 1871, the Edinburgh Northern Tramways Act, 1884, and the other Acts of and relating to the Corporation Tramways within the said City and Royal Burgh, 6 and 7 Will. IV., Cap. 25 (Local and Personal), the North British Edinburgh and Dundee and West of Fife Railways Amalgamation Act, 1864, the Caledonian Rail-way Act, 1845, the Caledonian and Scottish Central Railway Amalgamation Act, 1865, and the several Acts of Parliament of and relating respectively to the North British Railway Company and the Caledonian Railway Company, the Leith Corporation Tramways Confirmation Act, 1904, the Telegraph Acts, 1863 to 1899, the Act 3 Geo. IV., Cap. 91, the Roads and Bridges (Scotland) Act, 1878, the Local Government (Scotland) Act, 1889, the Burgh Police Acts, 1892 to 1903, and all or any Acts extending or amending any of these Acts, the Local Government (Scotland) Act, 1894, and the Public Health (Scotland) Act, 1897.
