ORDER OF THE BOARD OF AGRICULTURE AND FISHERIES.

(DATED 3RD JULY 1905.)

The Board of Agriculture and Fisheries, by virtue and in exercise of the powers vested in them under the Diseases of Animals Acts, 1894 to 1903, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:—

- 1. The application of the provisions of the Sheep-Scab (Compulsory Dipping Areas) Order of 1905 to the area described in the Schedule to this Order is suspended from the date hereof until after the first day of October nineteen hundred and five.
- 2. Nothing in this Order shall affect the operation in the said area of the Sheep-Dipping (Scotland) Order of 1905.

* Section 8 of the Corn Returns Act, 1882, provides that where returns of purchases of British Corn are made to the Local Inspector of Corn Returns in any other measure than the imperial bushel, or by weight or by a weighed measure, that Officer shall convert such returns into the imperial bushel, and in the case of weight or weighed measure the conversion is to be made at the rate of sixty imperial pounds for every bushel of wheat, fifty imperial pounds for every bushel of barley, and thirty-nine imperial pounds for every bushel of oats.
