<sup>\*</sup> Section 8 of the Corn Returns Act, 1882, provides that where returns of purchases of British Corn are made to the Local Inspector of Corn Returns in any other measure than the imperial bushel, or by weight or by a weighed measure, that Officer shall convert such returns into the imperial bushel, and in the case of weight or weighed measure the conversion is to be made at the rate of sixty imperial pounds for every bushel of wheat, fifty imperial pounds for every bushel of barley, and thirty-nine imperial pounds for every bushel of oats.

Whereas Regulations for the keeping and use of Petroleum for the purposes of light locomotives have been made under the fifth section of the Locomotives on Highways Act, 1896, and dated 18th March 1903; and

Whereas by the Motor Car Act, 1903, the said Act of 1896 is made applicable to persons in the public service of the Crown;

Now, therefore, I hereby declare that:-

The said Regulations, dated 18th March 1903, shall not apply to the keeping or use of Petroleum Spirit by or under the control of any Government Department. Such keeping or use may be the subject of Regulations to be made by the Department concerned.
