CULAG (LOCH INVER) AND LOCH CLAISH (LOCH INCHARD) PIERS.

### PROVISIONAL ORDER.

(Construction of Works by an extension of the existing Pier at Loch Claish (Loch Inchard); Maintenance and Improvement of Piers; Power to Levy Rates, &c.; Definition of Limits; Leasing of Rates, &c.; Borrowing of Money; Management and Regulation of Piers; Bye-laws; Constitution of Harbour Authority; Incorporation of Acts and other purposes.)

OTICE is hereby given that in pursuance of the provisions of the General Pier and Harbour Acts 1861 and the General Pier and Harbour Act 1861 Amendment Act application is intended to be made to the Board of Trade on or before the 23rd day of December next by His Grace Cromartie Sutherland Leveson Gower, Duke and Earl of Sutherland, K.G., in the County of Sutherland, for a Provisional Order (hereinafter referred to as "the Order") for all or some of the following among other purposes, that is to say:—

To empower the said Cromartie Sutherland Leveson Gower Duke and Earl of Sutherland or other the owner for the time being of the Piers hereinafter described (who are in this notice called "the Undertakers") to maintain improve and extend the Piers hereinafter men-

tioned, that is to say :-

 The existing Pier and Works known as Culag Pier (Loch Inver) in the Parish of Assynt and County of Sutherland.

(2) The existing Pier and Works known as Loch Claish Pier (Loch Inchard) in the Parish of Eddrachilles and County of Sutherland.

To construct and maintain in the Parish of Eddrachilles and County of Sutherland at Loch Claish (Loch Inchard) and in or upon the foreshore and bed of the sea adjoining the existing Pier at Loch Claish or near thereto the following works or some part or parts thereof (that is to say):—

- (1) An extension of the said existing Pier at Loch Claish commencing at the south-east extremity of said Pier and proceeding in a southerly direction for a distance of forty-nine feet or thereby from said point of commencement and there terminating, which work will be of open timber work.
- (2) A Quay commencing at the termination of Work No. 1 and proceeding in a south-easterly direction for a distance of three hundred and sixty feet or thereby and there terminating, which work will be solid throughout.

(3) The reclamation raising and making up of the foreshore enclosed by roadway leading to said existing Pier, and Work No. 2.

Together with all necessary and incidental works and conveniences required for the proper construction and use of the said Piers and Works.

To deviate laterally and vertically from the line or level of the said proposed works as shown on the deposited plans or described in the Order.

To purchase or acquire by agreement lands foreshore and other rights for the purposes of the Order.

And the expression "the Pier" in this notice means each of the said Piers and the Works connected therewith respectively.

To authorise the Undertakers to levy tolls rates and charges on vessels boats and other craft arriving at using or departing from the Pier and on passengers animals goods and other things landing or embarking or loaded or unloaded at the Pier or using the same, and in respect of warehouses sheds cranes mooring buoys weighing machines and other conveniences connected with the Pier and for the supply of water and ballast to vessels and to provide for the collection of such tolls rates and charges and to alter tolls rates and charges, to confer vary or extinguish exemptions from or to compound for a payment of tolls rates and charges and to confer vary extinguish other rights and privileges.

To empower the Undertakers to sell, let, or lease the Pier and the tolls rates and charges authorised to be levied by the Order for such period and on such terms as the Order may prescribe.

To define the limits within which the Undertakers shall have authority and the power to levy tolls, rates, and charges and within which the powers of the Pier Master and other officers and servants of the Undertakers may be exercised.

To authorise the Undertakers to borrow money for the purposes of the Pier and of the Order on the security of the Pier and of the tolls rates and charges authorised to be levied by the Order.

To provide for the application of the revenue of the Undertakers.

To authorise the Undertakers from time to time to excavate the foreshore and bed of the sea adjoining the Pier and to scour dredge deepen and improve the approaches to the Pier and to appropriate or dispose of the materials so dredged.

To make provisions for the maintenance management use and protection of the Pier and for the regulation and control of vessels persons and traffic using frequenting resorting to or employed loaded or unloaded at the Pier and to authorise the Undertakers to make alter and rescind bye-laws for such purposes or any of them and to impose and recover penalties for the breach or non-observance of such bye-laws.

To authorise the Undertakers to appoint and remove Pier Masters meters weighers and other officers and servants.

To constitute the Undertakers the Harbour Authority and Pilotage Authority for the Pier and the neighbourhood thereof and to confer on the Undertakers all powers rights and privileges which may be necessary for carrying the Order into effect and to vary or extinguish all rights or privileges which might interfere therewith.

To empower the Undertakers to buoy light or remove wrecks or other obstructions and to prevent or regulate the deposit of rubbish refuse or spoil on the beach or foreshore or in the neighbourhood of the Pier within such distance as may be specified in the Order. To provide that it shall not be obligatory on the Undertakers to charge the same rates at each of the Piers to which the Order applies and to vary section 17 of the General Pier and Harbour Act 1861 Amendment Act accordingly.

To incorporate with the Order all or some of the provisions of the Harbours Docks and Piers Clauses Act 1847 the Harbour and Passing Tolls Act 1861 the General Pier and Harbour Act 1861 and the General Pier and Harbour Act 1861 Amendment Act, the Lands Clauses Acts and of the Commissioners Clauses Act 1847 with such alterations and exception as may be provided by the Order.

And notice is hereby also given that on or before the 30th day of November instant plans and sections of the proposed new works with a copy of this notice will be deposited for public inspection with the Principal Sheriff Clerk of the County of Sutherland at his Office at Dornoch, at the Custom House of the Port of Inverness, at the Custom House of the Port of Wick, and at the Office of the Board of Trade, Whitehall, London.

Printed copies of the draft Provisional Order will be furnished by the undersigned at their offices as undermentioned and also at the Sutherland Estate Offices at Golspie to all persons applying for same on and after the 23rd day of December next at the price of 1s each.

Any objections to the Provisional Order must be deposited or received by the Board of Trade on or before the 20th day of January next. A copy of such objections must also be sent at the same time to the Promoters' Agents.

### DUMBARTON WATER WORKS AND BURGH EXTENSION.

(New and additional Water Works; Acquisition of Lands; Agreements; Wayleaves; Borrowing Powers; Application, Alteration and Repeal of Existing Acts and Orders; Extension of Boundaries of the Burgh of Dumbarton in the County of Dumbarton; Limits of Extended Burgh; Arrangement of Wards; Provisions for Valuation Roll and Register of Voters; Supplementary Valuation Roll; Extension and Application of existing Public and Private or Local Acts to the Extended Burgh; Alteration and Enlargement of Con-

stitution and Jurisdiction of Town Council of Extended Burgh and Dean of Guild Court, and conferring other and further Powers; Separation of the Districts annexed from the County of Dumbarton and from all other Jurisdictions, Powers, Functions and Authorities within the same; Abolition of separate Jurisdictions within the Districts annexed; Local and Sanitary Authority; Transfer of Property and Rights and Roads, Streets and Footpaths; Agreements; Alteration, Enlargement and Extension of the Powers of Rating and Assessment; Borrowing Powers and Levying of Rates and Assessments in districts annexed and in the Extended Burgh; Alteration and Variation of Rates and Assessments; Provision with respect to the indebtedness of the Districts annexed; Provision as to the Districts annexed being within the Registration District of the Burgh for the purposes of the Births, Deaths and Marriages Acts; Provisions with respect to Water, Gas, and Electricity Supply and to include the Districts proposed to be annexed within the Compulsory Water Supply Limits of the Burgh, and for Drainage and Water and Sewer Rates, including Guarantee Rates for Gas, Pier and Harbour purposes; Provisions as to the Redemption of Casualties and Recording of Writs and Deeds applicable to Lands within the Area of the Royalty of the Burgh of Dumbarton; Costs of Order; Incorporation and Amendment or Repeal of Acts, Bye-laws, and other purposes.)

OTICE is hereby given that application is intended to be made to the Secretary for Scotland on or before the 17th December, 1905, by Petition under the provisions of the Private Legislation Procedure (Scotland) Act, 1899, for a Provisional Order (hereinafter called "the Order") promoted by the Provost, Magistrates and Councillors of the Burgh of Dumbarton—and who are hereinafter called "the Town Council"—for the following or some of the following objects, powers and purposes, that is to say:—

To authorise the Town Council to construct, make, execute, maintain and use the Water Works hereinafter described, or some of them, or some part or parts thereof, with all proper conveniences, roads, and approaches connected therewith, and to take, appropriate, acquire and use the lands and streams shown on the deposited plans, and described in the Book of Reference, to be deposited as after-mentioned, applicable thereto for the purpose thereof or so far as may be necessary for the purpose of said Works. The said Water Works are the following:—

1. A Reservoir (Work No. 1) wholly situate in the Parish of Arrochar and County of Dumbarton, embracing the natural Loch known as Loch Sloy, commencing at a point in the line of the stream known as Inveruglas Water, where it flows into said Loch, 650 yards or thereby measured in south-easterly direction from the south-west corner of the dwelling house known as Loch

Sloy, and terminating by an embankment to be formed across the outlet from Loch Sloy at a point 2250 yards or thereby measured in a southeasterly direction from the point of commencement, and which embankment will commence at a point 50 yards or thereby in a south-westerly direction, and will terminate at a point 90 yards or thereby in a north-easterly direction, both measured from the centre line of the said Inveruglas Water at a point where it issues from Loch Slov.

2. A Road of Access (Work No. 2) to the said Reservoir, wholly situate in the Parish of Arrochar and County of Dumbarton, commencing at a point 75 yards or thereby east of the point of commencement of the embankment of the intended Reservoir (Work No. 1) and terminating by a junction with the highway leading from Ardlui to Dumbarton at a point 180 yards or thereby northward from the point where said highway is crossed by the centre line of Inver-

uglas Water.

3. A conduit or line of pipes (Work No. 3) conmencing in the Parish of Arrochar and County of Dumbarton in the intended Reservoir (Work No. 1) at a point 55 yards or thereby measured in a north-north-easterly direction from the point of commencement of the embankment of the said intended Reservoir (Work No. 1) and terminating at Garshake in the Parish of Dumbarton and County of Dumbarton, at a point 50 yards or thereby north of the north-east corner of the ground presently occupied by the Filters and Clear Water Tanks belonging to the Town Council, which conduit or line of pipes will be situate in, and will pass from, in, through or into the Parishes of Arrochar, Luss, Bonhill, Dumbarton and Burgh of Dumbarton, all in the County of Dumbarton.

4. A Filter or Filters (Work No. 4) wholly situate in the Parish of Dumbarton and County of Dumbarton in the fields or enclosures numbered 183 and 228 on the Ordnance Survey Map marked "Second Edition, 1898."

5. A Clear Water Tank or Tanks (Work No. 5) wholly situate in the Parish of Dumbarton and County of Dumbarton in the fields or enclosures numbered 189 and 191 on the Ordanace Survey

Map marked "Second Edition, 1898."

Together with all proper embankments, bridges, roads, approaches, ways, wells, tanks. basins, gauges, filter-beds, stand-pipes, dams, sluices, waste weirs, outlets, outfalls, discharge pipes, adits, shafts, tunnels, aqueducts, culverts, cuts, channels, conduits, drains, mains, pipes, junctions, valves, engines, apparatus, and conveniences connected with the said works, or any of them, or necessary for conducting, inspecting, maintaining, repairing, cleansing, managing, and using the same.

All which intended works and the lands, houses, waters, streams, springs, and other property which will or may be taken for the purposes thereof and of the Order, will be situate in or will pass from, in, through or into the Parishes of Arrochar, Luss, Bonhill and Dumbarton and the Burgh of Dumbarton, all in the

County of Dumbarton.

To authorise the Town Council by means of the intended works and of their existing Water Works to abstract, divert, take, appropriate, impound, collect, store, distribute, supply and use for the purposes of the Order, and for the compensation water (if any) hereinafter mentioned, the waters

of Loch Sloy and all such streams, springs and waters as flow into or as can be collected by the said works or any of them, or as may be found within the limits of deviation marked on the plans after-mentioned, which waters now flow down the stream known as Inveruglas Water into Loch Lomond, thence into the River Leven, the River and Firth of Clyde and the sea.

To authorise the Town Council to deviate laterally in the construction of the said several Works from the lines, situations, and levels thereof, within the limits respectively shown upon the Plans hereinafter mentioned, or to such extent as shall be prescribed in the Order, and to deviate vertically from the lines, situations, and levels of those Works, as shown on the Sections thereof to be deposited as hereinafter mentioned, or to such extent as shall be prescribed in the Order.

To authorise the Town Council to enter upon appropriate, take, use, and acquire compulsoril or by agreement, all lands, houses, water, streams, springs, and other property necessary for the execution, maintenance, and use of the Works, or any of them, to be authorised by the Order, and to hold the same for the purposes of their Water undertaking and of the Order, or to lease, feu, or otherwise acquire. lands, houses, or other property in all or some of the several parishes and places aforesaid, and also rights of easement or servitude, permanent or temporary, in and over lands, and also to vary or extinguish all existing rights and privileges connected with such lands, houses, water, streams, springs, and other property which may in any way interfere with the purposes of the Order, or with the existing works and property of the Town Council; and also to confer further or other powers, rights, and privileges, and to empower the Town Council to purchase so much only of the lands or property as they may require for the purposes of the Order, without being subject to the liability imposed by Section 90 of "The Lands Clauses Consolidation (Scotland) Act,

To construct, make, lay down, erect and maintain such embankments, weirs, channels, sluices, catchwater drains, culverts, cuts, aqueducts, tunnels, bridges, roads, tramways, railways, gauges, filters, filtering apparatus, tanks, main and distributing pipes, meters. houses, buildings, and all other works and conveniences as may be necessary or convenient for diverting, taking, collecting, storing, regulating, and distributing the water hereinafter mentioned, and for conducting, inspecting, maintaining, repairing, cleansing, and managing, or using the same, and for the other objects and purposes of the Order, and of the existing and authorised water supply of the Town Council.
