The Civil Service Commissioners hereby give notice that an Open Competitive Examination of Candidates for registration as Temporary Boy Clerks will be held in London, Edinburgh, Dublin, Bedford, Bristol, Liverpool, Southampton, Aberdeen, Glasgow, Belfast, and Cork, on the 6th February 1906, under the Regulations dated the 24th March 1905.
