Commission should forthwith issue to inquire nto the origin, nature, amount, and application of the temporalities, endowments, and other

properties of the Church of England in Wales and Monmouthshire; and into the provision made, and the work done, by the Churches of all Denominations in Wales and Monmouthshire for the spiritual welfare of the people, and the extent to which the people avail themselves of such provision; and to report thereon:

Now know ye, that We, reposing great trust and confidence in your knowledge and ability, have authorised and appointed, and do by these Presents authorise and appoint you, the said Sir Roland Lomax Bowdler Vaughan-Williams, (Chairman); Hugh Richard Heathcote Cecil; Sir John Williams; Frank Edwards; Owen Evans; Samuel Thomas Evans; Andrew Martin Fairbairn; John Ernest Greaves; and Henry Jones, to be Our Commissioners for the purposes of the said inquiry :

And for the better effecting the purposes of this Our Commission, We do by these Presents give and grant unto you, or any three or more of you, full power to call before you such persons as you shall judge likely to afford you any information upon the subject of this Our Commission; and also to call for, have access to, and examine all such books, documents, registers, and records as may afford you the fullest information on the subject, and to inquire of and concerning the premises by all other lawful waysand means whatsoever:

And We do further by these Presents authorise and empower you, or any three or more of you, to visit and personally inspect such places as you may deem it expedient so to inspect for the more

effectual carrying out of the purposes aforesaid : And We do by these Presents will and ordain, that this Our Commission shall continue

in full force and virtue, and that you Our said Commissioners, or any three or more of you, may from time to time proceed in the execution thereof, and of every matter and thing therein contained, although the same be not

continued from time to time by adjournment. And We do further ordain that you, or any three or more of you, have liberty to report your proceedings under this Our Commission from time to time if you shall judge it expedient so to do.

And Our further will and pleasure is that you do, with as little delay as possible, report to Us, under your hands and seals, or under the hands and seals of any three or more of you, your opinion upon the matters herein submitted for your consideratiou.

### ORDER OF THE BOARD OF AGRICULTURE AND FISHERIES. (DATED 21st JUNE 1906.)

The Board of Agriculture and Fisheries, by virtue and in exercise of the powers vested in them under the Diseases of Animals Acts, 1894 to 1903, and of every other power enabling the in this behalf, do order, and it is hereby ordered, as follows :-

1. Notwithstanding the provisions of the Swime Fever (Regulation of Movement) Order of 1984, or of any Order by which such provisions at applied to any scheduled area, swine may be moved to the exhibition mentioned in the Schedul hereto, and from such exhibition to any plas of destination in Great Britain situate in any schedulad area, if accompanied by a Licent authorising such movement.

2. In the case of movement to the said entitie tion the Licence shall be one granted by some person authorised in that behalf by the Peeblas shire Gounty Council, and in the case of movement from the said exhibition the Licence shall be one granted by an Inspector of the Local Authority of the District in which the place of destination is situate.

3. The swine shall be moved by the nearest available route and without unnecessary delay to the exhibition or place of destination specified in the Licence and not elsewhere, and while being so moved shall not be subject to Regulations made by a Local Authority under any Order of the Board relating to Swine-Fever.
