FACTORY AND WORKSHOP ACT, 1901.

THE Secretary of State for the Home Department hereby gives notice, pursuant to section 80 of the Factory and Workshop Act, 1901, that he has certified the manufacture of paints and colours, in which dry carbonate of lead or red lead is used, to be dangerous, and that he proposes to make Regulations to apply to factories and workshops in which such manufacture is carried on.

Copies of the Regulations proposed to be made made be obtained on application to the Chief Inspector of Factories, Home Office, London.

Objections to the draft Regulations by or on behalf of any persons affected by the Regulations must be sent to the Secretary of State within forty days from the date of this notice.

Due notice will be given, by future advertise-ment in the London Gazette, of the date proposed for the commencement of distribution, and, at the same time, the amount of an Individual's share in the respective Classes will be announced.

CIVIL SERVICE COMMISSION, July 6, 1906.

The Civil Service Commissioners hereby give notice that an Open Competitive Examination of Candidates for registration as Temporary Boy Clerks will be held in London, Edinburgh, Dublin, Bedford, Bristol, Liverpool, Southampton, Aberdeen, Glasgow, Belfast, and Cork, on the 25th September 1906, under the Regulations dated the 6th March 1906.

The number to be registered will depend partly on the requirements of the service, and partly on the number of Candidates who may show sufficient proficiency; but it is not likely to be less than 250, if so many shall be found competent;

is to say, 230 for service in London, Edinburgh, and provincial towns in England, Scotland, and Wales, and 20 for service in Dublin and provincial towns of Ireland exclusively.

No Candidate will be admitted to the Examina-tion from whom the Secretary, Civil Service Commission, has not received, on or before the 30th August, an application, on a prescribed form, which may obtained from the Secretary at once.
