*Section 8 of the Corn Returns Act, 1882, provides that where returns of purchases of British Corn are made to the Local Inspector of Corn Returns in any other measure than the imperial bushel or by weight or by a weighed measure, that Officer shall convert such returns into the imperial bushlel and in the case of weight or weighed measure the conversion is to be made at the rate of sixty imperial pounds for every bushlel of wheat, fifty imperial pounds for every bushlel of barley, and thirty-nine imperial pounds for every bushlel of oats.

KILMARNOCK CORPORATION WATER.

(Construction of Additional Water-Works; Compulsory Acquisition of Lands, Springs, Streams, Waters, Easements, and Servitudes; Power to take parts only of Properties, and for Disposal of Properties not Required; Diversion, Appropriation, and Distribution of Waters; Discharge of Waters into Streams and Watercourses; Acquisition of Mines or Minerals; Agreements with Companies, Local Authorities, etc.; Pressure of Water; Rates, Assessments, Rents, and Charges; Application of Moneys and Additional Borrowing Powers; Provisions for securing Purity and Preventing Pollution of Water Supply, and for recovery of Penalties; Incorporation, Application, Amendment, or Repeal of Acts and Order; Costs of Order; Other Purposes.)

OTICE is hereby given that Application is intended to be made by Petition to the

of the Private Legislation Procedure (Scotland) Act, 1899, in December next, by the Provost, Magistrates, and Councillors of the Burgh of Kilmarnock (hereinafter called "the Corporation") for a Provisional Order (hereinafter called "the Order") for the following or some of the following amongst other purposes (that is to sav) :-

1. To authorise the Corporation to make, construct, lay down, erect, maintain, and use the works hereinafter described, or some of them, or some part or parts thereof, viz. :

(1) A Reservoir (Work No. 1) on the Burn known as the Loch Burn and on lands adjacent thereto, situate partly in the Parish of Fenwick, and County of Ayr, and partly in the Parish of Eaglesham, and County of Renfrew, commencing in the Parish of Eaglesham and County of Renfrew, in the Loch Burn, at a point 873 yards or thereby, measured in a south-south-easterly direction from the south-east corner of the dwelling-house of Blackwoodhill, and terminating in the Parish of Eaglesham and County of Renfrew at an embankment to be formed across the said Loch Burn at a point 760 yards or thereby measured in a northeast by easterly direction from the northeast corner of the dwelling-house of Lochgoin Farm. The said embankment will commence in the Parish of Fenwick and County of Ayr at a point 607 yards or thereby measured in a north-easterly direction from the north-east corner of the dwelling-house of Lochgoin Farm, and will terminate in the Parish of Eaglesham and County of Renfrew at a point 977 yards or thereby measured in an east-north-easterly direction from the said north-east corner of the said lastmentioned dwelling-house.

(2) A Road of Access (Work No. 2) wholly situate in the Parish of Fenwick and County of Ayr, commencing in the road leading to Lochgoin Farm Steading at a point 180 yards or thereby measured in a north-westerly direction from the north-east corner of the dwelling-house of Lochgoin Farm and terminating at the point of commencement of the embankment of the intended Reservoir (Work No. 1).

(3) A Conduit or line of pipes (Work No. 3) commencing in the Parish of Eaglesham and County of Renfrew in the intended Reservoir (Work No. 1) at a point 760 yards or thereby measured in a northeast by easterly direction from the northeast corner of the dwelling-house of Lochgoin Farm, and terminating in the Parish of Fenwick and County of Ayr at a point 5 yards or thereby measured in a west by southerly direction from the east or upper end of the existing conduit from the Loch Burn to Dunton Reservoir, which Conduit or line of pipes will be situate in and will pass from in through or into the Parish of Fenwick in the County of Ayr and the Parish of Eagles-

ham in the County of Renfrew. Together with all necessary and proper embankments, dams, weirs, channels, sluices, out-Seceretary for Scotland under and in pursuance lets, outfalls, catchwater drains, cuts, culverts, aqueducts, tunnels, bridges, roads, approaches, ways, tramways, railways, wells, tanks, basins, gauges, filters, filtering apparatus, stand pipes, main and distributing pipes, junctions, valves, meters, pumps, pumping stations, engine-houses, buildings, works, apparatus, and conveniences in connection with the said Works hereinbefore described, or any of them or necessary or convenient for diverting, taking, collecting, storing, conducting, distributing, and regulating the waters hereinafter mentioned, and for diverting any sewerage or drains which might pollute or otherwise injuriously affect the same, and for conducting, inspecting, maintaining, repairing, cleansing, managing, or using the said several Works, and for the other objects and purposes of the Order.

2. To authorise the Corporation to deviate laterally and vertically in the construction of the said several Works from the lines, situations, and levels thereof, as shown on the Plans and Sections hereinafter mentioned to the extent delineated thereon respectively, or to such extent as may be prescribed in the Order, and also from time to time to extend, alter, and enlarge or to replace the intended works, mains, and pipes, and to increase the number, size, and capacity thereof for the purpose of collecting, storing, conducting, or distributing the waters hereinafter mentioned.

3. To authorise the Corporation to carry the Works hereinbefore described, or any of them through, over, under, along, across, or into, and for that purpose to open, break up, cross, stop up, submerge, appropriate, alter, divert and use temporarily or permanently, and either compulsorily, or by agreement, or to acquire easements, servitudes, or rights of way or other rights over, in, under, or along lands, highways, roads, streets, lanes, paths, passages, bridges, rivers, streams, railways, tramways, culverts, sewers, drains, water courses, and gas, water, telegraphic, electric, telephonic, or other mains and pipes, and to carry conduits, pipes and other works through, over, under, across, along, upon, or into the same so far as may be necessary or expedient for the purpose of making, maintaining, and using the said several works before mentioned, and to exercise all usual and neces-

sary powers.
4. To authorise the Corporation to purchase, acquire, enter upon, appropriate, take, and use temporarily or permanently, and either compulsorily or by agreement, and to hold for the purposes of the Order, and of their Water undertaking, all such lands, houses, springs, streams, waters, and other property in the Parishes hereinbefore mentioned as may be necessary or convenient for the purposes of the intended Works hereinbefore mentioned and described, or some of them, or some part or parts thereof, and for the other purposes of the Order or rights of user thereof, and easements, servitudes, privileges, and powers through, over, in, or under the same, and notwithstanding Section 90 of the Lands Clauses Consolidation (Scotland) Act, 1845, to purchase and take by compulsion a part or parts of any lands, house, building, or manufactory without being required or compelled to purchase the whole thereof, and also to sell feu lease, and dispose of any lands, houses, or other property which they may acquire under the powers of the Order, and which may not be required for the purposes thereof, in such
