Whereas We have deemed it expedient that a Commission should forthwith issue to inquire into the operation of Shipping "Rings" or Conferences generally, and more especially into the system of deferred rebates, and to report whether such operations have caused, or are likely to cause, injury to British or Colonial trade, and, if so, what remedial action, if any, should be taken by legislation or otherwise:

Now know ye that We, reposing great trust and confidence in your knowledge and ability, have authorised and appointed, and do by these Presents authorise and appoint you the said Arthur Cohen (Chairman); Victor Albert George, Earl of Jersey; James Cleland, Baron Inverclyde; Charles Napier Lawrence; Sir Hugh Bell; Sir William Thomas Lewis; Sir Francis John Stephens Hopwood; Sir David Miller Barbour; Sir Alfred Edmund Bateman; Sir John Macdonell; Robert Henry Muirhead Collins; Henry Birchenough; William Pember Reeves; John Barry; Edward Carter Kersey Gonner; Fred Maddison; Willirm Henry Mitchell; Owen Cosby Philipps; Oswald Sanderson; Austin Taylor; and John Torrance to be Our Commissioners for the purposes of the said inquiry.

And for the better effecting the purposes of this Our Commission, We do by these Presents give and grant unto you, or any five or more of you, full power to call before you such persons as you shall judge likely to afford you any information upon the subject of this Our Commission; and also to call for, have access to, and examine all such books, documents, registers, and records as may afford you the fullest information on the subject, and to inquire of and concerning the premises by all other lawful ways and means whatsoever.

And We do by these Presents authorise and empower you, or any five or more of you, to visit and personally inspect such places as you may deem it expedient so to inspect for the more effectual carrying out of the purposes aforesaid.

And We do by these Presents will and ordain that this Our Commission shall continue in full force and virtue, and that you, Our said Commissioners, or any five or more of you, may from time to time proceed in the execution thereof, and of every matter and thing therein contained, although the same be not continued from time to time by adjournment.

And We do further ordain that you, or any five or more of you, have liberty to report your proceedings under this Our Commission from time to time, if you shall judge it expedient so to do.

And Our further will and pleasure is that you do, with as little delay as possible, report to Us, under your hands and seals, or under the hands and seals of any five or more of you, your opinion upon the matters herein submitted for your consideration. And for the purpose of aiding you in your inquiries We hereby appoint Our trusty and well-beloved James Alexander Webster, Esquire, of the Board of Trade, to be Secretary to this Our Commission.

Given at Our Court at Sandringham, the twenty-ninth day of November one thousand nine hundred and six, in the sixth year of Our Reign.

\* Section 8 of the Corn Returns Act, 1882, provides that where returns of purchases of British Corn are made to the Local Inspector of Corn Returns in any other measure than the imperial bushel or by weight or by a weighed measure, that Officer shall convert such returns into the imperial bushlel and in the case of weight or weighed measure the conversion is to be made at the rate of sixty imperial pounds for every bushel of wheat, fifty imperial pounds for every bushel of barley, and thirty-nine imperial pounds for every bushel of oats.
