" The powers of the Commission shall be in force until the first day of March nineteen hundred and six, but His Majesty may, by Order in Council, continue their powers for such further period as His Majesty thinks fit":

And whereas the said Commission was duly established by the appointment of five Commissioners in pursuance of a Warrant under His-Majesty's Royal Sign Manual, bearing date the eleventh day of August nineteen hundred and five :

And whereas His Majesty, by Orders in Council dated respectively the sixteenth day of February nineteen hundred and six, and the twenty-eighth day of July nineteen hundred and six, continued the powers of the said Commission until the first day of January nineteen hundred and seven.

And whereas it is expedient that the powers of the said Commission should be continued for a further period:

Now, therefore, His Majesty, by and with the advice of His Privy Council, is pleased to order, and it is hereby ordered, that the powers of the Commission established under the Act aforesaid shall be in force until the first day of July nineteen hundred and seven.

COAL MINES REGULATION ACT, 1896.

The Secretary of State for the Home Department hereby gives notice that on the 17th December 1906 he made an Order under section 6 of the Coal Mines Regulation Act, 1896, entitled "The Explosives in Coal Mines Order of the 17th December 1906," the effect of which is to amend the conditions under which explosives may be used, and to alter the list of Permitted Explosives by the addition of four explosives, viz., "Cliffite," "Oaklite No. 1," and "Tutol," and by the omission of four explosives, viz., "Colliery Cheddite," "Nobel Ammonia Powder No. 1," "Nobel Ammonia Powder No. 2," and "Nobel Ardeer Powder." The Order which revokes and consolidates all previous Orders comes into force on the 1st March 1907; but the changes in the Permitted List will take effect at once.

NOTICE OF ACCIDENTS ACT, 1906.

The Secretary of State for the Home Department hereby gives notice that, in pursuance of section 7 of the Notice of Accidents Act, 1906, he has appointed the 1st January 1908 as the date on which section 1 of the said Act (relating to the Annual Return of accidents to be made by owners of mines and quarries) shall come into operation.

He also gives notice that, in pursuance of section 5 of the suid Act, he has made Orders dated the 22nd December 1906 extending the provisions of the Act requiring notice of accidents to be given to an Inspector, to the following classes of occurrences, whether personal injury or disablement is caused or not:—

(a) In Mines and Quarries-

- All cases of ignition of gas or dust below ground, other than ignitions of gas in a safety lamp; of fire below ground; of breakage of ropes, chains, or other gear by which men are lowered or raised; of overwinding cages while men are being lowered or raised; of inrush of water from old workings.
- (b) In Factories, Workshops, &c.--
- All cases of bursting of a revolving vessel wheel, emery wheel, or grindstone moved by mechanical power; of breaking of a rope, chain, or other appliance used in raising or lowering persons or goods by aid of mechanical power; of fire affecting any room in which persons are employed and causing complete suspension of ordinary work therein for not less than twenty-four hours.
