ABERDEEN HARBOUR.

(Power to Aberdeen Harbour Commissioners to borrow additional moneys for the purposes of the Enlargement, Alteration, Improvement and Maintenance of Aberdeen Harbour; Application of Aberdeen Harbour Act 1895 to such additional borrowing; Incorporation and amendment of Acts; and other purposes.)

NOTICE is hereby given that application is intended to be made to the Secretary for Scotland on or before the 17th day of April next by Petition under the provisions of the Private Legislation Procedure (Scotland) Act 1899 by the Aberdeen Harbour Commissioners

(hereinafter called "the Commissioners") for a Provisional Order (in this Notice called "the Order") to effect all or some of the following purposes:—

1. To enable the Commissioners to borrow additional sums of money for the purposes of enlarging, altering, improving and maintaining the Harbour of Aberdeen and the Works thereof, and in security for the moneys so borrowed to assign the rates leviable under the authority of the Aberdeen Harbour Act 1895 (in this Notice called "the Act of 1895") and the other revenues of the Harbour.

2. To apply to the moneys to be borrowed under the Order all or some of the provisions of the Act of 1895 relating to borrowing powers, debenture stock, and Sinking Fund and such other provisions as the Order may prescribe.

3. To alter, amend, extend and enlarge, and, if need be, to repeal the powers and provisions of the Aberdeen Harbour Acts 1895 and 1899 and any other Acts relating to or affecting the Harbour or the Commissioners, and to vary or extinguish all rights and privileges which would interfere with the objects of the Order, and to confer other rights and privileges.

4. The Petition for the Order and printed copies thereof and of the draft of the Order will be deposited at the Office of the Secretary for Scotland on or before the 17th day of April next, and on or before the same day a printed copy of the draft of the Order will also be deposited in the Office of the Clerk of the Parliaments, House of Lords, and in the Private Bill Office of the House of Commons.

5. The subsequent procedure will be by way of Provisional Order unless it is otherwise decided in terms of the Private Legislation Procedure (Scotland) Act 1899, in which case the procedure may be by way of Private Bill, and this Notice will, subject to the Standing Orders of Parliament, apply to such Bill.

INVERNESS ROYAL ACADEMY AND
EDUCATIONAL ENDOWMENTS.

Alteration of Scheme or new Scheme. Change of Governing Body. Transfer of Academy and its Endowments to Inverness Burgh School Board. Power to School Board to Contribute to Maintenance of Academy. Bursaries and Free Scholarships. Mackintosh Farr Fund. Alteration of Provisions regarding Foundationers, Bursars, and Bursaries. Forbes Fund. Alteration of Scheme and Transfer of Administration to

Inverness Burgh School Board. Amendment of Acts and Orders and Schemes and other Purposes.

NOTICE is hereby given that application is intended to be made to the Secretary for Scotland on or before the 17th day of April 1907, by Petition for a Provisional Order, promoted by the Directors of the Royal Academy and Governors of the Inverness Educational Trust for the following or some of the following objects, powers, and purposes, that is to say :—

I.—To authorise the promoters to transfer the Inverness Royal Academy and the Endowments connected therewith and all Property and Estate and Effects at present administered by them in virtue of a Scheme Number 101 under the Educational Endowments (Scotland) Act, 1882, to the Inverness Burgh School Board, and to authorise the School Board to accept such transfer and all the obligations incident thereto, and to make contributions from time to time from the School Fund towards the maintenance of the Academy, and to authorise the whole business of, and connected with, the said Endowments and the administration thereof to be transacted by the said School Board; to make the alterations upon the said Scheme rendered necessary by the said transfer, including authority to the said School Board to transact the business connected with the said Royal Academy as part of its ordinary business. To dissolve the said Educational Trust, and to release and discharge the Directors of the said Academy of and from all obligations against the same.

To alter the Provisions of the said Scheme with regard to the Subjects to be taught in the said School, and to amend the said Scheme and any other Scheme in such way as the Order may prescribe.

To make alterations on the Bursary Provisions of the said Scheme, and to make new Provisions for Bursaries including provisions conserving the interests of the County of Inverness in the Endowments.

To make provision for the admission of Girls to the benefit of the Mackintosh Farr Fund, to make alterations as to the terms of admission of Foundationers on the said Fund, and to make additional provision as to Bursaries.

II.—To authorise the said Directors of the Royal Academy and Governors of the Inverness Educational Trust to transfer to the School Board of the Burgh of Inverness the administration of the Endowment known as the Forbes Fund, now held and administered by the said Directors and Governors under the Scheme No. 377, framed and promulgated by the Commissioners under the said Educational Endowments (Scotland) Act, and to authorise the School Board to accept such transfer, and to make alterations upon the terms of the said Scheme as to the manner of awarding the bursaries therein provided for.

To make agreements carrying out any of the said purposes and to confirm any agreements made or to be made.

To make provision for the application of Capital and Revenue as the Order may prescribe.

To confer power to feu and sell and to purchase and hold property.

To make bye-laws.

To empower the Court of Session to alter any Scheme, and to alter the provisions of the Order on the application of the School Board.

To authorise retiring allowances to be provided to any teachers or officials.

The Order will vary or extinguish all rights, restrictions, powers, authorities, jurisdictions, privileges and exemptions inconsistent with or which might or would in any way interfere with the objects or purposes of the Order, and will either vary or extinguish such rights, powers, authorities, jurisdictions, privileges, and exemptions.

III.—To alter, amend, extend and enlarge or repeal, so far as it should be necessary or desirable for the purpose of the Order the powers and provisions of the said Schemes Numbers 101 and 377, and the provisions of the said Educational Endowments (Scotland) Act 1882, and any Acts or Orders applicable to the said Academy or the School Board.

IV.—Printed copies of the Petition and Draft Order will be deposited at the Office of the Secretary for Scotland, Whitehall, London, on the 17th day of April 1907, and printed copies of the Draft Order will on or before the said date be deposited at the Scotch Education Department, London, and at the Parliament Office, House of Lords, and the Private Bill Office, House of Commons.
