ORDER OF THE BOARD-OF AGRICULTURE AND FISHERIES.

(DATED 21st MARCH 1907.)

ELGINSHIRE (CONTROL OF DOGS) ORDER OF 1907.

The Board of Agriculture and Fisheries, by virtue and in exercise of the powers vested in them under the Diseases of Animals Acts, 1894 to 1903, the Dogs Act, 1906, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:—

Power to make Regulations.

- 1.—(1.) The Local Authority of either of the Districts specified in the Schedule to this Order may, in accordance with the provisions of this Order, make Regulations, with a view to the prevention of worrying of cattle (including sheep), for requiring that dogs or any class of dogs shall, during all or any of the hours between sunset and sunrise, be kept by the owners thereof under control in manner prescribed by the Regulations.
- (2.) The Regulations may apply to the whole or any part of the District, and may exempt any class of dogs either generally or under prescribed conditions.

Confirmation of Regulations.

2.—(1.) Regulations made under this Order shall not take effect unless and until they have been submitted to and confirmed by the Board of Agriculture and Fisheries.

(2.) Unless the Board otherwise direct, the

following provisions shall apply-

(i.) Notice of intention to apply for confirmation of any Regulations shall be given in one or more of the local newspapers circulating within the District in two successive issues two weeks at least before the making of the application.

(ii.) For two weeks at least before an application, a copy of the Regulations proposed to be confirmed shall be kept at the office of the Local Authority of the District, and be open during office hours thereat to the inspection of ratepayers of the District without fee or reward.

(iii.) The Clerk of the Local Authority shall on the application of any such ratepayer furnish him with a copy of the proposed Regulations on payment of sixpence.

(3.) A copy of any Regulations made by a Local Authority under this Order, signed and certified by the Clerk of that Local Authority to

be a true copy and to have been duly confirmed, shall be evidence, until the contrary is proved, in all legal proceedings, of the due making, confirmation, and existence of the Regulations, without further or other proof.

Seizure of Dogs where Regulations are Contravened.

3. Any dog in respect of which an offence is being committed against a Regulation made under this Order may be seized and treated as a stray dog under the powers conferred by section three of the Dogs Act, 1906.

Extension of Definition in Diseases of Animals Act, 1894.

4. Dogs shall be animals for the purposes of the following sections of the Diseases of Animals Act, 1894 (namely):—

Section forty-three (powers of police); Section forty-four (powers of inspectors);

and also for the purposes of all other sections of the said Act containing provisions relative to or consequent on the provisions of those sections and this Order, including such sections as relate to offences and legal proceedings.

Local Authority to enforce Order.

5. The provisions of this Order shall be executed and enforced by the Local Authority.

Short Title.

6. This Order may be cited as the Elgin-Shire (Control of Dogs) Order of 1907.

EDINBURGH CORPORATION (TRAMWAYS, &c.)

(New Tramways; Motive Power; User of and Roads; Posts, Overhead Streets Wires; Lopping of Trees; Powers Lease; Widening and Improvement of Streets and Bridges; Advertising Vans and Structures; Advertisements; Contributions to Reformatories and Industrial Schools; Regulation of Houses Let in Lodgings and Farmed-Out Houses; Licensing and Regulation of Places of Public Entertainment and Amusement; Amendment of Edinburgh Municipal and Police Acts, 1879 to 1906; Rates, Charges and Assessments; Borrowing Powers; Agreements; Bye-laws; Application, Amendment, Repeal, and Incorporation of Acts, and other Purposes.)

OTICE is hereby given that application is intended to be made to the Secretary for Scotland, on or before 17th day of April next, by petition under the provisions of the above-mentioned Act, for a Provisional Order to be promoted by the Corporation of the City of Edinburgh (hereinafter called "the Corporation") for the following or some of the following objects, powers, and purposes, that is to say:—

To authorise the Corporation to construct, lay down, form, work, use, and maintain the tramways hereinafter described, or some of them, with all necessary and proper junctions, passing places, loops, cross-overs, rails, plates, sleepers, tubes, pulley pits, underground chambers, manholes, shafts, wires, cables, overhead wires, poles, posts, chains, engines, engine-houses, machinery, apparatus, and works and conveniences connected there-

with and necessary or convenient for working such tramways either by animal, mechanical, or electrical power, all in the lines, and according to the levels respectively shown on the deposited plans and sections applicable to the said tramways.

The said tramways are the following:-

(Where in the description of the proposed tramways any distance is given with reference to any street or road which intersects or joins the street or road in which the tramway is to be laid the distance is to be taken as measured from the point at which the lines drawn along the centres of the two streets or roads and produced would intersect each other, and a point described as being opposite a street or road is to be taken, unless otherwise stated, as opposite the centre of the street or road.)

Tramway No. 1 (Double Line)—3 furlongs 9.79 chains or thereabouts in length, wholly situate in the City Parish of Edinburgh, commencing by a junction at or near the termination of the existing tramway in Corstorphine Road at a point 70 yards or thereabouts measured in an easterly direction from the continuation of the eastern boundary of "Belmont" and passing thence in a westerly direction along Corstorphine Road and thence in a southerly direction through private property into and along the site of the unfinished new road or street, and its proposed continuation to its junction with Balgreen Road and terminating in Balgreen Road at a point in the line of the north side of the bridge carrying the Edinburgh and Glasgow main lines of the North British Railway Company over the said road.

Tramway No. 2 (Single and Double Lines)—3 furlongs, 0.75 chains or thereabouts in length, of which 2.30 chains are single line and 2 furlongs 8.45 chains are double line, wholly situate in the City Parish of Edinburgh, commencing by a junction with Tramway No. I at its termination in Balgreen Road and passing thence in a south-easterly direction along the said road and in continuation into and through private property along the site of the unfinished new road or street to be known as Saughton Avenue and terminating by a junction with the existing tramway in Gorgie Road at a point opposite the Gorgie Post Office.

Tramway No. 3 (Double Line)—6 furlongs 1.8 chains or thereabouts in length, wholly situate in the City Parish of Edinburgh, commencing by a junction at or near the termination of the existing tramway in Gorgie Road at a point 9 yards or thereabouts eastwards from the line of the eastern boundary of the cottage at the south-east corner of Balgreen Road, and passing thence in a westerly direction along Gorgie Road, thence in a south-easterly direction into and through the property of the Corporation along the site of the proposed road or street, being the access to the new Cattle Market and terminating near the north side of Slateford Road opposite a point in the said road 190 yards or thereabouts measured in a westerly direction along Slateford Road from the west side of Robb's Loan.

Tramway No. 4 (Double Line)—2 furlongs from stations or otherwise, or steam, pneu-9.85 chains or thereabouts in length, wholly matic, gas, oil, or other mechanical power,

situate in the Parish of Corstorphine, commencing by a junction with Tramway No. I in Corstorphine Road at a point in the municipal boundary 10 yards or thereabouts measured in a westerly direction from the continuation of the eastern boundary of "Belmont," and passing thence in a westerly and south-westerly direction along Corstorphine Road, and thence in a south-easterly direction along Balgreen Road, and terminating in that road at a point in the municipal boundary in line with the northern boundary of No. 20 Balgreen Road.

Tramway No. 5 (Double Line)—2 furlongs 9.55 chains or thereabouts in length, wholly situate in the City Parish of Edinburgh, commencing by a junction with Tramway No. 4 at its termination in Balgreen Road, and passing thence in a south-easterly direction along the said road, and terminating in Balgreen Road by a junction with Tramway No. 1, 42 yards or thereabouts measured in a north-westerly direction from the northern boundary of the North British Railway.

The said intended Tramways are and will be situate in the City Parish of Edinburgh, Parish of Corstorphine, and City and Royal Burgh of Edinburgh and County of the City of Edinburgh and County of Mid-Lothian.

At the places indicated in the plans by a thick dotted line it is proposed to lay the Tramways, so that for a distance of 30 feet or upwards a less space than 9 feet 6 inches will intervene between the outside of the footpath on either side of the road and the nearest rail of the Tramways.

The proposed Tramways will be constructed on a gauge of 4 feet 81 inches, and it is not intended to run carriages or trucks adapted to run on railways, and the motive power will be mechanical power.

To deviate laterally from the lines of the Tramways and Works to the extent shown on the plans to be deposited as hereinafter mentioned, and vertically from the levels as shown on the sections after-mentioned, and as may be provided by the Order.
