Copy of a Letter from Vice-Admiral Sir John Thomas Duckworth, K. B. Commander in Chief of his Ma-jefty's fhips and veffels at Jamaica, to William Marf-den, Efg. dated at Port Royal, 30th Sept. 1804.

SIR-I transmit you, for the information of the Lords Commissioners of the Admiralty, the copies of two letters from Captains Gordon, of the Racoon, and the Hon. John Murray, of the Franchife, relating the capture of L'Alliance and L'Uranie French privateers.

J. T. DUCKWORTH. I am, &c.

His Majefty's Brig Raccon, off Bird Key, Aug. 9. 1804.

SIR-I have the pleasure to inform you, that on the 1st instant. in lat. 20 deg. 52 min. N. long. 71 deg. 30. min. W. Sand Key, N. E. by N. distant seven or eight leagues, I had the good fortune to decoy within musket shot, a large French privateer, who struck after we had fired at him for three quarters of an hour; she proved to be L'Alliance, pierced for twelve guns, having only fix mounted, four fix-pounders and two nines, commanded by Jaques Dunoque, manned with fixty-eight men, out three days from Samaria, and had taken nothing; she is a fine vessel, but much cut in her fails and rigging, and had only one man slightly wounded. had only one man flightly wounded.
