**ROYAL BURGH OF FORRES.**

**A**PETITION has been presented in the Sheriff Court of Inverness, Elgin, and Nairn at Elgin, by the Provost, Magistrates, and Councillors of the Royal Burgh of Forres, praying the Court to revise and extend the Boundaries of the said Royal Burgh of Forres, and to define in a written Deliverance to be pronounced thereon the revised and extended Boundaries of the said Royal Burgh for the purposes of the Burgh Police (Scotland) Acts, 1892 to 1903, to be as follows, namely:—From Sweno's Stone on the north-east of
