PRESENT,

The KING's Most Excellent Majesty in Council.

WHEREAS by the "Burial Grounds (Scotland) Act, 1855," as amended by "The Secretary for Scotland Act, 1885," it was enacted that it should be lawful for His Majesty from time to time, by Order in Council, upon the Representation of the Secretary for Scotland that a copy of an Interlocutor of a Sheriff of a County of Scotland under certain provisions of the said first-named Act had been received, in pursuance thereof, to order that no new burial ground should be opened within certain limits specified in such Order, save with the previous approval of the Secretary for Scotland (or as the case might require) that after a time mentioned in such Order burials within certain limits, or in certain burial grounds or places of burial, should be discontinued wholly or subject to any exceptions or qualifications mentioned in such Order, and that such Order in Council should thereupon have like force and effect as if the same were embodied in the said Act: Provided always that notice of such Representation, and of the time it should please His Majesty to order the same to be taken into consideration by the Privy Council, should be transmitted to the Crown Agent in Edinburgh, and the Sheriff-Clerk of the County in which such burial ground is situated; and that the same should be by them respectively published in the Edinburgh Gazette, and fixed on the doors of the church of, or on some other conspicuous places within, the Parish affected by such Representation, one month before such Representation was so considered:

And whereas the Secretary for Scotland made a

Representation stating that he had received a copy of an Interlocutor by the Sheriff of the Lothians and Peebles at Linlithgow finding that the Burial Grounds on the north and south sides of Church Wynd, Bo'ness, and at Corbiehall, Bo'ness, all situated within the Burgh of Bo'ness, and Parish of Bo'ness and Carriden, are so situated and so crowded with bodies as to be offensive and injurious to health and contrary to decency:

And whereas in the said Representation it was recommended that the said Burial Grounds should be closed as hereinafter directed:

And whereas notice of the said Representation, and of the time when it pleased His Majesty to order the same to be taken into consideration by a Committee of the Lords of the Privy Council, has been duly published in the Edinburgh Gazette, and has been fixed as required by the said Act:

Now, therefore, His Majesty, by and with the advice of His Privy Council, is pleased to order, and it is hereby ordered, as follows, viz.:-

That the Burial Grounds on the north and south sides of Church Wynd, Bo'ness, and at Corbiehall, Bo'ness, all situated within the Burgh of Bo'ness, and Parish of Bo'ness and Carriden, shall be closed except for the burial of any person whose husband or wife has been buried in the said Burial Grounds, and for the burial of the unmarried children of parents buried therein, and subject to the further conditions as regards all interments in the said Burial Grounds after the date of this Order that the exercise of the right of burial shall not be injurious to the public health, and that no interment shall be made unless the coffin can be laid at a depth of four feet from the surface of the ground to the upper side of the coffin, and that without the exposure of another coffin.

Whereas by the Merchandise Marks Act, 1887 (50 and 51 Vict. c. 28) it is, amongst other things, provided that—

Section 8.—(1) Every person who after the date fixed by Order in Council sends or brings a watch case, whether imported or not, to any assay office in the United Kingdom for the purpose of being assayed, stamped, or marked, shall make a declaration declaring in what country or place the case was made. If it appears by such declaration that the watch case was made in some country or place out of the United Kingdom, the assay office shall place on the case such a mark (differing from the mark placed by the office on a watch case made in the United Kingdom), and in such a mode as may be from time to time directed by Order in Council :

(2) The declaration may be made before an officer of an assay office, appointed in that behalf by the office (which officer is hereby authorised to administer such a declaration), or before a justice of the peace, or a commissioner having power to administer oaths in a Supreme Court of Judicature in England or Ireland, or in the Court of Session in Scotland, and shall be in such form as may be from time to time directed by Order in Council.

(3) Every person who makes a false declaration for the purposes of this section shall be liable, on conviction on indictment, to the penalties of perjury, and on summary conviction to a fine not exceeding twenty pounds for each offence.

And whereas by Order in Council dated the 28th November 1887, Her late Majesty did order and declare the marks to be placed by the Authorities mentioned in such Order upon watch cases which had been made in some country or place out of the United Kingdom.

And whereas it appears expedient to alter the marks prescribed by the Order in Council dated the 28th November 1887 :

Now therefore, His Majesty, by and with the advice of His Privy Council, and in exercise of the powers vested in him by the above-recited provisions of the said Act, is pleased to order and declare and doth hereby order and declare that where it appears by the declaration required by the above-recited provisions that such watch cases have been made in some country or place out of the United Kingdom, then the following Authorities, that is to say :

The Wardens and Commonalty of the Mystery of Goldsmiths of the City of London,

The Guardians of the Standard of Wrought Plate, Birmingham,

The Company of Goldsmiths of the City of Chester,

The Guardians of the Standard of Wrought Plate, Sheffield,

The Incorporation of Goldsmiths of the City of Edinburgh,

The Goldsmiths Company of the City of Glasgow.

The Fraternity or Company of the City of Dublin,

shall respectively cause to be placed on such watch cases the marks more particularly described and delineated in Schedule II. hereunto annexed, and such marks shall be substituted for the marks prescribed by the said Order in Council of the 28th November 1887.

And it is hereby further ordered and declared that the declaration to be made shall be in the form set forth in Schedule I. hereto annexed.

And it is hereby further ordered and declared that as from the coming into operation of this Order the said Order in Council dated the 28th November 1887, shall be repealed.

This Order shall come into operation on the fourteenth day of May 1907.

The mark for the annual date letter is to be added by each Assay Authority after the mark for the particular Hall and the mark for standard.

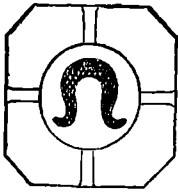

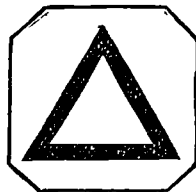

PARTICULAR MARK FOR EACH ASSAY AUTHORITY.

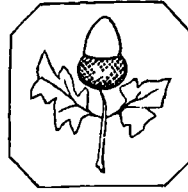

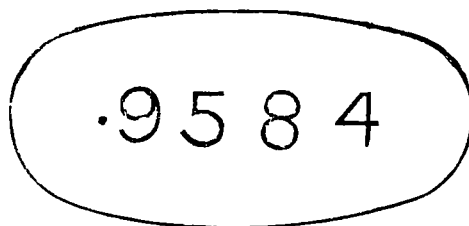
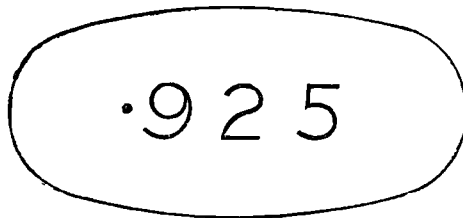
REPRESENTATION OF STANDARD MARKS.
