## FACTORY AND WORKSHOP ACT, 1901.

(2) Applying the provisions of section 110 (prohibition of home work in places where there is infectious disease) to the making, cleaning, washing, altering, ornamenting, finishing, and repairing of wearing apparel and any work incidental thereto (as in the said section specified); the making, ornamenting, mending, and finishing of lace and of lace curtains and nets; upholstery work; fur-pulling; the making or repairing of umbrellas, sunshades, parasols, or parts thereof; the making of artificial flowers; the making of nets other than wire nets; the

sacks; the covering of racquet or tennis balls; the making of paper bags; the making of boxes of other receptacles or parts thereof made wholly or partially of paper, cardboard, chip, or similar material; the making of brushes; pea-picking; feather sorting; the carding, boxing, or packeting of buttons, hooks and eyes, pins, and hair pins ; the making of stuffed toys; the making of baskets; and any processes incidental to the above.

## LOCAL GOVERNMENT (SCOTLAND) ACT, 1894.

SPECIAL DISTRICTS FOR LIGHTING, SCAVEN-GING AHD OTHER PURPOSES ; BORROWING POWERS OF COUNTY COUNCILS.

Whereas by section 44 of the Local Government (Scotland) Act, 1894, provision is made for the formation within a County of Special Districts for lighting, scavenging, and other purposes as therein mentioned, or any one or more of them, and for the adoption for such purpose or purposes of the provisions contained in certain specified sections of the Burgh Police (Scotland) Act, 1892:

And whereas by subsection (6) of the said section it is enacted that— "Any expenditure attending the formation

"of a Special District or the carrying out " within such Special District of the purposes "of this section, or of any of them, shall be "paid out of an assessment to be imposed "by the County Council within the Special "District, to be called the Special District "Rate, and levied along with and as an "addition to and in excess of the Public "Health Rate, and with the same remedies " and modes of recovery, provided that such "Special District Rate shall not exceed ninepence in the pound on the annual value " of the lands and heritages within the Special "District, and a County Council may borrow " for such of the said purposes as the Secre-"tary for Scotland may by Order prescribe, "on the security of such Special District " Rate."

Now therefore, I, the Right Honourable John Sinclair, His Majesty's Secretary for Scotland, do hereby make the following Order :-

1. A County Council may, in terms of the said subsection as read with the adopted provisions, borrow money for the following purposes or any one or more of them, namely :---

A.—Within Special Lighting Districts.

- (a) The purchase and laying of mains and pipes.
- The purchase and erection of lamps, (b)lamp-posts, pillars, and other appurtenances.
- (c) The provision of accommodation for the storage and housing of plant or the like purpose.

## B.—Within Special Scavenging Districts.

The construction of capital works in connection with the collection, removal, deposit and disposal of dust, ashes, and other refuse including, where necessary :-

- (a) The purchase of lands or premises.
- (b) The provision of a refuse destructor and relative plant.
- The provision of separator, branch (c) railway, engine, engine-house, and suitable plant.
- (d) The erection of stables and other offices for the housing of the horses and plant required for scavenging purposes. (e) The provision of public ashpits. (f) The erection of public water-closets,
- latrines, and urinals, including the provision of lavatory accommodation where considered expedient, but without prejudice to any power of the local authority under the Public Health (Scotland) Act, 1897.

2. Without prejudice to anything duly done thereunder, the County Council (Scotland) (Finance) Order, 1901, is hereby revoked.

3. This Order may be cited as the County Council (Scotland) (Finance) Order, 1907.

## CIVIL SERVICE COMMISSION, May 24, 1907.

The Civil Service Commissioners hereby give notice that the following Regulations have been approved by the Lords Commissioners of His Majesty's Treasury, viz. :--

**REGULATIONS** respecting Open Competitive

Examinations for Clerkships in the Second Division of the Civil Service.

## N.B.—These Regulations are liable to alteration for future Examinations.

1. Open Competitive Examinations of Candidates for Clerkships in the Second Division of the Civil Service will be held from time to time at such places as may be deemed expedient.

2. These Examinations are open, under such general restrictions as may be laid down, to all natural-born or naturalised British subjects being of the prescribed age and of good health and character. The under-mentioned special conditions are at present in force :---

- (i.) The following classes of persons are eligible under certain conditions only, that is to say :---
  - (a) Persons actually serving in the Army.(b) Persons actually serving in the Navy.
- No person actually serving in the Army will be eligible unless he produces to the Civil Service Commissioners, when called upon to do so, the permission of his Commanding Officer to attend the examination, dated before the commencement of the competition and given in accordance with such orders as may from time to time be issued by or under the authority of the Army Council.
- No person actually serving in the Navy will be eligible unless he produces to the Civil Service Commissioners, when called upon to do so, the permission of his Commanding Officer to attend the examination, dated before the commencement of the competition and given in accordance with such orders as may from time to time be issued by or under the authority of the Lords Commissioners of the Admiralty.
- (ii.) The following classes of persons will not be eligible, unless they obtain the permission of the authorities of their department, to attend the examination before the commencement of the competition, viz. :--(a) Persons holding situations in the Civil Service, (b) Probationary Engineer Cadets in the Navy, and Apprentices in His Majesty's Dockyards.
- (iii.) Persons who have been trained in Training Colleges at the public expense will not be qualified to receive appointments until the consent of the Board of Education in England, the Committee of Council on Education for Scotland, or the Commissioners of National Education, Ireland, as the case may be, given in conformity with rules sanctioned by the Lords of the Treasury, has been notified to the Civil Service Commissioners.

3. The limits of age are 17 and 20. If an examination begins in one of the first six months of any year, candidates must be of the prescribed age on the first day of March in that year. If an examination begins in one of the last six months of any year, candidates must be of the prescribed age on the first day of September in that year.

(iv.) In reckoning age for competition, the following allowances will be made, viz. :-(1) Persons who have served in the Army or Navy may deduct from their actual age

any time during which they have served; (2) Members of the Militia, the Imperial Yeomanry, the Honourable Artillery Company, or the Volunteers (whether commissioned or non-commissioned), may deduct from their actual age any time spent on actual military service, such time being reckoned by the number of days for which they received Army pay; (3) Persons who have served for two full consecutive years (a) in any Civil situation to which they were admitted with the Certificate of the Civil Service Commissioners, or (b) as Registered Boy Clerks or Registered Boy Copyists in connection with the Civil Service, may, if their service commenced before the 20th April 1900, deduct from their actual age any time not exceeding five years which they may have spent in such service; if their service did not commence before the 20th April 1900, they may deduct only two years.

4. The subjects of Examination will be as follows :---

- 1. Handwriting and Orthography, including Copying Manuscript.
- 2. Arithmetic.
- 3. English Composition.
- 4. Précis, including Indexing and Digest of Returns.
- 5. Bookkeeping and Shorthand Writing.
- 6. Geography and English History.
- 7. Latin (translation from the language, and composition). Only two of these languages may
- 8. French (Ditto). be taken up.
- 9. German (Ditto).
- 10. Elementary Mathématics.
- 11. Inorganic Chemistry, with Elements of Physics.

N.B.—Not more than four of the subjects numbered 4 to 11 may be offered.

5. Service marks for each full period of three calendar months of actual approved service, subject to a maximum of twelve of such periods, may be allowed to Candidates attending an Examination who are serving or have served as Registered Boy Clerks or Boy Copyists.

6. Application for permission to attend an Examination must be made at such time and in such manner as the Civil Service Commissioners may appoint.

7. A fee of  $\pounds 2$  will be required from every Candidate attending an Examination.

The Civil Service Commissioners further give notice that on the 30th September 1907, and following days, an Open Competative Examination will be held in London, Edinburgh, Dublin, Bedford, Birmingham, Bristol, Leeds, Liverpool, Manchester, Newcastle - on - Tyne, Plymouth, Southampton, Aberdeen, Glasgow, Belfast, and Cork, under the foregoing Regulations, at which Examination not fewer than 70 Candidates will be selected for Clerkships in the Second Division of the Civil Service, provided they satisfy the Civil Service Commissioners that they are duly qualified.

No person will be admitted to Examination from whom the Secretary, Civil Service Commission, has not received, on or before the 5th September, an application, in the handwriting of the Candidate, on a prescribed form, which may be obtained from the Secretary at once.
