

DUNDEE ELECTRIC LIGHTING.

HEREAS the City and Royal Burgh of Dundee as at present constituted is within the jurisdiction of The Lord Provost, Magistrates, and Councillors thereof, and is also within the jurisdiction or limits of the Dundee Gas Commissioners, and such jurisdiction or limits also include a part of the Burgh of Broughty

And whereas, conform to appointment published in the Edinburgh Gazette on the 23rd June 1891, the said Commissioners were duly appointed as the Local Authority of the said City and Royal Burgh of Dundee Authority of the said City and Royal Birgh of Dinder as then constituted for the purposes of the Electric Lighting Acts, 1882 and 1888, and any other Acts or parts of Acts incorporated therewith; and by the Dundee Electric Lighting Order, 1890, the said Commissioners were authorised to supply electrical energy within the meaning of "electricity" as defined in the Electric Lighting Act, 1882, within a portion of the said City and Royal Burgh as the same then existed; And whereas by the Dundee Extension and Improvement Act, 1892, the Municipal Boundaries and the Police Boundaries of the said City and Royal Burgh
