SCOTTISH OFFICE, WHITEHALL, February 24, 1908.

THE King has been pleased, by Warrant under His Majesty's Royal Sign Manual, bearing date the 21st instant, to direct Letters Patent to be passed under the Seal appointed by the Treaty of Union to be kept and made use of in place of the Great Seal of Scotland, nominating, constituting, and appointing the Right Honourable Lord Kinnaird to be His Majesty's High Commissioner to the next Meeting of the General Assembly of the Church of Scotland.

WHITEHALL, January 18, 1908.

The King has been pleased to allow Miss Margaret Jane Lamb, of Newcastle-upon-Tyne, to receive the Edward Medal of the First Class in recognition of the gallant action of her brother, the late George Huddleston Lamb, who lost his life in endeavouring to save the lives of five men at a fire at the Strathcona Company's Mine, at Strathcona, in the Province of Alberta, Canada, on the 8th June 1907.

There were two shafts in the mine, a hoisting shaft and an air shaft. The engineer of the mine woke Lamb at about 11.25 P.M., when the fire was discovered, and told him that there were five men in the mine. Lamb descended three times, once by the air shaft, and having found the men urged them to escape by the ladder, saying he would remain until they had ascended. One man made an attempt, but returned. Lamb himself then succeeded in reaching the surface, but his

clothes were in flames, and he died shortly afterwards from the effect of his injuries. The others seem to have endeavoured to follow him, but failed, either because they were overcome by the smoke or because the ladder was burned.

THE COMPANIES ACTS 1862-1907.

In regard to certified copies and certified translations of documents required by section 35 of the Companies Act, 1907, to be filed with the Registrar, the Board of Trade do hereby prescribe as in manner following, that is to

(I) A certified copy of the Charter, Statutes. or Memorandum and Articles of Association, or other Instrument constituting or defining the constitution of a Company in the case of a Company incorporated in a Foreign Country required to be filed with the Registrar under section 35 of the Companies Act, 1907, shall be deemed to be certified as a true copy if in such Foreign Country it is-

(a) duly certified as a true copy by an official of the Government to whose custody the original is committed, the signature or seal of such official being authenticated by any of the British Officials mentioned in section 6 of the Commissioners of Oaths Act, 1889, or

in any Act amending the same, or

(b) duly certified as a true copy by a Notary of such Foreign Country, the certificate of the Notary being authenticated by any of the British Officials mentioned in section 6 of the said Act or in any Act amending the

(c) duly certified as a true copy on oath by some officer of the Company before a person having authority to administer an oath as provided by section 3 of the said Act, the status of the person administering the oath being authenticated by any of the British Officials mentioned in section 6 of the said Act, or in any Act amending the same.

- (2) A certified copy of the Charter, Statutes, or Memorandum and Articles of Association, or other Instrument constituting or defining the constitution of a Company, in the case of a Company incorporated in the Channel Islands, Isle of Man, or in any Colony, Island, Plantation, or place under the Dominion of His Majesty in Foreign Parts, required to be filed with the Registrar under section 35 aforesaid, shall be deemed to be certified as a true copy if in the Channel Islands, Colony, Island, Plantation, or places under the Dominion of His Majesty, it is
 - (a) duly certified as a true copy by an official of the Government to whose custody the original is committed;
 - (b) duly certified as a true copy by a Notary Public of such Colonies, Islands, or places aforesaid;

- (c) duly certified as a true copy on oath by some Officer of the Company before some person having authority to administer an oath as provided by section 3 of the Commissioners of Oaths Act, 1889.
- (3) In the case of a company in which the Charter, Statutes, or Memorandum and Articles of Association, or other Instrument constituting or defining the constitution of the Company is not written in the English language a certified translation thereof required to be filed with the Registrar shall be deemed to be certified as a correct translation if certified to be a correct translation,

(a) when such translation is made out of the United Kingdom by

(1) an official having custody of the

original; or
(2) a Notary Public of the country or place where the Company is incorporated, the signature or seal of the person so certifying where the Company is incorporated in a Foreign Country being authenticated in either case by any of the British Officials mentioned in section 6 of the Commissioners of Oaths Act, 1889, or in any Act amending the same;

(b) where such translation is made within

the United Kingdom

(1) in the case of a translation made in regard to a Company whose place of business is established in England by

(1) a Notary Public in England, or (2) a Solicitor of the Supreme Court in

England.

- (2) In the case of a translation made in regard to a Company whose place of business is established in Ireland by
 - (1) a Notary Public in Ireland, or (2) a Solicitor of the Supreme Court in Ireland.
- (3) In the case of a translation made in regard to a Company whose place of business is established in Scotland by

1) a Notary Public in Scotland, (2) a Writer to the Signet or a Solicitor

of the Supreme Court in Scotland.

(4) The Board of Trade may in any particular case, if they think fit to do so and upon such conditions as they think fit, permit certified copies or translations though not certified in accordance with the above requirements to be filed with the Registrar.

ORDER OF THE BOARD OF AGRICULTURE AND FISHERIES.

(DATED 19TH FEBRUARY 1908.)

MIDLOTHIAN AND DISTRICT (FOOT-AND-MOUTH DISEASE) ORDER OF 1908 (No. 4).

The Board of Agriculture and Fisheries, by virtue and in exercise of the powers vested in them under the Diseases of Animals Acts, 1894 to 1903, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows;

Modification of former Orders.

1.-(1) The Midlothian and District (Footand-Mouth Disease) Order of 1908, as modified by the Midlothian and District (Foot-and-Mouth Disease) Order of 1908 (No. 3), is hereby further modified in manner hereinafter appearing.

(2) The Scheduled District for the purposes of this Order shall be the District prescribed in the First Schedule to the Midlothian and District (Foot-and-Mouth Disease) Order of 1908 (No. 3).

Movement to Licensed Markets, &c., and thence to Slaughter-house.

- 2.—(1) An animal may be moved from any place or premises within or outside the Scheduled District to any market, fairground, or saleyard in the Scheduled District which shall be licensed for this purpose by the Local Authority of the District under this Order, provided that the animal is accompanied by a Movement Licence authorising such movement granted by an Inspector of the Local Authority of the District in which the market, fairground, or saleyard is situate.
- (2) For the purposes of movement to a licensed market, fairground, or saleyard, animals may be moved by railway from outside the Scheduled District to a railway station in the Scheduled District without a Licence, but the subsequent movement must be authorised by a Licence under this Article.
- (3) An animal exposed at a licensed market, fairground, or saleyard may be moved therefrom only if accompanied by a Movement Licence authorising such movement, granted hy an Inspector of the Local Authority of the District in which the market, fairground, or saleyard is situate, and only to a slaughterhouse in the Scheduled District specified in the
- (4) A Movement Licence under this Article shall be in force for not more than four days inclusive of the day of issue.
- (5) A copy of a Licence authorising movement from a market, fairground, or saleyard shall be sent by the Inspector granting the same to the Local Authority of the District in which is situate the slaughter-house specified in the Licence.

Movement into Scheduled District for Slaughter.

- 3.—(1) For the purpose of movement to a slaughter-house an animal may be moved by railway from outside the Scheduled District to a railway station in the Scheduled District without a Licence, but an animal so moved shall only be moved from the railway station to a slaughterhouse in the Scheduled District, and only if accompanied by a Movement Licence authorising such movement granted by the Local Authority of the District in which the slaughter-house is situate.
- (2) An animal may also be moved by railway or otherwise from any place outside the Scheduled District to a slaughter-house in the Scheduled District, if accompanied by a Movement Licence authorising such movement granted by an Inspector of the Local Authority of the District in which the slaughter-house is situate, which Licence shall be obtained before movement into the Scheduled District.

Article 4 of the Midlothian and District (Footand-Mouth Disease) Order of 1908 (No. 3).

Movement of Milch Cows into Scheduled District by Licence.

4. Where the Local Authority consider it necessary or expedient that any milch cow should be permitted to be moved into their District from premises outside the Scheduled District, an Inspector of the Local Authority may authorise such movement by a Movement Licence.

Landing of Animals at Leith for Movement through Scheduled District.

5. Animals intended to be moved to a place of destination outside the Scheduled District may without a Movement Licence be la ided at Leith, and moved from the landing place forthwith by the most direct route to the nearest available cattle loading docks and thence forthwith by railway out of the Scheduled District.

Exception of Certain Animals from Provisions as to Movement.

- Nothing in this Order shall be construed as authorising-
 - (i.) movement of an animal which is affected with Foot-and-Mouth Disease, or which has during the preceding twenty-eight days been in any way exposed to the infection of such disease; or
 - (ii.) movement of an animal of the movement of which is prohibited by notice of an Inspector of the Local Authority or of the Board given under any Order of the Board; or

(iii.) movement out of a Foof-and-Mouth Disease Infected Place; or

(iv.) movement of an animal along, over, or across a highway or thoroughfare in the Area described in the Second Schedule to the Midlothian and District (Foot-and-Mouth Disease) Order of 1908 (No. 3), except that an animal may be moved from any place or premises in that Area to a slaughter-house in the city of Edinburgh, under and in accordance with the conditions of Article 5 of such Order.

Forms.

7. Movement Licences under this Order shall be in the form set forth in the Third Schedule to the Midlothian and District (Foot-and-Mouth Disease) Order of 1908 (No. 3), or to the like

Commencement.

8. This Order shall come into operation on the twenty-fourth day of February nineteen hundred and eight.

Short Title, &c.

9. This Order may be cited as the MIDLOTHIAN AND DISTRICT (FOOT-AND-MOUTH DISEASE) ORDER OF 1908 (No. 4), and shall be read with the Orders mentioned in Article 1 of this Order.

To determine and declare that the Councillors apportioned to the new or altered Wards shall retire in the order they would have fallen to retire respectively from their existing Wards as specified in said Petition. existing Wards as specified in said Petition.
