FACTORY AND WORKSHOP ACT, 1901.

The Secretary of State for the Home Department hereby give notice, pursuant to section 86 (1) of the Factory and Workshops Act, 1901, that on the 23rd December 1908 he made Regulations under section 79 of the said Act for the Generation, Transformation, Distribution and Use of Electrical Energy in any factory and workshop, or any place to which the provisions of section 79 are applied. These Regulations are to come into force on the 1st July 1909, except as regards such parts of electrical stations as were constructed before the 1st July 1908, in respect of
