#### KIRKCALDY PROVISIONAL ORDER.

(Extension of Burgh and matters relating thereto; Construction of Tramways, posts, brackets, wires; Tolls, rates, and charges; Bye-laws; Contracts as to construction and working; Confirmation of agreement with the Burgh of Dysart and power to Burgh of Dysart to contribute; Extension of the compulsory limits of water supply; Extension of area for supply of electricity; to confer further powers on the Corporation in relation to their electricity undertaking; Additional borrowing powers for Harbour undertaking; Purchase of lands and houses for gas works purposes compulsorily; Additional powers in regard to the gas undertaking; Purchase compulsorily and maintenance as open spaces of strand of seashore and waste ground adjoining; Incorporation and amendment of Acts, &c.)

NOTICE is hereby given, that application is intended to be made to the Secretary for Scotland in the month of December next by a petition for a Provisional Order, under the Private Legislation Procedure (Scotland) Act, 1899, by the Provost, Magistrates and Councillors of the Royal Burgh of Kirkcaldy hereinafter called "the Corporation" for all or some of the following purposes—that is to say:—

## EXTENSION OF BURGH.

To alter and extend the boundary of the Burgh so as to include within the Burgh the following area, namely,

The area within the lines now set forth, namely:—Commencing at a point on the present Burgh Boundary at the south side of the bridge near Datie Mill, carrying the road from Kirkcaldy to Auchtertool or Boglely Road over the stream flowing from Raith Lake into the West Mill Dam, crossing the said Boglely Road in a northerly direction and following the course of the said stream to the side of Raith Lake, then along the south margin of the lake in an easterly direction to a point 137 yards or thereby north-west from the gateway leading from Boglely Road into the artificial curling rink and 60 yards from the nearest point of the boundary wall on the north side of the said road, then following a course in an easterly and south-easterly direction parallel to and about 60 yards north from the north side of the said road, then in a north-easterly direction to a point on the present Burgh boundary on the Long Braes, 50 yards from the centre of Abbotshall Road, measuring in a north or north-westerly direction, thence along the existing burgh boundary to the first-mentioned point in this description, which area contains  $15\frac{1}{2}$  acres or thereby and lies within the Parish of Kirkcaldy and Dysart, and County of Fife; which area is in this notice called the "district proposed to be annexed."

To provide that the election of members of Parliament is not to be affected.

To provide that the district proposed to be annexed is to be disjoined from the County of Fife.

To provide that the district proposed to be annexed will form part of the First Ward of the Burgh.

To make such alterations on the existing wards of the Burgh as may be provided in the Order.

To make provision that all local, private and public and general Acts and Orders, and all bye-laws, rules, regulations, orders and determinations made under the same which apply to the existing Burgh shall, except so far as may be otherwise provided in the Order, extend and apply to the district proposed to be annexed.

To provide for the levying of assessments in the district proposed to be annexed.

To make such provisions as may be expedient in regard to the management of the Cemetery at present belonging to the Corporation, and in particular to provide for the same being managed for behoof of the existing First and Second Wards of the Burgh and of the district proposed to be annexed.

## TRAMWAYS.

To authorise the Corporation to construct, lay down, form, work, use and maintain the several new Tramways hereinafter described, with all necessary and proper junctions, rails, plates, sleepers, tubes, pulley pits, underground chambers, manholes, shafts, wires, cables, chains, engines, engine-houses, machinery, apparatus, works and conveniences connected therewith. The Tramways proposed to be authorised by the Order are situated in the Parish of Kirkcaldy and Dysart, in the County of Fife. Tramway

No. 1 is wholly situated within the Burgh of Kirkcaldy. Tramway No. 2 is situated partly in the Burgh of Kirkcaldy and partly in the Burgh of Dysart. The new tramways are as follows:—

Tramway No. 1 (1.2 chains in length single line), situate wholly in the Parish of Kirkcaldy and Dysart and Burgh of Kirkcaldy, commencing in Saint Clair Street by a junction with an existing tramway belonging to the Corporation, passing in a south-easterly direction along Saint Clair Street, thence into and along Dysart Road to, and terminating by, a junction with Tramway No. 2.

Tramway No. 2 (one mile one furlong 3.5 chains in length, whereof 1 mile 0 furlongs 3.5 chains will be single and 1 furlong will be double lines), situate wholly in the Parish of Kirkcaldy and Dysart, commencing in the Burgh of Kirkcaldy by a junction with an existing tramway in Dysart Road belonging to the Corporation, passing thence in an easterly direction along Dysart Road, and thence into and along the road or street known as the Townhead and thence into and along Normand Road, and terminating therein in the Burgh of Dysart at a point 0.8 chain measured in a southerly direction from the centre of the mineral railway crossing Normand Road.

Between the following points it is proposed to lay the said Tramways so that for a space of 30 feet or upwards a less space than 9 feet 6 inches will intervene between the outside of the footpath on the side or sides of the streets or roads and the nearest rail of the tramway in the places hereinafter mentioned. That is to say:—

## TRAMWAY NO. 1.

In the whole of the Tramway on the east side.

## TRAMWAY NO. 2.

In the whole of the Tramway on the north-west side with the exception of the part situate between the junction of the Tramway with the existing Tramway in Dysart Road and the junction of Tramways Nos. 1 and 2.

In Dysart Road on the south-east side from a point 0.6 chain eastward from the junction of Dysart Road and St. Clair Street for a distance of 2 chains in an easterly direction.

In Dysart Road on the south-east side from a point 2 furlongs 7.4 chains from the junction of Dysart Road with St. Clair Street for a distance of 2 chains in a north-easterly direction.

In Dysart Road on the south-east side from a point 7.8 chains westward from the point of the junction of Dysart Road and the Road to Dysart House for a distance of 2 chains in a north-easterly direction.

In Townhead on the south-east side from the north-west corner of East Port for a distance of 2 chains in a south-westerly direction.

In Normand Road on the south-east side from a point 2.6 chains northward from the junction of Berwick Place and Normand Road for a distance of 2 chains in a north-easterly direction.

Where, in the description of any of the fore-said tramways and narrow places in streets hereinbefore set forth, any distance is given

with reference to any street or road which intersects or joins the street or road in which the tramway is to be made, or in which such narrow place occurs, the distance is to be taken as measured from the point at which lines drawn along the centres of the two streets or roads and produced would intersect each other.

The proposed tramways will be constructed on a gauge of 3 feet 6 inches, and it is not intended to run thereon carriages or trucks adapted for use on railways.

To authorise the Corporation to lay down double lines in lieu of single lines or single lines in lieu of double lines or interlacing lines in lieu of double or single lines, on any of the tramways, and to abandon any portion of any tramway, whether constructed or authorised, which may be rendered unnecessary by the construction of any tramway to be authorised by the proposed Order.

To constitute the proposed tramways part of the tramway undertaking of the Corporation, and to make applicable thereto all or any of the provisions of the "Kirkcaldy Corporation and Tramway Act, 1899," and the "Kirkcaldy Corporation Order, 1904," subject to such amendments as may be contained in the Order.

To authorise the Corporation from time to time, and either temporarily or permanently, to make, maintain, alter, or remove such crossings, passing places, sidings, junctions, turnouts, and other works, in addition to those particularly specified in this notice, as may be necessary or convenient for the efficient working of the tramways, or any of them, and for facilitating the passage of traffic along streets or roads, or for providing access to any works, stables, buildings, carriage sheds, or lands of the Corporation.

To authorise the Corporation from time to time to enter upon, open, and break up the surface of, and to alter, raise, lower, cross, divert, widen, improve, enlarge, stop up, remove, and otherwise interfere with, either permanently or temporarily, streets, roads, lanes, footpaths, places, bridges, railways, tramways, streams, sewers, drains, pavements, gas mains or pipes, water mains or pipes, and electric, telegraphic, or telephonic or other pipes, tubes and appliances and apparatus, and also to straighten or set back the edge or kerb of the footpath or pavement on both sides, or either side, of any streets and roads in or along which any of the proposed Tramways will be laid, and also to widen or strengthen, raise or lower any bridges, arches, and culverts to be crossed by the proposed Tramways so far as may be necessary or convenient for the purpose of constructing, maintaining, repairing, removing or altering the proposed Tramways and Works, or any of them, or for the other purposes of the Order.

To empower the Corporation to remove or discontinue the use of any Tramway or any part thereof, when by reason of the execution of any work affecting the surface or soil of any street, road or thoroughfare, or otherwise it is necessary or expedient so to do, and to make in the same or any adjacent street, road, or thoroughfare in any parish or place mentioned in this Notice, and to maintain, so long as occasion may require, a temporary tramway or temporary tramways in lieu of the tramway or part of a tramway so removed or discontinued to be used or intended so to be.

To provide for the maintenance of the whole

or some portion or portions of the respective streets, roads, and places upon or along which any of the proposed tramways, rails, or plates, may be laid, and to provide for and regulate the use and disposal by the Corporation of any paving, metalling, or road materials excavated or removed by them in the construction of the proposed tramways, or any of them, or in the exercise of any of the powers of the Order.

To empower the Corporation themselves or any Company, body or person to whom they may lease the same to work and use the said Tramways, and any other Tramways for the time being belonging to the Corporation, and to place and run carriages and trucks on such Tramways, and also to work such Tramways, or any of them, or any part thereof, by animal power or by electricity, steam, pneumatic, gas, oil, or any other mechanical power, or partly by one such power and partly by another such power. In the case of electricity, such power is intended to be applied by means of fixed conductors in connection with a generating station or generating stations, such conductors being placed overhead or on or under the surface of the streets, or part of such conductors may consist of the rails of the tramways or other uninsulated return, or such power may be carried with the carriages; in the case of steam, such power is intended to be carried with the carriages or applied by means of cables, wires, or ropes, placed under the surface of the streets or roads, and worked by and in connection with a stationary engine or stationary engines; and in the case of pneumatic, gas, oil, or other mechanical power, such power is intended to be carried with the carriages or applied by means of locomotives, or other engines, machinery or apparatus.

To empower the Corporation to lay down, construct, erect, and maintain on, in, under or over the surface of any street, road, or place, and to attach to any house or building such posts, brackets, rosettes, conductors, wires, tubes, mains, plates, cables, ropes and apparatus, and to make and maintain such openings and ways in, on, or under any such surface as may be necessary or convenient either for the actual working of the tramways or for providing access to or in connection with any engines, machinery or apparatus, and to empower the Corporation for the purpose of working such tramways to utilise any electrical power for the time being generated by the Corporation under any powers from time to time conferred on them for the purpose, and to contract with any persons for the supply to them of electricity for such purpose.

To reserve to the Corporation or their Lessees the exclusive right of using on the Tramways carriages adapted or suited for running thereon.

To prohibit, except by agreement with the Corporation or their Lessees, the use of the Tramways by persons or Corporations other than the Corporation or their Lessees, with carriages having flanged wheels or otherwise suitable or adapted to run on the Tramways, and to authorise and give effect to agreements between the Corporation or their Lessees, and any other person or Corporation, for the use of the said Tramways with such carriages, and to confer all necessary powers in that behalf on all such other persons or Corporations.

To authorise the Corporation or their Lessees to levy and recover tolls, rates, and charges for the use of the tramways by carriages passing along the same and for the conveyance of passengers or other traffic upon the same, and to alter or vary tolls, rates, and charges, and to confer, vary, or extinguish exemptions from payment of tolls, rates, and charges.

To make provision for regulating the passage of traffic along or across any streets, roads, or other places through or along which the Tramways will be laid, or any part or parts thereof, and along, over, or across such Tramways, and for preventing obstructions to all or any such traffic or to such Tramways, and to enable the Corporation and their Lessees jointly or separately, or either of them, to make and enforce Bye-Laws, Rules, and Regulations with reference to all or any of the matters aforesaid, and to attach and recover penalties for the breach or non-observance of such Bye-Laws, Rules, and Regulations, or any of the provisions of the Order.

To authorise and empower the Corporation, and any Company, body, or person to enter into and carry into effect Contracts and Agreements for and in relation to the construction, working, repair, and lease of the whole or any part of the Tramways for such consideration and upon such terms and conditions as may be agreed on between them.

To confirm an agreement entered into between the Corporation and the Burgh of Dysart for the working of the said tramways.

To make provision for any deficiency in the revenues or receipts arising from the working by the Corporation of their Tramway undertaking being made good out of the Burgh General Assessment, and any other rates or assessments leviable by them under the Burgh Police (Scotland) Act, 1892, or some or one of them.

To provide that the Corporation may apply towards the construction of the tramways sought to be authorised by the Order moneys which they have been authorised to borrow under the Kirkcaldy Corporation and Tramways Act, 1899, and the Kirkcaldy Corporation Order, 1904.

To authorise the Corporation to borrow and re-borrow money for the construction of the Tramways, and for other purposes of the Order, on Mortgage or Bond or by Annuity, or Cash Credit or otherwise on the credit and security of the revenue of the Tramway undertaking and the tolls, rates and charges to be authorised by the Order, and on any rates or assessments which the Corporation already have, or may hereafter have power to levy under any Act or Acts, and on any estates, undertakings, tolls, rates, rents, revenues, and other property of the Corporation or any of such securities, and to execute and grant Mortgages, Bonds, or other securities therefor, prescribe the form thereof; and to authorise the Corporation to apply any of the funds or any money borrowed, or which they have power to borrow, to all or any of the purposes of the Order; and also to apply the tolls, rates, charges, and profits of the Tramways to the general purposes of the Corporation.

To make provision for a sinking fund or sinking funds for repayment of the monies to be borrowed under the powers of the Order.

To confer upon the Corporation all such other powers, rights, and privileges as may be necessary or convenient for carrying into effect the objects and purposes of the Order, and to vary and extinguish all existing powers, rights, and privileges which would in any manner impede or interfere with any of such objects, and to confer, vary, or extinguish other rights and privileges.

#### BURGH OF DYSART.

To authorise the Provost, Magistrates and Councillors of the Burgh of Dysart, out of the common good of that Burgh and the Burgh General Assessment and Roads and Bridges Assessment or other rates and assessments of that Burgh or one or other of them, to contribute towards the working of the tramways proposed to be authorised by the Order.

#### WATER.

To alter and extend the present limits of compulsory supply fixed by The Kirkcaldy and Dysart Waterworks Act, 1867, so as to include within the compulsory limits

- (a) such portions of the existing municipal Burgh of Kirkcaldy as are at present beyond the same; and
- (b) the area above specified which it is proposed by the Order to add to the existing Burgh of Kirkcaldy,

and to apply and make applicable to the extended limits of compulsory supply the whole provisions and enactments of the said Act and of the Kirkcaldy and Dysart Waterworks Amendment Act, 1870; the Kirkcaldy and Dysart Waterworks (Additional Powers) Act, 1881; the Kirkcaldy and Dysart Waterworks Act, 1886; the Kirkcaldy and Dysart Waterworks Act 1896; the Kirkcaldy and Dysart Water Order Confirmation Act, 1908; and of the several Acts incorporated therewith or some parts or portions thereof.

#### ELECTRICITY.

To extend the area of the Corporation for the supply of electricity as defined by the Kirkcaldy Electric Lighting Order, 1899, so as to include:—

- (a) The municipal Burgh of Dysart.
- (b) The area above specified which it is proposed by the Order to add to the existing Burgh of Kirkcaldy.

And to enable the Corporation to exercise within the said extended area, with or without modification, all or some of the powers exercisable by them under the "Kirkcaldy Electric Lighting Order, 1899," within the existing area of supply, including powers to break up streets and roads and levying and recovering rates, rents and charges, for the supply of electricity and meters and apparatus used in the consumption of electricity, and all the powers that may be acquired by them under the Order.

To confer further powers on the Corporation in regard to their electricity undertaking, and particularly with regard to the following matters:—

To make provision for the terms upon which persons shall be entitled to demand from the Corporation a supply of electric energy to premises having a separate supply.

To authorise the Corporation to provide, sell, let for hire, lamps, meters, electric lights, fittings, apparatus and things for lighting and

motive power, and for which electric energy is used.

To confer upon the Corporation all or some of the powers of the Electric Lighting Acts, 1882 and 1888, and the Electric Lighting Clauses Act, 1899, and the enactments incorporated therewith, and to alter, vary or extinguish all rights and privileges which would or might interfere with any of the objects of the Order, and to confer all other rights and privileges necessary for carrying such objects into effect.

To confer on the Corporation power to erect overhead wires and to transmit energy thereby, notwithstanding anything contained in Section 14 of the Electric Lighting Act, 1882, or Section 10 of the Schedule to the Electric Lighting Clauses Act, 1899, or Section 6 of the Kirkcaldy Electric Lighting Order, 1899.

To provide that the Corporation may refuse to supply electrical energy to any persons whose payments for the supply of such energy may be in arrear, and to require that consumers of electrical energy shall give notice to the Corporation before quitting any premises supplied with energy, and to provide for the liability of such consumers where requisite notice is not given.

To authorise the Corporation to provide or let for hire and fix and repair lamps, motors and electrical fittings and fixtures and other material for the use of electricity.

To empower the Corporation to supply electricity to any local authority, company or person within or without the area of supply of the Corporation.

To define the rate or assessment on the security of which loans to the Corporation in connection with their electricity undertaking are or may be secured.

#### GAS.

With the object of acquiring the undertaking of the Kirkcaldy Gas Light Company, Limited, the Corporation, at a special meeting held on 10th May 1909, resolved that the Burghs Gas Supply (Scotland) Act, 1876, shall be adopted in and applied to the Burgh of Kirkcaldy, and they appointed the 15th day of November, 1909, for holding a second special meeting to resume consideration of the said resolution. The Provisional Order will make the following provisions applicable to the gas undertaking after it has been acquired by the Corporation under the Burghs Gas Supply (Scotland) Act, 1876 :—

To empower the Corporation to enter upon, take and use the lands hereinafter described, and to erect gasworks and buildings thereon, as well as on the land already belonging to the Gas Company in connection with their gas undertaking; and to make, construct, lay down, and maintain, either separately or as part of the existing gas works, retorts, gasometers, receivers, mains, pipes, machinery, and other works and apparatus, and to manufacture, produce and store, and contract with any person for the manufacture and production and storage of gas, and for the manufacture and production of residual substances, liquids and products arising in the manufacture of gas, and to manufacture, convert and store substances, liquids and products on the following land—that is to say :—

That piece of ground, situated in the Burgh of Kirkcaldy and Parish of Kirkcaldy and Dysart and County of Fife, containing 12

decimal or 1000th parts of an acre or thereby, now belonging or reputed to belong to Mrs. Justina E. Lockhart or Anderson, bounded as follows :—on the west by Links Street, and on the north, east and south by the property of the Gas Company.

The lands belonging to the Gas Company in connection with their gas undertaking, on which or on parts of which the existing gas works and gas holders of the Corporation are situated, are :—

- (1) That piece of land within the Burgh of Kirkcaldy, bounded on the north by School Wynd; on the south by Gas Wynd; on the east by the sea flood, the Sands Road intervening; and on the west by Links Street; but excepting from the area above described that piece of ground above described, for which compulsory powers of purchase are proposed to be asked.
- (2) That piece of ground within the Burgh of Kirkcaldy, bounded on the north by the property of Mrs. Marianne Reynolds Heggie or Melville; on the south by School Wynd; on the east by the sea flood, the Sands Road intervening; and on the west by the property of N. Lockhart & Sons.
- (3) That piece of ground situated in the Burgh of Kirkcaldy, bounded on the north-west by Victoria Road; on the north-east by Mitchell Place; on the south-east by the burial yard of Dunnikier and the properties of Michael Nairn & Company, Limited, Mrs. Janet Christie, and the Trustees of the Evangelical Union Church, and on the south-west by the property of Robert Hutchison.

To amend or repeal the provisions of the Acts relating to the gas undertaking with respect to the illuminating power of gas and testing thereof, and to make other provisions with respect to the illuminating power, purity and testing of gas and the apparatus to be used therefor.

To alter and vary the provisions of the Acts relating to borrowing for the gas undertaking with reference to the sinking fund and repayment of moneys borrowed or to be borrowed by the Corporation for the gas undertaking.

To confer further powers on the Corporation in regard to the gas undertaking, and particularly with regard to the following matters :—

To provide that if there shall be any surplus remaining on account of the revenue of the gas undertaking, the Corporation may carry such surplus, or such part thereof as they see fit, to the Burgh General Assessment.

To provide that the Corporation may make regulations as to the size, material, and other particulars of pipes and fittings to be laid by consumers.

To provide that the Corporation may sell, let for hire, fix, repair and remove engines, stoves, ranges, pipes and other fittings, and to make provision for such engines, fittings, etc., not being subject to distress or landlord's hypothec.

To make provision in respect to the recovery of all gas rates and charges and meter rents.

To make provision as to the discount to be allowed on public lighting.



## ELECTRICITY AND GAS.

To provide that the Corporation may lay pipes and cables and relay and renew the same in streets not dedicated to the public use nor reparable by the Corporation.

## HARBOUR.

To authorise the Corporation to borrow additional money for Harbour purposes.

## STRAND OF SEASHORE AND WASTE GROUND ADJOINING.

To empower the Corporation to purchase compulsorily and to maintain as open spaces the land hereinafter described, all lying in the Burgh of Kirkcaldy, Parish of Kirkcaldy and Dysart, and County of Fife; that is to say:—

- (1) The strand adjoining the seashore and waste ground adjoining the strand lying between the Sands Road on the west, the high water mark of ordinary spring tides on the east, the Tiel Burn on the south, and the Harbour of Kirkcaldy on the north.
- (2) The strand adjoining the seashore and waste ground adjoining the strand, extending from the Tiel Burn on the north to the boundary of the burgh on the south, bounded on the east by the high water mark of ordinary spring tides, and bounded on the west partly by the Sands Road, partly by the Forth and Clyde Ropework belonging to the Forth and Clyde Roperie Company, and partly by the road leading to Seafeld Cafe, but excepting therefrom (1) the premises formerly occupied as a Chemical Work and now used as Stables; and (2) a store used in connection with the said Ropework as shown on the deposited plans.
- (3) The strand of the seashore of Pathhead Sands and waste ground adjoining the strand lying between the buildings and enclosures on the north-west and high water mark of ordinary spring tides on the south-east, the East Den burn on the south-west and the rock on which Ravenscraig Castle is built on the north-east.

To provide that such strand and waste ground shall not be deemed part of a house or other building or manufactory within the meaning of Section 90 of the Lands Clauses Consolidation (Scotland) Act, 1845, and that owners may be required to sell and convey said strand and waste ground alone, and that they shall not be entitled to call upon the Corporation to purchase any other property belonging to them.

To confer further powers upon the Corporation with reference to the purchase of the strand and waste ground, including power to borrow money for the payment of the purchase moneys and moneys required for sea walls and embankments, and to charge the moneys so borrowed on the Burgh General Assessment, the General Improvement, or other local rates.

To provide that the moneys required for this part of the Order, including moneys required for sea walls and embankments, may be supplied out of the General Improvement rate or out of moneys to be borrowed under the Order.

To provide that the Corporation may borrow the moneys required for this part of the Order

on the credit of the General Improvement rate, or the Public Health General Assessment, and that the limit imposed on such rates shall not apply to any rate required to be levied for the purpose of defraying any expenses under this part of the Order.

To provide that the period for repayment of such loans may be fifty years.

To make applicable to the purchase of the strand and waste ground the provisions of the Public Parks (Scotland) Act, 1878, as to the acquisition of land and the provisions of the Railway Clauses Consolidation (Scotland) Act, 1845, as to the working of mines.

To make better provision for the protection of the amenity of the strand and waste ground adjoining the seashore within the burgh.

To prohibit the deposit of ballast, dirt, rubbish, ashes, and other things upon the foreshore between high and low water mark and on the strand and waste ground adjacent to high water mark, and to prohibit the taking away from the foreshore of sand, gravel, or stones.

To prohibit the deposit in the sea within the waters of the Forth within three miles of low water mark of the solid refuse of any manufactory or any rubbish, cinders, cork dust, or other waste matter.

## TRAMWAYS, ELECTRIC LIGHT, AND HARBOUR AND STRAND.

To provide for payment of the costs of this Order.

To alter, vary, amend and extend or repeal, so far as may be necessary or desirable for the purposes of the Order, the whole or some of the provisions of the following Acts and Orders, viz.:—“The Kirkcaldy Harbour and Petty Customs Act, 1849;” “The Kirkcaldy Burgh and Harbour Act, 1876;” “The Kirkcaldy Corporation and Tramways Act, 1899;” “The Kirkcaldy Electric Lighting Order, 1899;” “The Kirkcaldy Corporation Order, 1904;” “The Local Government (Scotland) Acts, 1889 to 1908;” “The Tramways Act, 1870;” “The Burgh Police (Scotland) Act, 1892;” “The Burgh Police (Scotland) Act, 1903;” “The Public Health (Scotland) Act, 1897;” “The Kirkcaldy and Dysart Waterworks Act, 1867;” “The Kirkcaldy and Dysart Waterworks Amendment Act, 1870;” “The Kirkcaldy and Dysart Waterworks (Additional Powers) Act, 1881;” “The Kirkcaldy and Dysart Waterworks Act, 1886;” “The Kirkcaldy and Dysart Waterworks Act, 1896;” and “The Kirkcaldy and Dysart Water Order Confirmation Act, 1908;” “The Town Councils (Scotland) Act, 1900;” “The Electric Lighting Act, 1882;” “The Electric Lighting Act, 1888;” “The Electric Lighting (Scotland) Act, 1890;” “The Electric Lighting (Scotland) Act, 1902;” “The Electric Lighting Clauses Act, 1899;” “The Burghs Gas Supply (Scotland) Act, 1876;” “The Burghs Gas Supply (Scotland) Act, 1893;” “The Gasworks Clauses Act, 1847;” “The Gasworks Clauses Act, 1871;” “The Sales of Gas Act, 1859;” “The Sale of Gas Amendment Act, 1860;” “The Sale of Gas (Scotland) Act, 1864;” and all other Acts amending the said Acts.

To incorporate with and make applicable to the Order all or some of the provisions of the Lands Clauses Acts; the Railways Clauses Consolidation (Scotland) Act, 1845; the Railway

Clauses Act, 1863; the Public Parks (Scotland) Act, 1878; the Tramways Act, 1870; the Electric Lighting Act, 1882; the Electric Lighting Act, 1888; the Electric Lighting (Scotland) Act, 1890; the Electric Lighting (Scotland) Act, 1902; the Electric Lighting Clauses Act, 1899; the Burghs Gas Supply (Scotland) Act 1876; the Burghs Gas Supply (Scotland) Act, 1893; the Gasworks Clauses Act, 1847; the Gasworks Clauses Act, 1871; the Burgh Police (Scotland) Act, 1892; the Burgh Police (Scotland) Act, 1903; the Town Councils (Scotland) Act, 1900; the Kirkcaldy Corporation and Tramway Act, 1899; the Kirkcaldy Electric Lighting Order, 1899; the Kirkcaldy Corporation Order, 1904; or some of them, with such modifications of the provisions of those Acts, or some of them, and all such other Acts as may be required or expedient.

And a copy of so much of the tramway deposited plans and book of reference as relate to the Burgh of Kirkcaldy, and also a copy of the gas deposited plans and book of reference, and a copy of the strand deposited plans and book of reference, together with a copy of the "Gazette" notice and duplicate maps showing the present boundaries of the burgh as well as the boundaries of the proposed extension, will be deposited on or before the said date with the Town-Clerk of the Royal Burgh of Kirkcaldy at his Office therein; and a copy of so much of the tramway deposited plans and book of reference as relate to the Burgh of Dysart, together with a copy of the "Gazette" notice, will be deposited on or before the said date with the Town-Clerk of the Burgh of Dysart at his Office therein.

The petition and draft Order and printed copies thereof may be deposited at the Office of the Secretary for Scotland, Whitehall, London, on the 17th day of December next.

The subsequent procedure in respect of the said application will be by way of Provisional Order, unless it is otherwise decided in terms of the "Private Legislation Procedure (Scotland) Act, 1899," in which case the procedure may be by way of private bill, and this notice and the deposits in reference to the said application will, subject to the Standing Orders of Parliament, apply to such Bill.
