REGULATIONS respecting Open Competitive Examinations for the Situation of Assistant in the Royal Observatory, Edinburgh.

N.B.—These Regulations are liable to alteration from time to time.

- I. The limits of age for this situation are 21 and 25, and Candidates must be of the prescribed age on the first day of the Examination.
- II. Candidates must be natural born or naturalised British subjects.
- III. The Examination will be in the following subjects :-
 - 1. English Composition, including Writing and Spelling.

2. French, or German, or Latin; translation from the language.

3. Computation:—Numerical multiplication, division, involution, evolution, and the solution of plane and spherical rightangled triangles (the formulas being supplied to the Candidate).

4. Elementary Mathematics:—Plane Geometry, Algebra, Plane Trigonometry, Spherical Trigonometry.

- 5. Further Mathematics: Elementary coordinate Geometry; Elementary differential and Integral Calculus; Elementary Statics, Dynamics and Hydrostatics.
- 6. Astronomy, Practical and Spherical.

Candidates must pass to the satisfaction of the Civil Service Commissioners in each subject.

- IV. Application for permission to attend an Examination must be made at such time and in such manner as the Civil Service Commissioners may appoint.
- V. A fee of 12s, 6d. will be required from every Candidate attending an Examination.

- 5. To provide for and regulate the management and administration of the business of the Trust in accordance with the rules and regulations to be set forth in the Order.
- 6. To make and to authorise the making and enforcing of rules and regulations for the management and administration of the Fund, and the conduct and direction of the business and affairs of the Trust, and to empower the Trustees to devolve all or any of their powers and duties upon Committees.
- 7. To provide for the proper keeping and auditing of the accounts of the Trust, the appointment of officers and the duties to be performed by them.
- 8. To regulate the mode of executing and authenticating deeds and writings by or on behalf of the Trustees, and of serving summonses, writs, notices and other documents upon the Trustees.
- 9. To authorise the Trustees to apply to the Court of Session for direction in certain events.
- 10. To make provision for the costs of and incident to the Order.
