Local Government (Scotland) Acts.

COUNTY COUNCIL ELECTORAL DIVI-SIONS OF LANARKSHIRE.

ORDER by the Secretary for Scotland.

HEREAS the Contents and Boundaries of the Electoral Divisions of Millerston and Springburn and of North Shettleston, in the County of Lanark, were determined by an Order under the hand and seal of the Secretary for Scotland, dated 16th May 1899:

And whereas the County Council of the County of Lanark have represented to me that it is desirable to alter the Contents and Boundaries of the said Electoral Divisions of Millerston and Springburn and of North Shettleston:

And whereas I am of opinion that it is expedient to give effect to the representation of the said County Council:

Now therefore I, the Right Honourable John, Baron Pentland, His Majesty's Secretary for Scotland, in virtue of the powers conferred on me by section 51 of the Local Government (Scotland) Act, 1889, and Acts amending the same, do hereby order as follows:--

The Order of the Secretary for Scotland, dated · 16th May 1899, is hereby recalled in so far as concerns the Electoral Divisions of Millerston and Springburn and of North Shettleston, and from and after the date hercof the Contents and Boundaries of the said Electoral Divisions shall be as follows :---

Contents of Division.

Millerston and Spring. That part of the Parish of Glas-(exclusive of the portion included within the limits of the Burgh of Glasgow) which lies to the east of the Possil Division and generally to the north of a line drawn along the southern boundary of that part of the Gatteraig Policies lying to the west of the Gatteraig Highway, and along the centre of the said Highway till it reaches the centre of Jessie's Ridge which greese the Monk-Bridge which crosses the Monk-land Canal, and thence in an easterly direction along the centre of the Monkland Canal to the point at which it enters the Parish of Old Monkland. That part of the Parish of Glas-gow (exclusive of the portion

included within the limits of the Burgh of Glasgow) which lies to the south of the Millerston and Springburn Division and to the north of a line drawn in an easterly direction along the centre of the road from Glasgow through Shettles-ton to Baillieston from the point at which the said road leaves the Burgh of Glasgow to the point at which it enters the Parish of Old Monkland.
